The figures are based on the monthly submission made to DfE via NCCIS for Kent County Council . Academic age is the age of the young person on 31st August (i.e.: prior to the start of the academic year). The figures include all 16 -18 year olds based on academic age with a Kent County Council area postcode as their primary address.



Executive Summary

The NEET percentage includes an adjustment factor which assumes that 8% of currency expired not knowns are assumed to be NEET.

Progress Tracking

The percentage of Not Knowns is now at its lowest since April 2014 and it has remained under 10% for the last 3 months. This is encouraging, as traditionally the number of Not Knowns begins to rise towards the end of the academic year. This progress is due to the embedding and maturing of new practices introduced in the last six months. It is anticipated that these foundations will have an even greater impact in the coming academic year of 2015/16.

Planned Tracking Activity

In preparation for academic year 2015/16, a series of county wide briefings for schools will take place in June and July. To date, 75 mainstream schools, 10 special schools and 3 PRUS are signed up to attend. Consultations with Kent Association of Further Education Colleges (KAFEC) and Kent Association of Training Organisations (KATO) have been held and new data collection processes agreed with both. By ensuring that all these organisations have clear processes to follow it is expected that there will be significant improvement in the number of Not Knowns.

The DfE have changed the requirement for recording young people at college. In previous years those finishing college could be recorded as being in a positive activity up until September, at which point, most then moved into the next positive destination. This year, most young people have been recorded as completing their college course at the end of July. As a consequence, there will be a significant increase in Not Knowns in July which cannot be compared with last year, but will compare with other Local Authorities July 2015 returns. How this will be managed, will be a key priority in June and July.

Troubled Families

• Kent's Troubled Families Programme (KTFP) has utilised Programme's funding to create three dedicated Employability Officer posts, that directly assist members of the families on the Programme reach their potential; supporting them in to training, work experience and apprenticeship opportunities, and ultimately put them on a path to work. These posts sit within and are line managed by the Kent Supported Employment team and work alongside the JobCentre Plus Troubled Families Employment Advisors.

• We have made available a small 'enabling pot' from KTFP funding to assist the Employability Officers in supporting young people taking up employment, training or an apprenticeship.

• KTFP funding has been used to establish a Saturday Job Scheme, enabling young people to be paid whilst gaining skills and experience; with the intention those who are successful are retained. This is coordinated by the Employability Officers.

• Funding for two Assisted Apprenticeship has also been secured from Skills and Employability team to support the Employability Officers and JobCentre Plus support for troubled families

Fair Access Team

• Fair Access Elective Home Education Officers (EHE) will write to all families of year 11 CYP who are registered as Electively Home Educated and will in agreement with the family, visit or telephone to discuss year 12 options available to them re further education, training, work experience and apprenticeship opportunities. The EHE officer will signpost CYP to Kentchoices4u and liaise with the local participation officer where the CYP requires support to enable them to access a suitable onward route.

• The EHE officer will record the onward route for the CYP on IYSS and contact the CYP in September to affirm the September Guarantee has been taken up.

Special Educational Needs

Young people with SEN who have an Education, Health and Care (EHC) Plan (or Statement of SEN up until 2018) The Children and Families Act 2014 defines a young person as someone who is aged 16 and over and who has left compulsory education. The SEN Team are only responsible for young people who have an Education, Health and Care Plan (or until 2018 a SSEN) in place to support them in education.

Staff training:

- A further Trainer to be identified by SEN to deliver IYSS training in order to be able to respond quickly to changes in personnel identified person will be given Train the Trainer training.
- All SEN Officers for Young People to be trained in the use of IYSS and accounts requested. A lead has been identified in each of the 4 areas who will also be trained in the use of IYSS to support the area to contribute to the county targets.

Sharing information:

• For all young people with an EHC Plan or SSEN who are post compulsory education (excluding Higher Education) up to the age of 25, SEN Officers for Young People will share information already known to SEN re; educational placement or provision (joiners and leavers) available to SEN from schools and/or college via the IYSS database.

- SEN Officer for Young People will update IYSS with September Guarantee information following the outcome of consultations with schools/colleges for young people with an EHC Plan/SSEN in year 11 and 12.
- SEN Officer will attend year 10 Annual Review meetings (wherever possible) to gather information re; plans for post 16 and update IYSS with intended destination information for young people with an EHC Plan/SSEN.
- When a young person who has an EHC Plan or SSEN leaves education, does not have plans to continue in education and becomes NEET, SEN Officer for young people will complete a referral to Early Help to enable the young person to access support. Their EHC Plan or SSEN will cease to be maintained by the LA at this point. Working collaboratively:

• SEN teams will request support from the Participation Officers in their area, to become better informed of the wider educational opportunities available to young people with SEN – to invite to local Section Meetings.

• SEN teams will work more collaboratively with other services such as VSK, Social Services, Elective Home Education Officers, Schools, Colleges and other Post 16 providers to enable early identification of issues that could impact on a young person's continuation in education and reducing NEET and Not Known.




