Headline Commentary

Figures for October are more stable than September, but still do not reflect the true position of the NEET and Not Known cohorts in Kent. It is at the beginning of the academic year that the system is updated with all the new enrolment information for young people in schools and colleges, and given the size of Kent, this takes several weeks to complete.

The NEET population is currently 1.6%, and the Not Knowns are at 13.5%. Not Knowns have fallen from 71.4% last month, due to the system being updated with new enrolment information for young people in schools and colleges. As the remaining enrolment data goes into the system during November the NEET figure is likely to rise slightly, whilst the Not Knowns will decrease even further.

The Participation rate has improved significantly from last month, up to 83.7%, in line with the same point last year. District performance for Not Knowns is varied, and ranges from 10.3% in Swale to 22.7% in Ashford. This is due to some schools returning enrolment data late to the local authority, meaning the system cannot be updated.

District performance for NEET is less varied, as figures are all currently below 2% while the cohort settles.

Work is continuing to take place to ensure we have contact details for the full NEET and Not Known cohorts. It can be a challenge to maintain monitoring and support when young people's details can change regularly.

Districts have been working with colleges to support young people in their first few weeks at college to ensure any issues can be addressed quickly and appropriately.

Statistical Neighbours NEETs September 2017

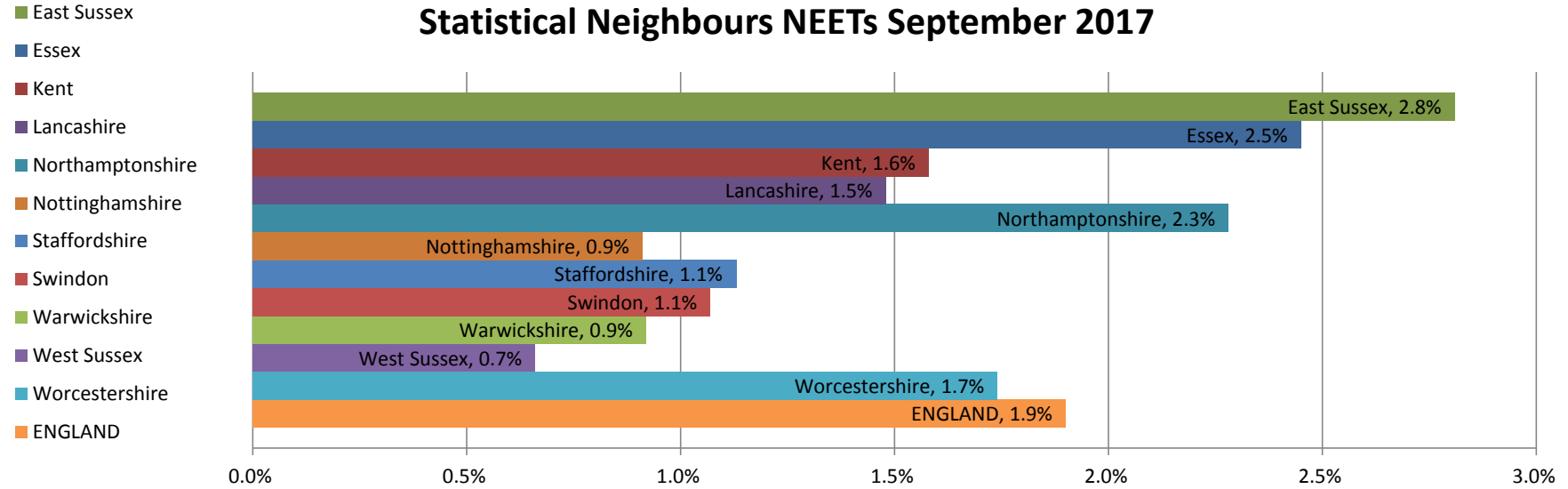
