Headline Commentary

Figures for July continue to show a stable position for the NEET population, which is 3.1%, a slight increase from last month (1022 young people). The proportion of Not Knowns has risen from 2.8% to 4.6%, which is an expected seasonal trend, as some courses come to an end.

These figures compare to a NEET figure of 3.1% at the same time last year, and a Not Known figure of 4.9% this time last year.

The combined NEET and Not Known figure is at 7.7%, up from 5.8% last month, largely due to the increase in the Not Knowns. The figure for the same month last year was 8.0%.

The NEET population of 1022 young people comprises 463 in the year 12 age group and 559 in the year 13 age group.

The Participation rate has decreased slightly from last month, down from 90.1% to 88.4 %, and is 0.3 percentage points lower than the same point last year.

District performance for NEET varies from 1.3% in Sevenoaks to 5.1% In Swale, though most districts are between 2.0% and 3.0%. District performance for Not Knowns ranges from 2.8% in Tunbridge Wells to 5.8% in Sevenoaks.

Combined NEET and Not Known figures range from 5.0% in Tunbridge Wells to 10.8% in Thanet.

The collection of September Guarantee data for Year 11 and Year 12 pupils is underway. Schools and colleges must submit details of those students they have offered places to for September. Services can then work with young people without a September Guarantee prior to September to ensure they have an appropriate positive destination to move into that will meet their needs and aspirations.

The figures for September Guarantees Not Yet Recorded has fallen from 26.5% in the previous month to 12.0% this month.

Chart 6 - Statistical Neighbours NEETs June 2018

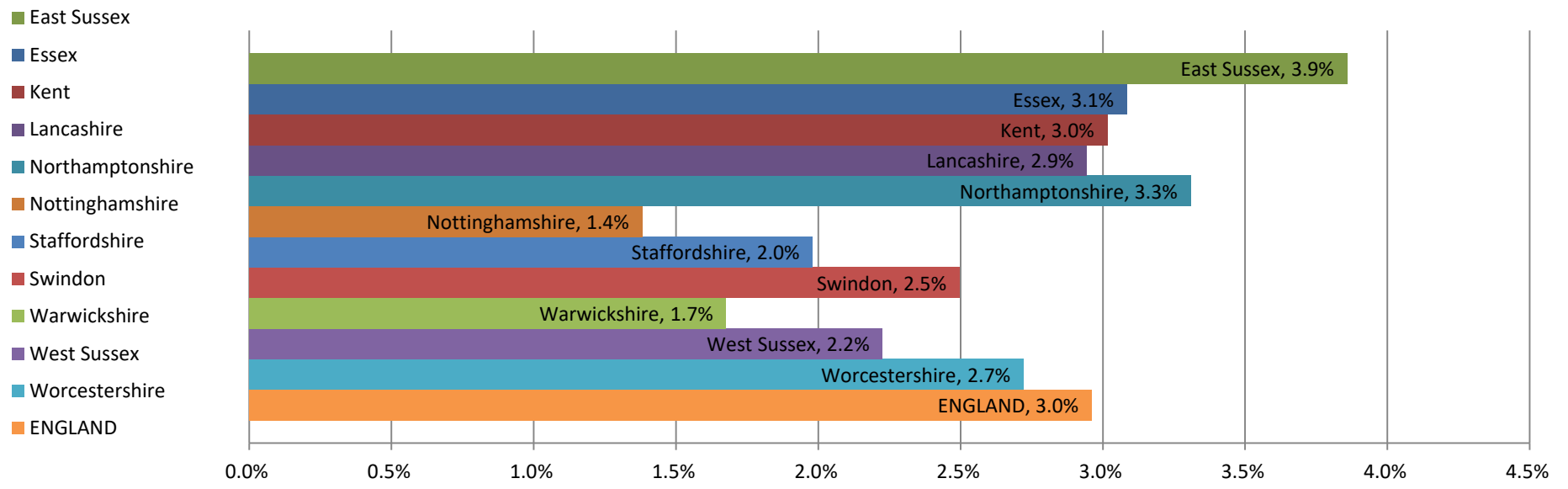
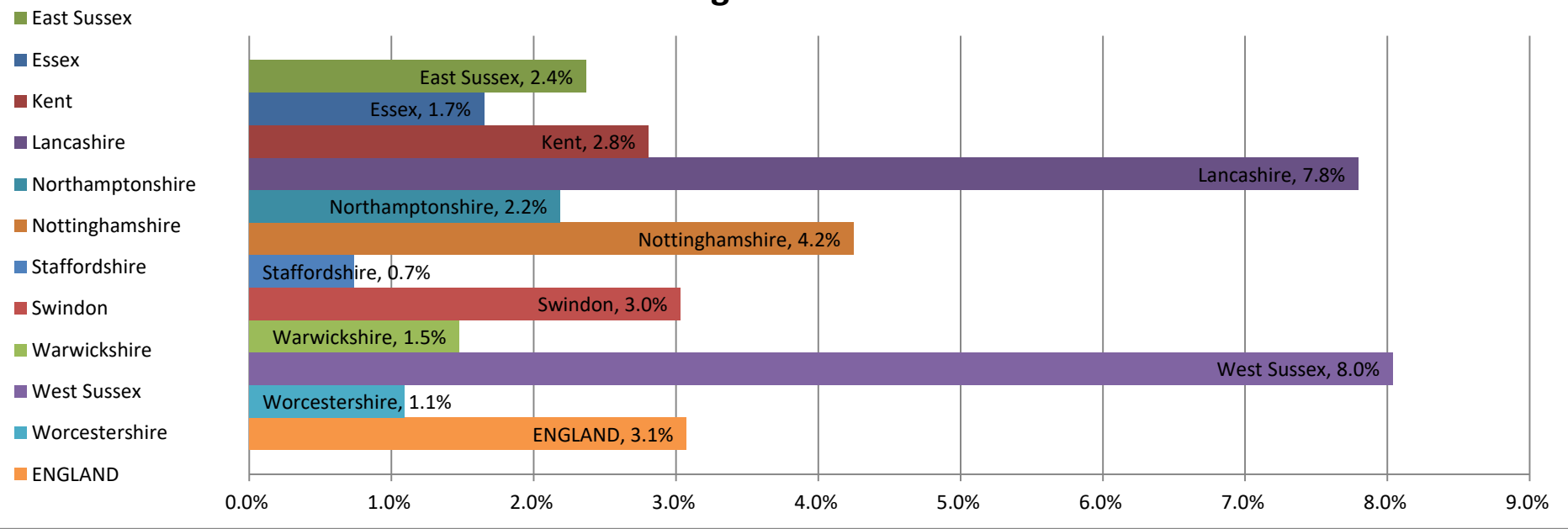


Chart 7 - Statistical Neighbours Not Knowns June 2018
