Actions for early years and childcare providers during the coronavirus (COVID-19) outbreak 14 July 2021

Updates for Families

What parents and carers need to know about early years providers, schools and colleges during COVID-19 8 July 2021

Published new guidance including updates on testing, face coverings, contact tracing, isolating and bubbles, which come into force from Step 4 of the Roadmap. The current guidance (dated May 2021) remains in place until Step 4.

Guidance for parents and carers of children attending out-of-school settings during the coronavirus (COVID-19) outbreak 8 July 2021

Change made: They have added out-of-school settings: COVID-19 guidance for parents and carers which applies from Step 4. This guidance outlines the removal of restrictions in these settings, such as keeping children in consistent groups (bubbles), wearing face coverings in classrooms and communal areas and in community settings, limits on parental attendance, and restrictions on group sizes for residential visits.
