CONSTITUTION

Although all GB's should now have reconstituted remember that you can reconstitute at any time. As you know, included in the guidance is greater flexibility of terms of office for governors. Although the maximum term of office remains four years, governing bodies can now specify in the instrument of government that the term of office for an individual governor within a particular category may be between one and four years as determined by the appointing body at the time of appointment.

THE COUNTER TERRORISM SECURITY ACT 2015

The Prevent Strategy has three main objectives:

- Respond to the ideological challenge of terrorism & the threat we face from those who promote
 it:
- Prevent people from being drawn into terrorism and ensure that they are given appropriate advice and support;
- Work with sectors and institutions where there are risks of radicalisation which we need to address.

The Prevent strategy aims to stop people becoming terrorists or supporting terrorism. While it remains rare for children and young people to become involved in terrorist activity, young people from an early age can be exposed to terrorist & extremist influences or prejudiced views. As with other forms of safeguarding strategies, early intervention is always preferable. Schools, working with other local

partners, families and communities, play a key role in ensuring young people and their communities are safe from the threat of terrorism.

Schools subject to the Prevent Duty will be expected to demonstrate activity in the following areas -

- Assessing the risk of children being drawn into terrorism
- Demonstrate that they are protecting children and young people from being drawn into terrorism by having robust safeguarding policies.
- Ensure that their safeguarding arrangements take into account the policies and procedures of the Local Safeguarding Children Board.
- make sure that staff have training that gives them the knowledge and confidence to identify children at risk of being drawn into terrorism, and to challenge extremist ideas which can be used to legitimise terrorism
- Expected to ensure children are safe from terrorist and extremist material when accessing the internet in school.

WHISTLEBLOWING

Please ensure your schools have an up to date Whistleblowing policy. Make sure your arrangements are clear and that all staff are aware of them. The LA Policy which applies to all employees, agency workers, volunteers and those contractors working on KCC Premises are covered by this policy. In the first instance you should contact the Whistleblowing Hotline internalaudit@kent.gov.uk with the subject line "Whistle Blowing"

BUSINESS INTERESTS

Further to last term's District Governor Briefings a reminder that there is now a requirement for Governor Business Interests to be published on the school website. Governing bodies should make it clear in their **code of conduct** that this information will be published about their **governors and any associate members**. Any governor failing to provide information to enable the governing body to fulfil their responsibilities may be in breach of the code of conduct and as a result be bringing the governing body into disrepute. In such cases the governing body should consider suspending the governor.

It is important you look at this before signing your Code of Conduct. Further details are available here Information that must be on your school website

HEADTEACHER PERFORMANCE MANAGEMENT AND APPRAISAL

A reminder that the terms and conditions have changed and Governing Bodies should follow the very clear advice in the Teachers Pay and Conditions Document and ensure they have adjusted their own pay policies in line. This is important to action now at the start of the Performance Management cycle.
