Executive Summary - continued

Introduction

It is anticipated by Participation Pathways Operational Group that the new systems, which are now in place across KCC services, will have a positive impact in reducing NEETs and Not Knows over the next 3 months. This report has been jointly written by all members of the Group with a view to providing a co-ordinated picture of activities. The Group will continue to monitor and report on progress towards the outcomes and targets set out in the NEET Strategy for 15/16.

Current Activities

The implementation by all relevant services and partners within the NEETs Strategy and Action Plan for 2015.16 includes

Tracking and monitoring potential and actual NEET's and Not Knowns.

Maintaining the accuracy of the IYSS database

Identifying and supporting at an early stage all young people at risk of being NEET

Increasing participation of all young people in education, employment and training post 16

Increasing provision of training opportunities in all districts at a range of levels

Regularly sharing information between partner organisations

Providing coaching and personal support to young people as required

Reviewing and evaluating impact

The Participation Pathways Operational Group (PPOG) will need to ensure:

- The identification of the correct status, EET or NEET, of young people in the 16 18 years age group
- Clear lines of communication are in place for all services providing for this age group so that all are engaged in the strategy to reduce the numbers amongst them who are either NEET or who have an "unknown" status

• The achievement of a co-ordinated approach across all services, e.g. Specialist Children's Services, Virtual School Kent, SEN Assessment & Placement Teams, the 18+ Service, the Troubled Families Programme, schools and PRUs and Colleges / training organisations

- The development of the Group so that it effectively assists the services represented to meet the objectives of the NEET strategy a revised version of Terms of Reference have been prepared
- Early Help & Preventative Services develop a consistent operational response via the Open Access Youth Hub in each District and are supported in determining the provision which needs to be available to increase the employability of young people

• Ensuring the accuracy and currency of the data recorded on IYSS by increasing the number of staff trained to use the system

Key Actions by Service area

Skills & Employability

Briefing Meetings for schools, the purpose of the briefings is to clarify what schools can expect from Skills & Employability, their responsibilities and the resources available to support young people who are at risk of becoming NEET

In September Welfare Call were tasked with contacting all young people, aged 16 to18 years, in the county recorded on IYSS as being NEET, the contact details of young people asking for support with regard to their NEET status has now been passed to the District Managers within the Early Help & Preventative Services

Participation & Progression Managers are meeting with the Youth Hub Delivery Managers (EHPS) who have the lead responsibility for the support of NEETs in each of the District, this will enable the networks developed by Skills & Employability to be brought together with the young people in each of the Districts

Participation and Progression Meetings (formerly NEET to EET Meetings) are being held in each of the Districts in November. These are run in each of the Districts 4 times a year, to enable discussion of opportunities for young people who schools and training providers believe are in danger of leaving school and of becoming NEET. The November meetings will focus on young people who left school at the end of their previous academic year and are NEET and young people who may have started a course in September and have not settled

The promotion of the DWP pilot involving a 16 / 17 Year Old NEET Worker who can support the Youth Hub Delivery Managers with individual young people in the target Districts

Kent Choices (the magazine) is being widely distributed to all services providing for the 16 to 18 year olds with a specific focus on the magazine being made available via the Youth Hubs.

Executive Summary - continued

Early Help & Preventative Services

There are a number of NEET focused activities within EHPS and work is underway to ensure that systems are consistent across each of the 12 Districts. The current actions are

The publication of guidance for recording the destinations of young people on IYSS by EHPS staff (includes the circulation of a revised Data Capture Form)

The training of EHPS staff in the use of IYSS with courses planned for both November and December which are critical to increasing the level of data entered on to IYSS as there are Districts in the county with no current users. There will be a further need to co-ordinate activity on the system as the number of users of the system increases. Ensuring there is a reliable information sharing process in place between Skills & Employability (Participation Team) and the Districts (EHPS) so that there is awareness of the contact details of young people on the IYSS data who:

- a. are known to be NEET
- b. have an Unknown "Destination"
- c. have indicated that despite being NEET they do not wish to be contacted

Skills & Employability and Information & Intelligence are working together to ensure that District Managers and Youth Hub Delivery Managers are fully aware of the EET opportunities for young people in their respective Districts and can, therefore alert young people to them and support any interests they have to be met, mainly through the district offer.

Developing new processes with Youth Hub Delivery Managers and CXK to best provide support to the vulnerable groups amongst the NEET population alongside other partners providing services to young people aged 16 – 18 years The Troubled Families Programme to promote training, employment and apprenticeship opportunities for the young people in families known to the programme. The Saturday work scheme is proving to be a great success in assisting young people to understand the core skills required when in either a training place or in employment

Youth Justice

Ensuring the current EET status of a young person is kept up to date throughout a youth justice intervention on the youth justice case management system

YOT staff to be trained in the use of IYSS so that the case record of a young person known to the Service is also kept up to date, so supporting accurate reporting

Implementation of a new agreement (in line with the Code of Practice, Chapter 10, Children & Families Act 2014) with the Youth Offending Teams to facilitate joint work with those young people in the youth justice system who have an Education Health Care Plan (ECHP) including those in and leaving custody

Ensuring awareness of the EET opportunities being created by the Youth Hubs

Utilising the opportunities to provide accredited programmes to increase the employability using the district offer

Access to Education / Fair Access

A challenge for Fair Access is to maintain accurate information regarding the destinations of those who have been "home educated". There is sometimes a reluctance to share personal data with the County Council, some young people will move into Further and Higher Education opportunities, others are known to be vulnerable. Fair Access aims, through the use of a new website and the links they are trying to establish with EHE communities, to overcome this reluctance. The plan is to build on the goodwill of those families who are happy to work with the officers in the Service, with the expectation that this will encourage the more reticent to become involved.

Virtual School Kent

The significant increase in Unaccompanied Asylum Seeking Children (UASC) will be reflected in future NEETs data sets. VSK have received both updated training on the use of IYSS and guidance from the Management Information Unit (Information & Intelligence) on the 8 different 'status' that can be used for UASC. Meeting the learning needs of this population, will be integral to the success of NEETs Strategy, there will be new EET related opportunities for young vulnerable people in the county. New provision is currently being developed across the county.

Executive Summary - continued

The 18plus Leaving Care Service

The level of engagement in EET by young people known to the 18plus Service (18 – 21 years) has been under reported as the data indicates only 38% of the cohort are engaged whereas VSK reports that 57.8% of the caseload are EET, more focused work will be undertaken for this group by VSK.

MI Team

The MI Team continue to support the NEET strategy by managing the Data Quality issues associated with individual case records. Developments from September onwards include:

Continuing to build good partnership arrangements with Schools and Colleges to ensure data required to support the NEET strategy is received in a timely fashion.

Importing the School and College September enrolment data which has captured in excess of 40,000 lines of information. The Joiners and Leavers data for Schools and Colleges is being processed promptly.

The Sytems Training Officer (STO) has written and produced an IYSS training program for new staff to ensure a consistent approach by all Trainers and users.




