Headline Commentary

The NEET population at 3.2% this month (1,049 young people) has increased by 28 young people compared to last month. This compares to a figure of 3.0% at the same time last year. The Not Known figure has reduced further to 2.2% this month (708 young people) which is a reduction of 248 young people. This is an also improvement on the same month last year, which was 2.4%. The combined NEET and Not Known figure continues to reduce and at 5.4%, is down 0.7 percentage points from last month. The figure for the same month last year was also 5.4%.

The NEET Interdependencies group has met again and is working to review and streamline processes to support a reduction in our figures, particularly the Not Known cohort, in order to ensure young people are offered the best support possible to move into a positive destination.

The NEET population of 1,049 young people comprises 412 in the year 12 age group and 637 in the year 13 age group. District performance for NEET varies from 1.6% in Sevenoaks to 5.6% In Thanet, though most districts are between 2.0% and 3.0%.

The Participation rate has increased slightly this month to 90.1%, and is 0.5 percentage points lower than the same point last year. District performance for Not Knowns ranges from 1.6% in Maidstone and Tunbridge Wells to 3.1% in Thanet.

The collection of Intended Destinations for Year 11 pupils is almost complete. Schools have submitted returns, and Intended Destinations are currently known for 82.0% of young people. Further work is taking place to ensure as complete a dataset as possible. Gaps are mostly caused by young people who are undecided and therefore do not yet have an intended destination, or where there are matching and data quality issues.
