

## Welcome and Introduction Alex Gamby, Head of Early Years and Childcare

Thank you to those of you who responded to our Early Years and Childcare Provider Satisfaction Survey 2016. We were pleased with the level of response and the nature of the feedback on our services. The survey was conducted online for a period of four weeks and we had 225 responses. Respondents were asked to strongly agree, agree, disagree or strongly disagree with a series of statements. The outcomes were as follows:

#### 1. Vision and Direction of Travel

There is clear vision and direction of travel for Early Years and Childcare provision in Kent over the next two to three years communicated through KCC's Early Years and Childcare Strategy 2016-19.

### **News and Updates**

#### Early Years Funding Rates

Following on from the communication emailed from Patrick Leeson on 28 February, providers should now have received a letter from KCC Finance confirming their individual hourly rate. Please ensure that you read this carefully and let Management Information or Finance know if you think your rate may be incorrect.

#### Early Years Census and Provider Survey

The deadline for the Early Years Census and Provider Survey was Friday 3<sup>rd</sup> February 2017 – thank you to all those who completed it on time.

You may recall that Management Information requested all settings to collect new data items on behalf of the Department for Education (DfE) for the January 2017 Early Years Census. The DfE requested this to keep in line with the School Census but later decided that there was no need to extend the collection of data on nationality or country of birth to the Early Years Census. We are very grateful for all those settings that did collect and record the ethnicity, country of birth, nationality and language in their Spring 2017 Headcount and will continue to collect this.

#### **Childcare Choices - New Website on Government Childcare Offers**

<u>Childcare Choices</u> sets out all current and upcoming Government childcare offers and support available to parents, including the Tax-Free Childcare scheme and 30 Hours of Free Childcare, the 15 hours of Free Childcare, Tax Credits, Universal Credit and Childcare Vouchers. Included on the website is a Childcare Calculator for parents to compare all offers and support available to them and check what works best for their family.

Parents will be able to use Childcare Choices to register for alerts for the Tax-Free Childcare scheme, which the DfE and Treasury have now confirmed will start from 28 April for parents of the youngest children. They can also sign up for information about the 30 Hours of Free Childcare for three and four year olds, coming in from September.

#### Free for Two (FF2)

At the end of the autumn term 2016, the take-up of FF2 places was 74%, the highest rate achieved in Kent so far, which is very good. This equates to 4302 children out of 5814 potentially eligible children identified by the DWP and an increase of 4.41% when compared to the end of the autumn term 2015.

The FF2 Parental Declaration, New Starter Claim, Continuing Claim and Adjustment Claim forms have been amended to reflect the directive from the DfE that Early Years providers should collect details of children's ethnicity. Only the options shown on the list that was provided by the FF2 team should be used. This may not be the same as on your registration forms. A great number of forms are being received stating ethnicity as 'White British' which is not a valid option. Please bear in mind that ethnicity is not the same as nationality or country of birth. Ethnicity refers to racial heritage and may be based on many things, including, for example, skin colour, culture, ancestry or family history. Parents may, however, refuse to give this information.

If you become aware that a child on the FF2 scheme has been adopted from care, please advise the FF2 Team as soon as possible in order to protect the confidentiality of the child and provide new details including name of the child, and name and address of the adoptive parent. All claims for payment should then be submitted in the child's adoptive name.

#### **DBS Checks for Committee Trustees**

Some providers have highlighted recently that when applying for a DBS check for new committee trustees, they are being charged £52.10.

It would appear that there is confusion in the overarching description of the two types of application category, described by Capita as 'Role Guidance' and 'Volunteer Guidance'. A Committee Trustee is listed under the 'Role Guidance' and the word 'volunteer' in the other grouping seems to be slightly misleading.

Please ensure that when applying for a DBS for a committee trustee the application is included under 'Role Guidance' which will ensure that their DBS application will not then incur a £44 fee. A typical volunteer application applying online and checking their ID via a responsible person will be charged £8.10 ( $\pounds 6.80 + \pounds 1.30$ ).

#### Business Update – Employers Reclaiming Statutory Sick Pay (SSP)

Please note for businesses managing payroll manually HMRC no longer allows you to reclaim SSP. For details regarding payments should you be insolvent please go to web <u>link</u>.

Employees who are sick at the time an employer becomes insolvent can still be paid by HMRC. Employers should signpost employees to contact the Statutory Payment Disputes Team on 03000 560 630.

#### Is Your Setting Ready for Ofsted?

Being prepared for Ofsted is not about someone coming to the setting to undertake a 'mock' inspection. Being prepared is being confident in your leadership and management processes and systems, having confident and informed staff that know their key children and who ensure they are providing inclusive, high quality and challenging learning experiences for all children.

#### Early Years and Childcare Service Centrally Funded Support: The Annual Conversation

All children in Kent are entitled to good quality Early Years education and our aim is to work with and alongside providers to ensure all children have access to high quality provision.

The Annual Conversation visit is offered to all Kent's group Early Years Private, Voluntary and Independent (PVI) settings. The purpose of this visit is for providers to engage in a shared professional dialogue with an Early Years and Childcare Improvement Adviser, to explore and understand the setting's approach to the monitoring of the quality of provision, the safeguarding and welfare requirements and its place within the self-evaluation and setting improvement planning processes, with the aim of reducing the risk of providers falling below a 'Good' Ofsted judgement.

Currently 97% of Kent's Early Years Settings have a Good or better Ofsted judgement.

Every group PVI setting will be offered the Annual Conversation this year and we strongly encourage managers to take up this offer. It is available at no cost to settings and could help to identify any areas of the provision that could prevent the setting from getting a Good or better judgement.

An Early Years and Childcare Improvement Adviser will contact the setting to arrange this visit.



#### Deferred Entry to School

Parents have the right to delay their child's start date (known as deferred entry), until later in the school year, but not beyond the beginning of the term after they turn five and not beyond the beginning of the final term of the school year in April.

Children may also start part time later in the school year, but not beyond the beginning of the term after they turn five.

If parents plan to defer their child's start date until later in the school year, they must still apply at the usual time for Primary or Infant school places. They should also speak to the schools they are applying for, to discuss how they would like their child to be admitted.

Parents will need agreement from the admissions authority of the school for any child to start Reception Year in the following September, a full year after they were first entitled to start. This is because a new application for a later admissions round would be needed for their child to be considered for a place to be taught outside of their age group and with a younger group of children. The admissions authority will make its decision taking into account the school admissions code and the advice of the Headteacher.

To request admission to Reception Year outside of the normal age group, parents should contact the Headteacher of each preferred school as early as possible during the application period for that child's date of birth (in line with other children the same age). This will allow the school and admissions authority enough time to make a decision before the closing date.

Parents are not expected to provide evidence to support their request to defer the application, but where provided, it must be specific to the child in question. This might include medical or Educational Psychologist reports. There is no legal requirement for this medical or educational evidence to be secured from an appropriate professional, but failure to provide it may impede a school's ability to agree to defer admission.


Parents are required to complete an application for the normal point of entry (start date) at the same time, in case their request is declined. This application can be cancelled if the school agrees to accept the request for deferred entry into Reception Year the following year.

Deferred applications must be made by completing the Primary Common Application Form to the local authority, with written confirmation from each named school attached. Deferred applications will be processed in the same way as all applications in the following admissions round, and offers will be made in accordance with each school's over subscription criteria.

If a setting is in receipt of Severe and Complex Accessibility Resource Funding (SCARF) for a child where a parent is hoping for deferred entry and continuation of attendance at the setting, it is not an automatic entitlement that the setting will be granted continuation of the funding. The above processes need to be followed and then consideration will be given to each individual case at the SCARF Complex Case panel.

#### Support for Children in Care (CiC)

The Early Years and Childcare Equality and Inclusion Team is pleased to be able to share information about the support you can access for children in care (CiC) in your setting. We have worked with the Virtual School Kent (VSK) to produce this information leaflet. It gives you the names and contact details of VSK staff in your area, and more information about how you can best meet the needs of the child or children. ### Early Years Pupil Premium (EYPP) News – what is happening nationally?

Recently two Government research and analysis papers were published on the use of the Early Years Pupil Premium (see links at end of article) and we thought providers would like to see a summary of the findings. The 'EYPP Providers' Survey' involved more than a thousand group and school-based providers and the second smaller-scale paper researched provider 'Experiences of the EYPP' through 30 in-depth interviews. This summary focuses on the results from PVI providers.

#### Identification and application:

• it was most common for providers to communicate with all parents rather than targeting children likely to be eligible, although there was a balance to be struck with targeting eligible families.

#### Use of funding:

 funding was mostly spent on staff training (e.g. communication and language), targeted support by staff, literacy and numeracy resources, supporting children to play and learn outside, such as a mud kitchen, additional sessions for children and improving home learning opportunities

'We have completely transformed our outdoor area. That was based on recognizing that 60% of our families don't have gardens'. (Voluntary setting, South West)

• spending was targeted on eligible children but all acknowledged the wider legacy this brought to a wider group of children, both now and in the future.

'We want the money to be sustainable; we want it to impact on individual children, but also be sustainable for all.' (Voluntary setting, West Midlands)

#### Decision-making and monitoring:

- providers valued the freedom to choose spending strategies
- the most commonly used methods of identifying impact were discussion with staff and parents and observing and tracking the progress of individual children with systems already in use. Remember that the Kent Progress Tracker has a filter for EYPP which enables you to quickly capture relevant data
- apart from not having eligible children, the most common reason for not applying was lack of knowledge (one in five). Please request support from the Equality and Inclusion Team if this is the case for you.

#### Impact of EYPP:

- providers typically perceived EYPP to have a positive impact e.g. by focusing on increasing services and resources provided to eligible children, including those with additional needs, that they would not have normally afforded
- improved awareness and understanding of children's family backgrounds e.g. providers had run courses for parents focusing on skills that would benefit eligible children, including behaviour management, sleep and toilet training
- financial savings where the EYPP was used for training and services when set in the context of public sector cuts.

The research reflected the views seen in our own survey last year with the main barriers being:

- fluctuation and timings of payments which made forward planning difficult
- barriers to parents completing paperwork e.g. literacy, EAL, lack of motivation and stigma
- showing impact where a limited amount of funding was claimed.

'Even though it's not a huge amount of money, it still makes a difference.' (Private setting, West Yorkshire)

'I think the nursery staff actually feel valued that they're getting a pot of money that is dedicated to their children...It's raising the status of nursery education and it's showing the value I personally place on education.'(Voluntary setting, West Midlands)

Key messages and recommendations included:


- to standardise eligibility criteria or to make criteria more transparent
- to remove burden from parents to complete application forms
- to provide more guidance on how to spend the money
- to give improved guidance and support to monitor the impact of EYPP with standardised tools, which could show performance across settings.

The research showed that support from local authorities was 'highly valued'. In Kent, we have seen a significant increase in the uptake of the funding last year, so please keep up the good work and let us know how you are using the funding in your setting and also any further guidance you would like. Settings in collaborations may want to think about pooling EYPP funding for greater effectiveness. Management Information is working hard to improve EYPP processes and the Equality and Inclusion Team has a separate EYPP page on <u>KELSI</u> for your information. In future bulletins, we hope to bring you some case studies about the impact of EYPP funding locally.


# **Briefing and Networking Sessions**
