# **New Safeguarding Documents**

On 26th March 2015, the Department for Education published a set of new and revised safeguarding documents.

The two key documents for safeguarding and child protection are 'Working Together to Safeguard Children' and 'Keeping Children Safe in Education'. Both these documents have been revised largely to include legislation that has been enacted since their original publication.

Working Together to Safeguard Children 2015 clarifies that the guidance applies in its entirety to all schools, including independent schools, academies and free schools, who all have duties in relation to safeguarding and promoting the welfare of pupils, consistent with *Keeping Children Safe in Education*.

Other additions include duties under the Counter Terrorism and Security Act 2015; disqualification regulations; and an increased emphasis on child sexual exploitation.

The management of allegations against staff has altered slightly. Local Authority Designated Officers (LADO) have been re-defined as 'designated officers'. These officers might be teams of people. Although it might sound the same, the designated officers must be part of a coordinated approach to child protection and not isolated from those teams. The designated officer(s) must be qualified social workers (except from those already in post, or moving to a new authority from an existing LADO role). KSCB procedures and Operational Guidelines for allegations management will be updated accordingly.

Two new documents are particularly useful. 'Information Sharing' aims to ensure that schools and other organisations understand both their duty to share information and when they are prevented from doing so. The document has a useful flowchart and "myth-busting" guidance.

'What to do if you're worried a child is being abused' is an update to the 2006 edition. The new document may be helpful to share with new staff during induction in addition to Part 1 of Keeping Children Safe in Education which, as you are aware, all staff must be given.

# Disqualification under the Childcare Act 2006

Following the publication of supplementary 'advice' to *Keeping Children safe in Education* by the Department for Education in October 2014, Primary schools have become increasingly concerned about the impact that the Disqualifications Regulations are having on their schools, which has raised anxiety levels about possible failure to comply as this is something that Ofsted are monitoring during inspections since January 2015.

In response to the concerns raised by schools, local authorities and settings to this supplementary advice, and after a small scale consultation process, the government published revised guidance on 26 February 2015. #### **Female Genital Mutilation**

There are new legislative measures being brought through the Serious Crime Act 2015 which will strengthen the legislative framework around tackling FGM.

According to the United Nations Children's Fund (UNICEF), there are an estimated 130 million women and girls living with FGM worldwide. Most of these women are located in 29 African countries. In the UK, FGM is increasingly identified amongst migrants from FGM-practising countries. There are an estimated 137,000 women in the UK affected by FGM.

Professionals in all agencies, individuals and groups in relevant communities, need to be alert to the possibility of a girl being at risk of FGM, or already having suffered FGM. There is a range of potential indicators that a child or young person may be at risk of FGM, which individually may not indicate risk but if there are two or more indicators present this could signal a risk to the child or young person. Victims of FGM are likely to come from a community that is known to practise FGM.

Professionals should note that girls at risk of FGM may not yet be aware of the practice or that it may be conducted on them, so sensitivity should always be shown when approaching the subject. ## **Counter-Terrorism and Security Act 2015**

The Counter-Terrorism and Security Act 2015, due to come into force on July 1<sup>st</sup>, places a duty on schools "to have due regard to the need to prevent people from being drawn into terrorism". Schools have a vital role to play in protecting pupils from the risks of extremism and radicalisation and keeping children safe should be approached in the same way as safeguarding children from other risks.

To help schools and Early Years settings meet the requirements of the Act we recommend the South East Counter Terrorism Unit (SECTU) toolkit is completed which can be found on Kelsi: <a href="Education-Prevent-Assessment-SECTU-Tool.pdf">Education-Prevent-Assessment-SECTU-Tool.pdf</a>. This will also help provide the evidence needed for Ofsted and the ISI purposes.

# e-Safety Update

# NSPCC ChildLine Assembly Event – 7<sup>th</sup> July

Many schools will have used the free Service for Primary schools which has been available form Childline for some months now. The service is aimed at children aged 9 to 11 years and seeks to raise awareness of abuse and how to seek help and support.

The NSPCC (ChildLine) Schools Service are now planning an event for Tuesday 7th July in Canterbury. These events bring together clusters of local schools in one venue, where messages about keeping safe from abuse, and where to go for help, can be provided on a much larger scale. Flyer below.

#### The NSPCC Schools Service Big Assembly Kent University (Woolf College – The Pavilion) 7<sup>th</sup> July 2015

The NSPCC's hugely successful Schools Service is protecting children in primary schools across the UK right now. However, we need to do more to reach every single child in order to protect an entire generation. Therefore, whilst a key part of our service focusses on delivering in schools, we are also running Big Assemblies across London and the South East. These events bring together clusters of local schools in one venue, where we will deliver our messages about keeping safe from abuse, and where to go for help, on a much larger scale.

In January this year we held our first Big Assembly at the Lee Valley Velodrome in the Queen Elizabeth Olympic Park. The event was an unqualified success and we saw 660 children in one morning.



On 7<sup>th</sup> July we are holding a Big Assembly at the University of Kent. We will run a morning and afternoon session and hope to see up to 600 children in one day. As with our in-school service, the NSPCC will provide this event free of charge. Here is the itinerary for the day:
