Dear early years and childcare providers

Kent County Council: COVID Related Closures and Free Early Entitlement Funding

We have received a number of enquiries recently from providers wanting to close early ahead of Christmas, with the potential implication of children missing out on several days of their entitlement. Whilst we (ie Kent County Council [KCC] and The Education People) continue to be extremely grateful for and proud of the way providers in Kent are dealing with the COVID-19 situation, and recognising the daily challenges this presents, we have to work within the statutory guidance which places a duty on KCC to secure sufficient childcare to allow parents to work. It goes without saying that this has never been more crucial for critical workers than during these unprecedented times. What we would all clearly want to avoid is examples where the majority of parents vote to close early but there are a handful who don't but are forced into accepting the situation because providers then say it is not financially viable to stay open for just those few parents. The Prime Minister has been very clear in his addresses to the nation that he expects early years and childcare providers to be open and provide a much needed service to parents, and Government guidance reiterates this. Where there have also been suggestions that any missed sessions might be offered during 2021, none of us can predict what challenges we might be facing in the Spring and Summer so it might not be possible to give the sessions then. Therefore, in this context, we feel that we must stay in line with published DfE guidance, that any setting choosing to close other than on the advice of Public Health England would have to repay funding for the period of closure, unless agreed differently as a consequence of our recent guidance on COVID-19 related closures and funding.

Government Updates for Families

<u>Protective measures for holiday or after-school clubs and other out-of-school settings</u> for children during the coronavirus (COVID-19) outbreak

This guidance informs practice for out of school providers. It was recently updated to give more information about social distancing (including pick up), who can attend (also see the equality section) and information for providers who offer music, drama, dance and sports provision after school.

Making a childcare bubble with another household

This document sets out how you can use informal childcare (friends and family) with people you do not live with. The guidance now includes how to switch your childcare bubble so you can keep everyone safe and reduce the risk of transmission.

Guidance for parents and carers of children attending out-of-school settings during the coronavirus (COVID-19) outbreak

This guidance informs families about the changes that out of school settings should be considering. It also includes updates about parent and child groups and if you have a child with health concerns.
