Free Entitlement and Childcare Period 15th April 2024 – 31st August 2024 Summer Actuals Claim

Synergy FIS Provider Portal

For the summer terms 2024 funding claims the 'Actuals' tab will be open from today, Monday 15th April for **all** 2, 3 and 4 year old claims. This is earlier than usual for 3&4 year old funding claims as providers may have additional children due to the expanded working parent entitlement.

The following types of claims can currently be submitted:

Free For 2 Funding

For Free For Two funding (2 year old disadvantaged) claims can be submitted for children that attend your setting from 15th April. All claims submitted by **5pm on 30th April** will be paid week commencing 27th May 2024.

3&4 Universal and the Working Parent Entitlement for 2-4 year olds

The deadline for submitting your 2 year working parent entitlement and all 3 and 4 year old claims is **5pm on Tuesday 30th April 2024**.

Claims **should not** be submitted for children who are not in attendance during the designated **headcount week** (22nd to 26th April) unless there is a known reason (i.e.

sickness or holiday). Please do not submit claims for children who have not yet started with you. You must ensure that all parents/carers have completed and signed a parental declaration for this term before submitting the claim.

The 'Actuals' tab will show details of children who claimed funding last term, however, to avoid incorrect submissions, no hours have been carried forward. You will need to add the funded hours for **all** children and check the weeks attended in the term are correct. If you need to delete any children that are no longer at the setting, please click the black X next to their name, further guidance can be found on page 8 of the Synergy guidance.

Balancing payments for the 2 year working parent entitlement and all 3 and 4 year old claims should be in providers' accounts week commencing Monday 10th June 2024.

Please be aware that passwords will need to be reset every 42 days.

The Working Parents Entitlement

To receive payment, you must have completed a Working Parents Entitlement validation check through KELSI for **all** 2, 3 and 4 year old children you are claiming the entitlement for. Please check your records to ensure this has been completed to avoid your payment being withheld.

You must only submit a claim for the working entitlement hours using a code that is valid for the summer terms. If the start date of the code is after 31st March 2024, it is not valid for a summer term claim. If you submit a claim and an invalid code is accepted in your headcount submission, this will **not** be processed for payment.

Full information on the working entitlement is available on KELSI.

Late Joiners

The adjustment tab will open from Wednesday 1st May 2024 for providers to add any late joiner claims. The deadline to submit Summer 2024 Late Joiners is Friday 30th August 2024.

Early Years Pupil Premium

You will have recently received information about the new way that EYPP is being claimed. In signing the new parental declaration parents give consent for information to be submitted to KCC to check eligibility for Early Years Pupil Premium. Please remember to complete the parent/carer tab and tick the EYPP box in the Synergy portal for all claims so we can complete this check.
