Updates for the Sector

Ofsted: coronavirus (COVID-19) rolling update 3 June 2021

Change made: Updated the guidance on paediatric first aid certificates. "If your paediatric first aid (PFA) certificate expired on or after 1 October 2020, the DfE previously advised that this would be valid until 31 March 2021. The extended deadline for requalification has now passed and providers must have a valid PFA certificate in place".

<u>Find examples to help you calculate your employees' wages</u> 3 June 2021 Change made: The example for how to calculate the amount you should claim for an employee who is flexibly furloughed during June 2021 has been updated.

(COVID-19) Coronavirus restrictions: what you can and cannot do 8 June 2021 Added guidance for people living in areas with variants of concern.

What to Do if a Child or Adult is Displaying Symptoms of or Has a Confirmed Case of COVID-19

The following is not new information, it is a reminder of current documents and current requirements. Having recently been asked by some settings whether they have to report cases to the DfE Helpline, we felt it timely to resend the appropriate information.

Please find attached the latest South East Public Health England Edu-settings Resource Pack. Section 1.1 of this document states the following:

The DfE COVID-19 helpline was introduced to relieve the strain on the local Health Protection Teams (HPTs).

Schools and other settings should call this helpline if they require advice about single or multiple cases of COVD-19 for assistance with undertaking risk assessments. However, if an education setting is comfortable managing their own cases and feel that they do not need to call the helpline for support then it is not mandatory to do so.

Helpline opening hours: Monday to Friday from 8am to 6pm (plus Saturday to Sunday 10am to 6pm for advice about cases or other COVID-19 related issues).

The DfE helpline has an escalation process with the PHE Health Protection Teams and will notify them of any complex cases and issues which might require their input.

If you have been managing your own cases, you should contact the local Health Protection Team through the DfE Helpline in the following circumstances:

- if the number of cases exceeds 2 within 14 days
- if you have taken the action outlined in Government guidance but are still seeing more cases
- if you are thinking you might need to close because of the number of people affected
- if a child or staff member in your setting has been admitted to hospital
- if you are getting significant interest from local media.

Your local health protection team will advise you on the next steps.

You must notify Ofsted, or the childminder agency with which you are registered, of any confirmed cases in the setting (either child or staff member). You should also tell Ofsted if you have to close your setting as a result. Report as soon as you can, and in any case within 14 days. Please read the guidance on reporting incidents to ensure all of the information required is included.
