Young People Not in Education, Employment or Training

Monthly Report – February 2016

1. Context

The data for February indicates that there has been both a numerical and a small percentage increase in the NEET population within the county during the last three months. The position for the Vulnerable Groups during the previous six months, between September 2015 and February 2016, reveals significant changes for the number of NEETs and Not Knowns. The number of:

- (i) NEETs has increased from 516 to 745 (+44.3%)
- (ii) Not Knowns has fallen, month on month, from 1812 to 221 (-87.8%)

The number of individuals becoming NEET increased during February amongst all three age groups, with the largest being amongst the 18 year old age group (+156). The number of those leaving the NEET group was also greatest amongst the 18 years age group (+107) with 16 year olds having the lowest number (+61).

2. Partnership Activities Undertaken to Support Delivery of the Strategy

Activities include:

Improving the KentChoices4U website to facilitate ease of access for young people and for professionals, the work has been led by Skills & Employability. The new site has an interactive map of the county which will enable the identification and contact details for all EET opportunities available to young people. This will enhance significantly the current publications of the "Kent District Offer".

The development of District Strategies for the NEET Reduction. The purpose of the Strategy is to provide a set of benchmarks to provide collaborative approaches between partners to deliver effective preventative interventions and support for those who have become NEET. Workshops have been delivered in Canterbury and in Thanet and a further one is scheduled for Swale towards the end of March

Identify the young people in Year 11, as part of the planning for the September Guarantee, who have yet to record an intended destination on the IYSS database. The plan is to make contact with all these young people, including those who are being educated at home, so that their support requirements can be assessed with a view to enabling them to make a successful transition and provide additional support

Events for young people, organised by Skills & Employability and Youth Hub Delivery Managers, to facilitate opportunities for them to meet EET opportunities for those in Year 12

Executive Summary - continued

Considerable progress being made to track young people recorded on IYSS as Not Known status and the outcomes are reflected in the data reported

Plans to strengthen and clarify the role of the Participation Pathways Operational Group are underway to ensure that there is representation from services responsible for each of the vulnerable groups. Representatives responsible for Youth Justice, Pupil Referral Units and Attendance and for those with special needs aged 18+ years will be invited to these meetings

Ongoing training of staff from different services on IYSS with the expectation that a higher number of users will lead to data being more readily entered and as a result its quality increasing

3. Management Information

Ongoing data processing work continues to be undertaken by the MIU (Education & Young People's Directorate) in the last month includes:

- (i) processing monthly updates from schools on joiners and leavers and colleges on joiners
- (ii) processing monthly updates from National Apprenticeship Service
- (iii) identifying possible not known matches with other CCIS databases nationally to agree the lead LA
- (iv) monitoring data quality and issues addressed with users to ensure records are updated























% of Vulnerable Cohorts who are NEET




