Headline Commentary

Figures for May continue to show a stable position for the NEET population, which remain at 3.0%, the same percentage as last month (1,002 young people). The proportion of Not Knowns has risen from 1.8% to 2.4%, which is an expected seasonal trend, as some courses come to an end.

These figures compare to a NEET figure of 3.3% at the same time last year, and a Not Known figure of 3.7% this time last year.

The combined NEET and Not Known figure is at 5.4%, up from 4.8% last month, due to the increase in the Not Knowns. The figure for the same month last year was 7.0%.

The NEET population of 1,002 young people comprises 396 in the year 12 age group and 606 in the year 13 age group.

The Participation rate has decreased slightly from last month, down from 91.4% to 90.6 %, and is 1.2 percentage points higher than the same point last year.

District performance for NEET varies from 1.4% in Sevenoaks to 5.1% in Thanet, though most districts are between 2.0% and 3.0%. District performance for Not Knowns ranges from 1.1% in Tunbridge Wells to 3.3% in Gravesham.

Combined NEET and Not Known figures range from 3.1% in Tunbridge Wells to 8.2% in Thanet.

The collection of Intended Destinations for Year 11 pupils is almost complete. All schools have submitted returns, and Intended Destinations are currently known for 88.0% of young people. The remainder is either where young people are undecided, or where there are matching and data quality issues. These continue to be followed up.

Chart 6 - Statistical Neighbours NEETs April 2018

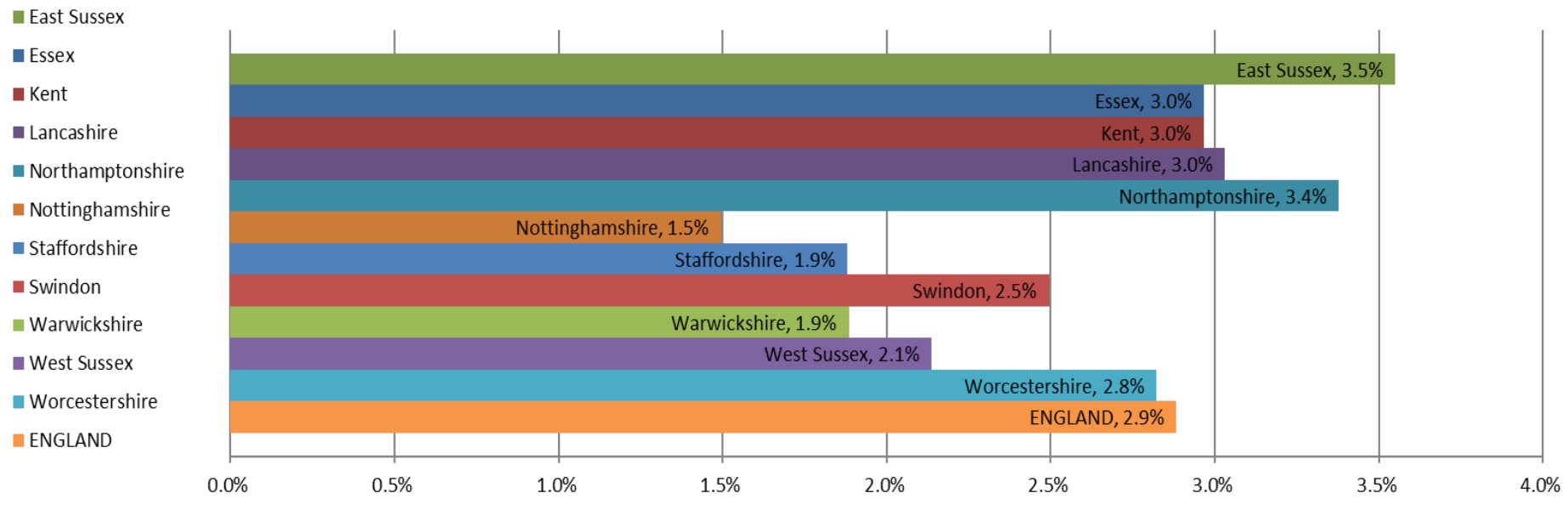
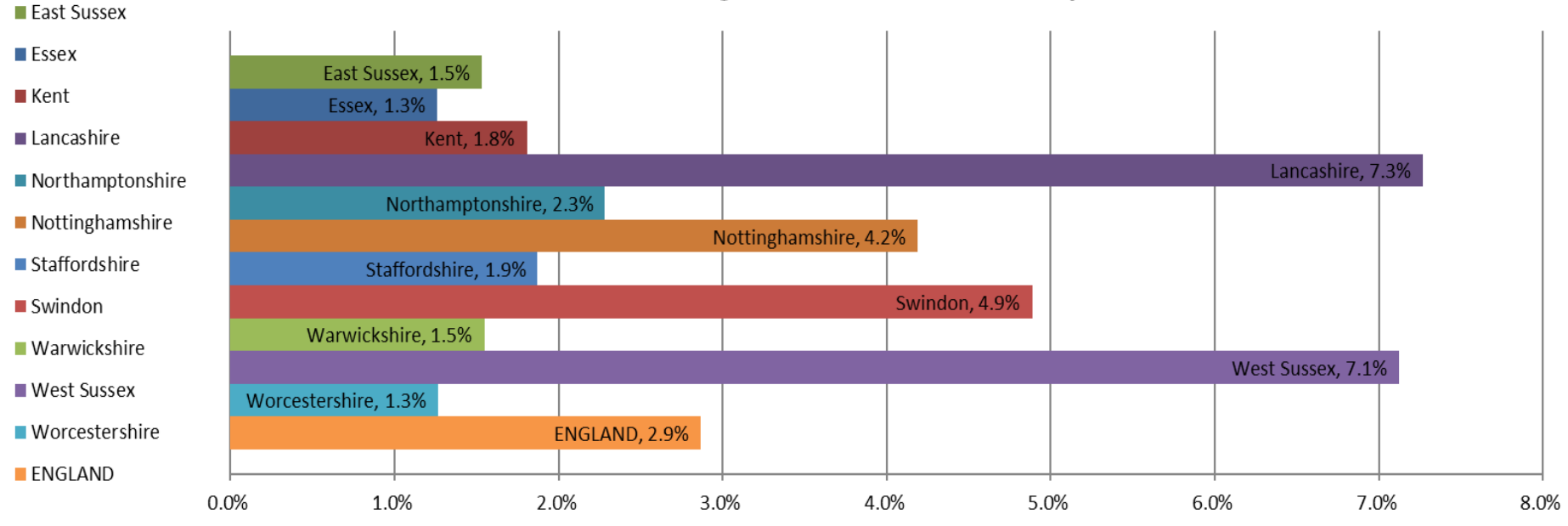


Chart 7 - Statistical Neighbours Not Knowns April 2018
