Academic age is the age of the young person on 31<sup>st</sup> August (i.e.: prior to the start of the academic year). The figures include all 16 -18 year olds based on academic age with a Kent County Council area postcode as their primary address.

### **Executive Summary - continued**

#### Strategic and Planning Skills and Employability

The change in rules this year regarding the recording of when college leavers become 'Not Known' has for the second month impacted on the overall total of 'Not Knowns' and explains the increase on last year. A high proportion of these leavers will be joining second and third years in sixth forms or FE colleges and their status will be captured in the returns from these institutions in September and October.

Those young people who left an advanced two year course in July this year, were contacted in August. The other focus for tracking Not Knowns in August was on those young people without a September Guarantee. As a consequence, the percentage of Year 11s without a September Guarantee is 8% lower than the same time last year and for Year 12's it dropped by 8.9% between July and August this year.

#### Early Help and Preventative Services

Early Help and Preventative Services, including Youth Justice, are currently taking a range of actions in response to the increases in the number in the NEET population (16 – 18 years academic age group) and in their percentage share of the overall cohort in this age group in the county. The actions will include:

(i) preparing a plan for the new service structure which will set out proposed approaches for both targeted and universal access opportunities, co-ordinated via the Youth Hubs in each District, for the NEET population. Youth Hub staff are working with CXK in targeting the vulnerable groups with the latter providing both drop ins, 1:1 appointments and surgeries. The Thanet Hub, for example, has Avanti co-ordinating a 4 week Dance intervention Project for young people who are NEET, running between 14.09.15 – 14.10.15, a 16+ group each Wednesday evening to deliver information and signposting on to programmes when appropriate, such as CXK Elevate, Talent Match and Youth Contract

(ii) a specific focus with District Managers and Youth Hub Delivery Managers in Swale, Thanet and Shepway, where the highest rises in the NEET population have been recorded, will be undertaken by Information & Intelligence during September and October

(iii) Information & Intelligence is undertaking an audit of cases with respect to ETE related activity and impact. The audit covers the 31 cases involving 16 & 17 year olds that will close during August & September - this will provide information on the accuracy of recording; if ETE is in the initial plan and if there is evidence that YP are supported into ETE in the final planning stage. It will also identify the level of needs of the young people and if they show willingness to engage in ETE; are offered an ETE place during their intervention and remain in that ETE destination for more than 4 weeks. The intention is to support effective interventions focussing on ETE within a youth justice service (iv) Information & Intelligence completing an audit of Youth Hubs which will enable best practice with the NEET population to be disseminated and the learning used to establish approaches which are consistent across all Districts and where there is evidence of effectiveness

(v) the NEET data sets published monthly by the Management Information Unit (Information & Intelligence) being shared with each of the Districts and used to inform the targeting of individual young people for support – these young people will include those who are both NEET and who are known to the 4 Youth Offending Teams across the county, including those being released from custody so improving through the gate support for individuals resettling in the community

(vi) establishing a consistent model across all Districts for the recording of participation and destinations for young people known to EHPS on IYSS so that the quality of data and management information reporting improves significantly – this in turn will assist the understanding of the population and of their needs if they are to be assisted to participate in EET. An IYSS training the trainers programme will be completed on the 22<sup>nd</sup> and 23<sup>rd</sup> September and the training of staff (Youth Hub Delivery Managers, Senior Early Help Workers and Business Support) similarly completed at the earliest possible point

#### Skills and Employability


In September, while enrolment data is collected from schools and FE colleges by the Management Information Unit, the focus of the Skills and Employability Service will be to set up the processes to collect leaver data from sixth forms, this will impact in October; to continue to communicate with providers about tracking processes, roles and responsibilities; strengthen the link with the Department for Work and Pensions and training providers and to track those in employment or apprenticeships whose status on the IYSS database has expired.


