Please be aware that a child can claim a maximum of 570 hours of Free Early Education (universal entitlement) in a funding year and, if eligible, a further 570 hours of free childcare (extended entitlement). A child's funding year starts the term after their 3rd birthday in line with the table below:

Funded Weeks

In line with the Kent Provider Agreement, Providers can now offer a non-stretched or stretched pattern or both. However, where providers are unable to open for the 38 weeks and this has been agreed with KCC, the provider must ensure that parents are made aware prior to taking up their place that they will not be able to access their full free entitlement with them.

*Please note: Due to Easter bank holidays falling late this year, if a child attends on a Monday, 2 days will need be offered at the end of Summer term to ensure the child receives their full entitlement. Please refer to the sample calendars in KELSI to assist with working dates out.

Settings offering Stretched funding

In the case of a parent taking up the 'stretched' offer, they must be made aware that they may exceed their free early education hours and be given the option of either (a) removing their child from the setting or (b) paying for the additional hours. Under no circumstances can you insist that the parent pays; they must have the option to remove their child if this best suits their circumstances. The terms around these extra hours must be agreed between yourself and the parent at the time they sign the Parental Declaration. Please be aware that the choice of whether to stretch the funding is up to each Provider and is not obligatory.

Should you wish to stretch funding between 38 or 48 weeks or 48 weeks plus please claim the funding over 38 or 48 weeks per year via Synergy and then stretch the funding yourselves with the parent. There is a calculator available on KELSI to convert non-stretched hours to stretched. You will also be required to track these children on the stretched tracker for audit purposes which is also available to download from KELSI. These tools are only required to be

used if you are stretching funding outside of the 38 or 48 week pattern.

There are 2 sample calendars on KELSI to assist you with working out your term dates. When stretching funding for a child for 48 weeks you **must** remember to tick that the child is stretched at headcount in Synergy and check the weeks you are claiming for are correct.

Providers should be aware that the universal and extended funding will be capped at 570 hours each a year (the maximum number of hours the Department for Education fund Local Authorities) so Management Information will deduct any overclaimed hours in the final term of the child's funding year.
