Headline Commentary

Figures for February continue to show a stable position, and tend to reflect, with December and January, the most reliable reporting period in the academic year.

The NEET population has increased slightly this month to 2.8% (908 young people), up from 2.6% last month. This compares to a figure of 3.3% at the same time last year. This slight increase to 2.8% is small given the Not Known population fell significantly to 2.0% this month (654 young people), down from 2.8%, showing only a small proportion of these Not Knowns were found to be NEET. This is the lowest ever-recorded level of Not Knowns in Kent. The Not Known figure in the same month last year was 3.1%.

The combined NEET and Not Known figure is at 4.7%, down from 5.4% last month. The figure for the same month last year was 6.4%

The NEET population of 908 young people comprises 330 in the year 12 age group and 578 in the year 13 age group.

The Participation rate has increased again from last month, up to 91.8%, and is 1.3 percentage points higher than the same point last year.

District performance for NEET varies from 1.9% in Sevenoaks to 5.4% In Thanet, though most districts are between 2.5% and 3.5%. District performance for Not Knowns ranges from 0.9% in Tunbridge Wells to 2.6% in Gravesham. All districts saw a decrease in their Not Known percentages in February.

The collection of Intended Destinations for Year 11 pupils is continuing, with Intended Destinations currently known for 79.2% of young people. As more schools submit their returns this will rise further.
