
The NEET population is currently at 3.0% compared to 3.0% at the same time last year, and our Not Knowns are at 3.0%, compared to 3.5% at the same time last year. The Participation rate is 89.9%, compared to 89.7% the same point last year.

District performance for NEET varies from 1.9% in Tunbridge Wells to 4.5% in Thanet. District performance for Not Knowns varies from 1.9% in Canterbury to 4.7% in Dover.

The Local Authority has a statutory duty to collect data from all education establishments regarding offers they have made to 16- and 17-year olds from September. It is an important part of our planning and transition support offer. Enabling us to identify those at-risk of NEET, gaps in local provision and to work alongside you in supporting our most vulnerable young people.

Please note the Kent and district NEET Y12 & Y13 targets have been updated to the September 2022 figures.


## **Youth Offending Team NEET and Not Known Breakdown**





