## **Introduction**

### **What is the purpose of the District Data Pack?**

The purpose of the district data packs is to stimulate discussion within district education/training communities on how best to prepare young people for employment, be that at the end of key stage 4 or after post graduate study.

The packs look at new and old data sets and ask searching questions about local pathways, their compatibility with the local economy and the support young people receive; particularly vulnerable young people. They have been produced as a desk top exercise, they do not propose solutions, but provide the key questions that need addressing and the data to support the development of localised solutions.

### **What data has been used?**

The intention has been to use where possible data that has not been widely used and to collate data to give an overview at a district, county, regional and national level to provide a wider context.

A significant number of data sources have been drawn together and as a consequence there will be some minor inconsistencies in the data. However, where there may be inconsistencies in the data, this is highlighted and the messages the data provide are consistent.

This is unavoidable due to the way data is collected locally, regionally and nationally. Kent County Council, Education Learning and Skills Directorate are currently reviewing the way it stores data and the way it works with other directorates.

### **How does the District Data Pack support Kent County Council Policy?**

The Local Authority has clearly articulated how it intends to support young people make the most of their potential in the 14-24 Learning, Employment and Skills Strategy and the structure of the data pack reflects its four strategic priorities:

- To raise attainment and skill levels
- To extend and improve vocational education, training and apprenticeships
- To increase participation and employment
- To target support to vulnerable young people

### **How should the District Data Pack be used?**

The executive summary tells the high level picture of the district and raises 8 key questions. Each priority section then has a summary, the supporting data from which the conclusions have been drawn, followed by a number of more searching questions.

It would not be possible to address all of the issues raised in the data pack at once, it is for local groups of education/training providers and employers to identify their own local priorities and strategies.

The data packs should not be used in isolation and local providers may wish to use the UKLP datadashboard on level 3 provision and their own data systems to complement the process.

Allan Baillie your local Skills and Employability Area Manager and Simon Bounds the Participation and Progression Officer will be able to support districts co-ordinate their response.

### **The relationship with the District scorecards**

The district data packs do not establish any new benchmarks or measures for local providers; their purpose is support providers' strategic planning.

## Executive summary

### 1. 16-18 population

Canterbury is a district that considerably more learners travel into rather than out of for Year 7-11 and for sixth form education. This suggests that Canterbury learners consider that they can access what they need within the district, particularly with regard to FE.

There is a dip in population which will be an issue for provision in the medium term: the Year 7 – 11 population is predicted to decline until 2016/17, after which it will climb steadily again. The sixth form population is forecast to rise until 2014/15, after which it will decline significantly before bottoming out in 2017/18.

The sixth form forecast models do not take into account the effect of Raising the Participation Age, which may increase numbers in sixth forms. If some providers can modify their sixth form provision to cater for RPA they will not see a decline in numbers. Those who do not modify their provision to attract learners as part of RPA will see a decline in numbers which may affect the quality of their sixth form.

Compared to the Kent average, Canterbury has a high proportion of retired people living comfortably, students, middle aged parents on benefits and people on the cusp of retirement.

This implies that:

- Canterbury has a population which has a high proportion of people who are middle aged or above
- Affluent people in Canterbury tend to be older
- Many of the younger age group in Canterbury are transient students who may not remain in the area
- Children of school age in Canterbury are likely to come from a broad range of income backgrounds

Providers of post 16 education need to bear in mind that there is a wide range of socio economic backgrounds for their students and that the Canterbury population is highly transient compared to the rest of Kent, especially considering the 7 million tourist visitors who pass through each year.

### 2. Raise Attainment

Over 1 in 4 Canterbury learners who gained additional qualifications by age 19 after leaving compulsory education did not progress to the next educational level. This was most significant for those learners who at age 16 were below Level 1 or at Level 2 without English and Maths, where over half did not progress to Level 3. This reflects both county and national trends, but in Canterbury performance was slightly lower.

However, when it comes to the proportion of learners who get no further qualifications at all post 16 by age 19, Canterbury performs slightly better than the Kent and National averages, but this still equates to 136 learners.

Canterbury is in the third quartile in Kent for both GCSE English and Maths at Key Stage 4. Almost 1 in 3 Canterbury learners did not get a Grade C or above in English or Maths. This is considered an essential attainment threshold by employers and is a major barrier for further progression.

A Level performance in Canterbury is not as strong as one might expect given the average KS4 points of its intake and the performance in other districts. Whilst the Average Points per Student (APS) is higher than the Kent and national average, Average Points per Entry (APE) is lower. Additionally, failure rates at AS and A Level are higher.

Performance at the “top end” of A Level is very good. Achievement at A\* is high and more students in Canterbury achieved 3+ A Levels at AAB or higher in facilitating subjects than the Kent or the national average.

However, proportional to the number of entries, a lower percentage of exam results in Canterbury achieved A Levels at every grade grouping apart from A\* than the Kent or the national average: achievement at all other grades was lower than that in Kent or nationally.

It was a similar picture for BTEC Diplomas: achievement at D\* was higher than for Kent or nationally but achievement at all other grades was less.

Canterbury performs well at progressing students to Higher Education. There is a very good range of A Level provision in Canterbury with seven of the Russell Group facilitating subjects in the top 10 most popular courses. Two schools in particular are very successful at progressing students to Russell group universities.

There is a significant gap in achievement at 19 between those who are eligible for free school meals and those who are not. The gap is 23% at Level 2 and 34.2% at Level 3.

### **3. Improve and extend vocational education, training and apprenticeships**

Whilst Canterbury had been experiencing a period of economic growth for most of the decade, between 2008 and 2011 employment in Canterbury fell by 1,900 jobs, or 3%, compared to a decline of 0.4% in Kent as a whole. It suffered more than the rest of Kent from the closure of Pfizers as a high proportion of its employees lived in the district.

Canterbury's key employment sectors of retail and public sector have suffered from the recession and resulting cuts- this trend could be reversed if the national economic picture recovers. Canterbury is a key retail centre for this part of Kent and would expect to see retail employment rise quickly if national economic growth was achieved.

The most dramatic increase in employment is in the Professional, Scientific and Technical Services Sector. This has very few relevant vocational courses at Level 3 other than IT and would benefit from a discussion between employers and providers as to what higher level courses and apprenticeships would meet their needs. Employment also grew significantly in the Accommodation and Food Service Sectors although there are few courses at Level 1.

Health and Social Care will continue to offer increasing opportunities, but again there are fewer courses at Level 1 than there should be given that many NEET young people express this as an area of interest. Travel and Tourism will be a growth area too: Canterbury City Council has a major focus on the "Visitor Economy" to complement Canterbury's status as a major tourist destination, with 7 million visitors annually and generating £495 million.

Although over the three year period employment in construction has dipped by 200, it did rise by 300 jobs in 2010-11 so is on an upward trend. The numbers of courses in this area are justified by this activity and the prospect that this is an area that would recover quickly with national economic growth.

The high numbers of self-employed people suggest that some vocational courses ought to include entrepreneurial skills including those for the arts, entertainment and recreation sectors where employment is increasing. Many of the opportunities in this sector are for freelance self-employed people.

### **4. Increase Participation and Employment**

In September 2013 the current Year 11 will for the first time have to participate for an additional year in learning, education or employment with training; by September 2015 this will rise to participation up to their 18<sup>th</sup> birthday. If the circumstances were to remain the same in Canterbury, an additional 291 young people would need to participate in September 2015.

Education providers will be held accountable for the destinations of their learners two terms after they have left learning at Key Stage 4 and Key Stage 5. This will apply to all types of learning providers. The

release of the 2012 destination data is expected in June 2013 and will include employment data for the first time.

The number of young people who are not participating in Year 13 (200) is over double that in Year 12 (91). This reflects a similar trend across the county; in fact the activities of 16-18 year olds in Canterbury are very similar to the county averages for example the number in full time education and employment with training. This does not mean that there is room for complacency when considering the Canterbury response to RPA. There will be real challenges trying to support vulnerable learners and getting the involvement of local employers to convert jobs into jobs with training; 4% of Canterbury young people are in employment without training.

Research by CXK has identified that a significant number of young people are interested in vocational areas where there are courses available locally and unemployment in Canterbury for 16-24 year olds, at 3%, is half the county average. Understanding why there are NEET young people in Canterbury, reasons for disengagement and identifying the gaps in the provision will need to be a key activity over the coming year.

A learner voice study undertaken by the Skills and Employability Service into RPA has identified that young people are very unclear about what it means for them and their options. Below are some of the main findings:

- there were problems in the communication of what RPA means to young people. They perceived it as meaning they had to stay at school and were not well informed about opportunities beyond that;
- there was little knowledge of training, work experience, volunteering or apprenticeships among 16 – 24 year olds. Half of them did not have any career plan. However, they did appreciate careers advice and guidance and preferred to receive it on a one to one basis or using online facilities. It seems that they would respond very positively to bespoke personal guidance and help in planning their future and this would encourage them to continue participating in education or training until 18;
- encouragingly young people recognised the importance of Level 2 English and Maths and expected to study this post 16 until they achieved it.

## **5. Target Support to Vulnerable Young People**

A close examination of the 16-18 year old NEET group in Canterbury shows that just under half have been identified by CXK as having a disability. Of this group over half are BESD. In addition the most significant needs for statemented learners of Year 9 to 11 in Canterbury are for those with BSED (258 learners). This group represents a significant challenge for the delivery of RPA in Canterbury

The second highest group of young people in Years 9-11 with statements are those with autistic spectrum disorders. There are also a significant number of young people in years 9 to 11 with speech, language and communication needs. Numbers for all other types of disability were very low, with no more than 3% of the NEET young people in any disability category which suggests there is good engagement and provision for other types of LLD young people.

A break down of the 16-24 CXK priority group shows that there are relatively low numbers of young people who are NEET because they are caring for their own child (37) or pregnant (12) when compared to the rest of the county. However, this is still a significant challenge.

The third highest group of the 16 – 24 CXK priority groups who are NEET are Looked After Children. Given that there are a total of 49 LAC at the post 16 stage and nearly 1 in 3 are NEET and that there are currently 70 statemented LAC in full time education in Canterbury, supporting this group this will be an ongoing issue.

There is a significant problem with permanent exclusions in Canterbury. There were 46 in the 2011-12 school year which is by far the highest in Kent. There were also 1246 fixed term exclusions in Canterbury, the fifth highest in Kent.

There were 95 children being educated at home in Canterbury in February 2013, which is the sixth highest in the county and may pose problems for post 16 transition for these students.

Canterbury was the fourth highest district in Kent for producing young offenders, but has seen a significant downward trend of offending by young people in Canterbury. Rates of offending by young people are falling across the county, but falling faster in Canterbury than in most districts. It is down 37% from September 2011 to September 2012.

Canterbury also has a significant problem with absenteeism. It had the highest number of absences at secondary school age of any district in Kent for the year 2011-12. As a proportion of learners, it is third highest behind Sevenoaks and Shepway. Canterbury is also third highest in Kent for absences from special schools.

## Key challenges for Canterbury providers

1. **Declining numbers: Canterbury has a falling number of sixth form students - there will be an 8% drop between 2014 and 2019.**

There is an opportunity for some sixth forms to mitigate this falling roll by engaging the types of students who are currently not participating using study programmes and traineeships.

2. **RPA: To meet the demands of RPA, Canterbury providers will need to engage 291 young people who are either NEET or in jobs without training, particularly in Year 13.**

They are unlikely to respond positively to a traditional A level or BTEC offer and providers will need to create study programmes which involve work placements and opportunities to achieve level 2 English & Maths as well as working with agencies offering mentoring and support such as the Porchlight Adolescent Support Service and the Youth Contract.

3. **CEIAG: Providers need to communicate the range of options available to young people from an earlier age so they can make informed choices about their progression.**

Young people are still associating RPA with the only option being staying at school or college until 18: There is very little knowledge about training, work experience, volunteering or apprenticeships among 16 – 24 year olds.

4. **Progression: Numbers of students not making progress is higher than the national average at every level, aggregating to 26.% of learners compared to 23% nationally.**

1 in 4 learners in Canterbury gain qualifications by age 19 but do not make progress to the next educational level.

5. **Although APS in Canterbury is higher than the national average, APE is lower in spite of a high performing intake at KS4.**

Failure rates and dropout (27%) at A and AS Level are higher than nationally although A\* grade rates are high. Thus whilst some schools are very successful with their top A Level students, many of them achieve low grades across a high number of subjects.

6. **Vocational offer: This needs to better reflect the needs of the local economy in the key growth areas of professional and scientific activity and hospitality and catering.**

To meet future employment needs, more provision is needed in those two areas, health and social care, and travel and tourism, especially at level 1 where there is very low provision and level 2. There is over provision in sports and leisure, creative arts and hair and beauty; all these courses also need to have a greater entrepreneurial dimension as most of the opportunities are for self employment.

7. **Inclusion: Canterbury must meet the needs of high numbers of learners with SEN.**

It is essential that the providers of the district create an offer which can engage and sustain the learners in this group in order for them to be able to participate and progress post 16. Currently a very high proportion of them become NEET AT 16 especially if they are also a looked after.

8. **Exclusions: Canterbury has by far the highest rate of exclusions and absence in the county.**

Both these are very strongly linked to young people becoming NEET at 16 and unemployed in their early adult life.

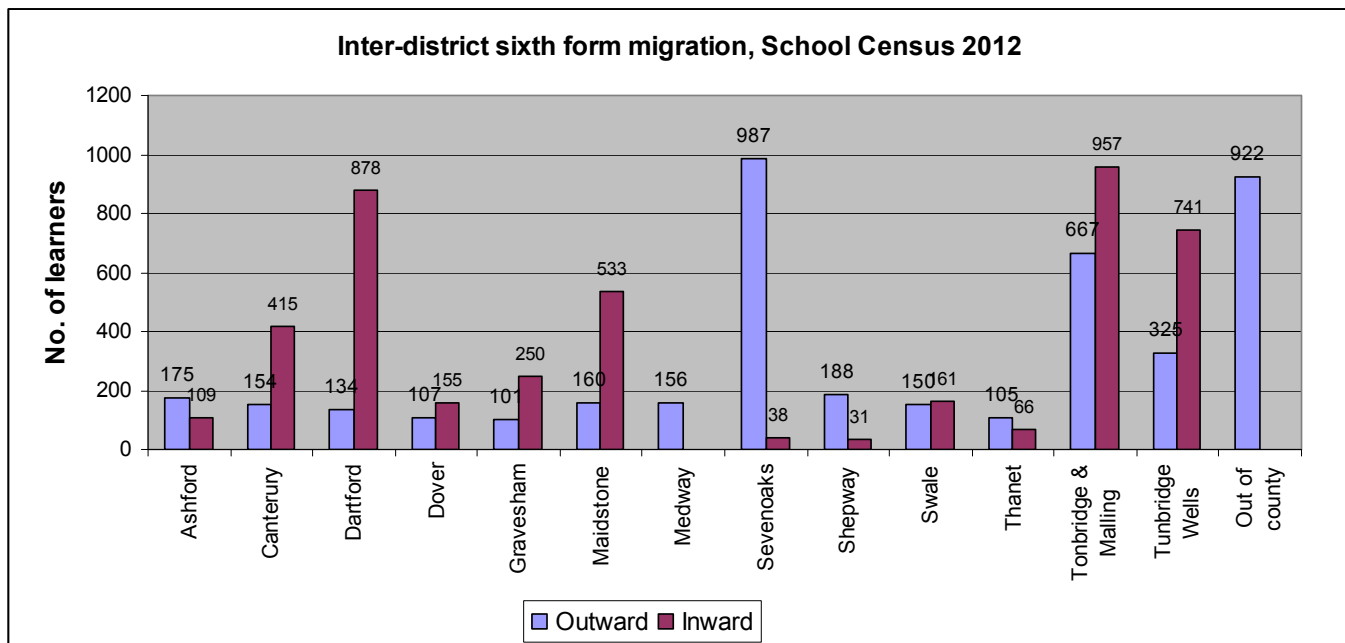
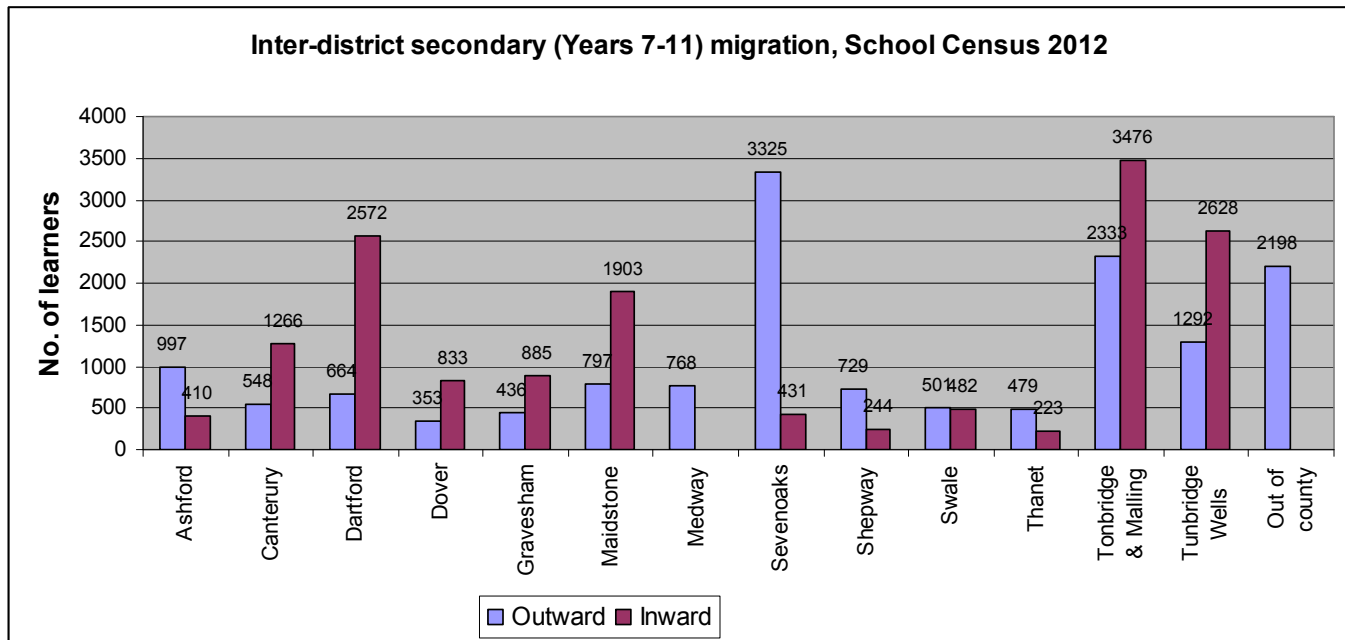

- 154 learners travel out for sixth form education and 415 travel in.

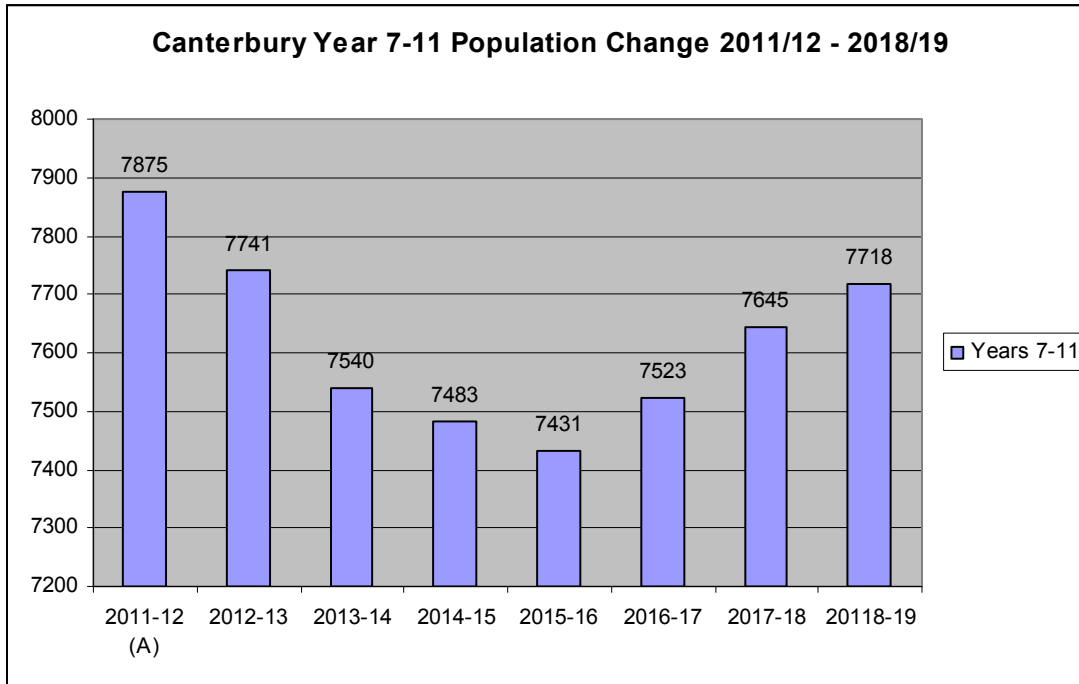


### 1.2.2 Population change

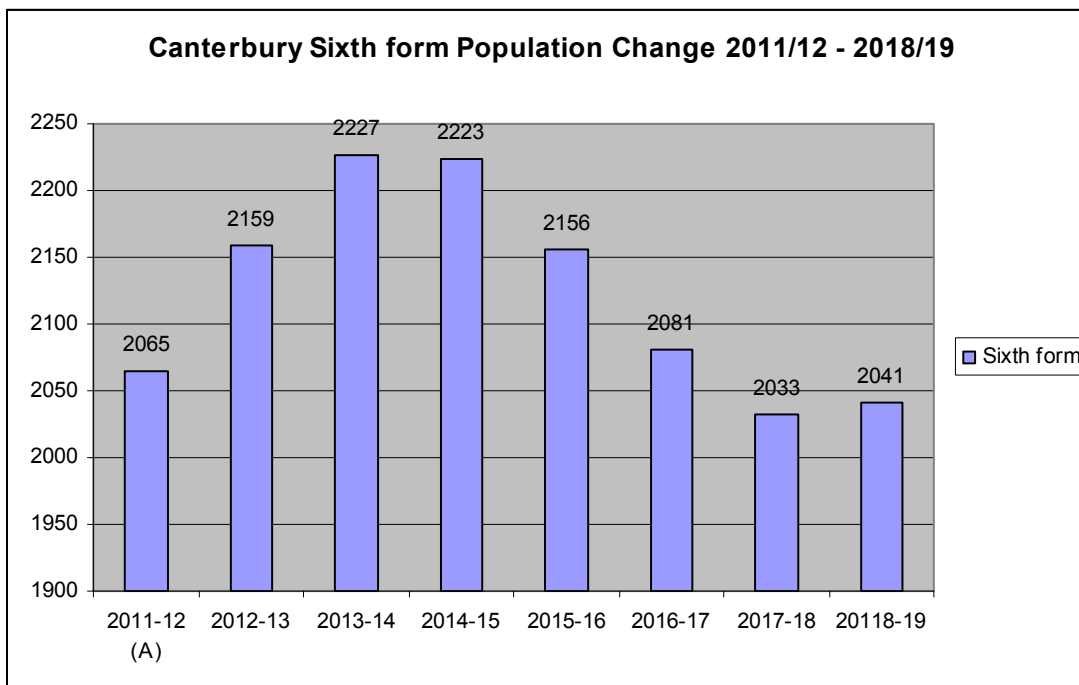
The Year 7 – 11 population is predicted to decline until 2016/17, after which it will climb steadily again.

### 1.2.3 Inter-district migration of Canterbury residents for Further Education

- Although Canterbury has one of the largest FE colleges in Kent, 129 learners travelled out to other districts to study FE in 2009/10.
- Two thirds of these (84) went to Thanet probably as it is more accessible by train from some towns in the Canterbury district than Canterbury is.
- Another 22 went to Tonbridge and Malling, to study at Level 2 and 3 at Hadlow college.
- Canterbury has a high number of students in FE compared to most districts of Kent.
- In addition to this about 2,900 students travel into Canterbury for FE from other districts.

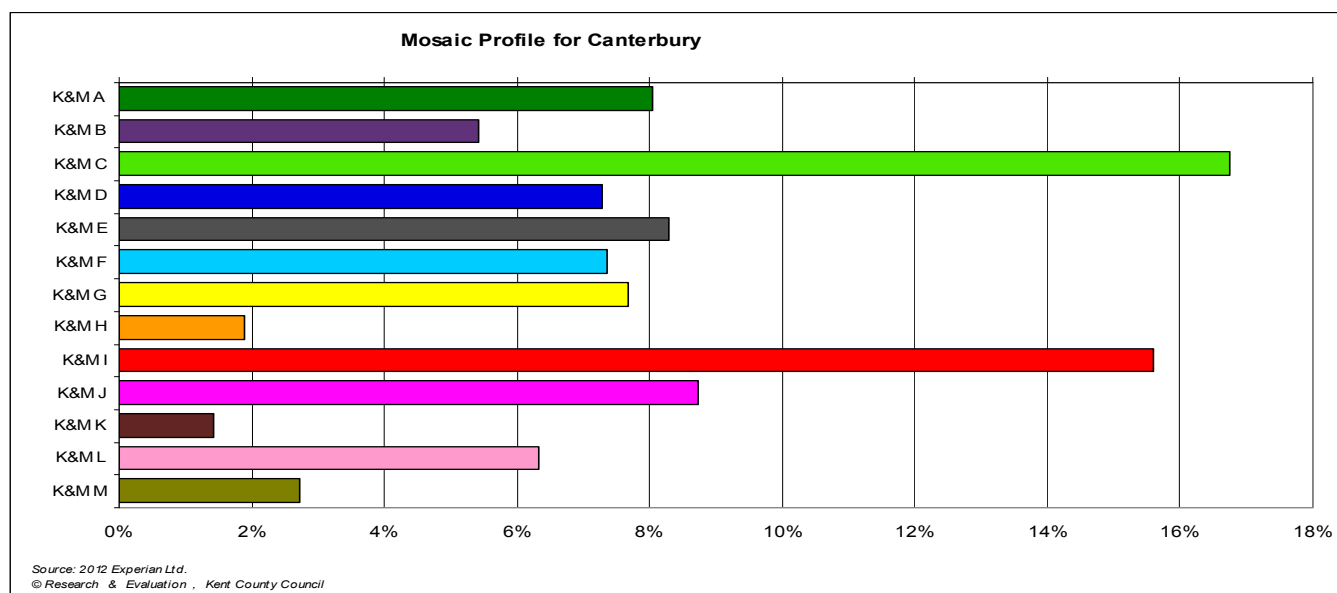

## 2.2 Supporting Data

### 2.2.1 Participation without progression

- 442 (26.5%) of the Canterbury learners who were 16 in 2009 and participated in post compulsory education gained qualifications but did not progress to the next level by age 19. This is higher than both the Kent average (23%) and the national average (25%)
  - 150 (53.9%) of learners at Level 2 without English and Maths gained qualifications but not at Level 3. Again this is higher than the Kent and national averages.
  - 52 (39.6%) of learners below Level 1 gained qualifications but not at Level 1. This is much higher than the Kent (28%) and national (26%) averages.
  - 113 (32.4%) of learners at Level 1 but below Level 2 gained qualifications but not at Level 2. This is a little higher than the Kent and national averages.
  - 127 (14%) of learners at Level 2 with English and Maths gained qualifications but not at Level 3, similar to the Kent and national averages.

### 2.2.2 No qualifications post 16 by age 19

- 136 Canterbury learners did not gain any further qualifications. This could include those who sat qualifications but weren't successful.
  - 48 (36.6%) were below Level 1, which is better than the national (41.6%) and Kent (44.1%) figures
  - 40 (11.5%) were Level 1 but below Level 2 – again better than for Kent and national averages
  - 32 (11.5%) were Level 2 without English and Maths- slightly better than Kent and national averages
  - 16 (1.8%) were Level 2 with English and Maths. The Kent and national averages were both 3.3%

## 2.2.4 Attainment by Provider Type

### Learners with prior attainment at 16

- In Canterbury, a significant percentage of a small number of learners (36% of 22) progressed from below Level 1 to Level 3 by staying at the same school post 16. Only 2.4% did so by going to an FE College. However this is based on a small number of learners who could have been doing one particular subject.
- Of those below Level 1, 36% who stayed at school progressed to Level 1 and 45% of those who went to an FE College
- 74% of the learners who were Level 1 but below Level 2 and stayed at the same school progressed to Level 2 by staying; 59% of those going to an FE College; and 64 % (of 36 learners) of those going to a training provider. 28% staying at the same school reached Level 3; the figure for those going to FE or a training provider was the same, 17%
- Of learners who had Level 2 without English and Maths, 58% who stayed at the same school progressed to Level 3. 29% of those who went to an FE College did so, and 38% of those going to a training provider.
- 91% of learners who had English and Maths at Level 2 and stayed at the same school progressed to Level 3. Only 69% of those who went to FE and 78% of those who went to a training provider did so.
- 4.2% of learners who went to another school post 16 did not obtain any further qualifications. This was the case for 2.7% of students going to FE and 1.5% of students who stayed at the same school
- Canterbury schools in particular and FE performed very well compared to the whole of Kent in obtaining qualifications post 16 for learners who were below or at Level 1 at age 16.
- Schools performed similarly to Kent as a whole in their progression of learners
- FE in Kent (34.8%) performed better than FE in Canterbury (28.7%) at progressing learners who had Level 2 without English and Maths to Level 3. Canterbury was slightly more successful at progressing those with English and Maths at Level 2.
- Training providers in Canterbury were comparatively very successful at progressing all Level 2 learners to Level 3. The figure for those without English and Maths was 21% higher than for Kent.

## **A level or academic equivalent performance**

- Performance at the “top end” of A Level is very good. More students in Canterbury achieved 3+ A Levels at AAB or higher in facilitating subjects than the Kent or the national average.
- More students in Canterbury achieved 1+, 2+ and 3+ A Levels, and A Levels or academic equivalent, at A\* - E than the Kent or the national average.
- Proportional to the number of entries, a lower percentage of exam results in Canterbury achieved A Levels at every grade grouping than the Kent or the national average.
- A Level performance in Canterbury seems to be affected by the high number of entries per student: some schools in Canterbury favour students entering for a high number of AS and A Levels and getting lower grades than entering students for lower numbers and potentially getting higher grades per entry.

### **Detailed figures:**

- More KS5 students (7.5%) achieved 3+ AAB (or higher) in facilitating subjects than in Kent(5.3%) or nationally (4.8%).
- More A Level students (9.6%) achieved 3+ AAB (or higher) in facilitating subjects than in Kent(8.6%) or nationally (7.4%).
- More students (55%) achieved 3+Levels A\* - E than in Kent (47%) or nationally (52%).
- Significantly more students (65%) achieved 2+Levels A\* - E than in Kent (55%).
- Significantly more students (73%) achieved 1+Levels A\* - E than in Kent (63%).
- Significantly more students (63%) achieved 3+ A Levels or academic equivalent at A\* - E than in Kent (51%) or nationally (53%).
- Significantly more students (73%) achieved 2+ A Levels or academic equivalent at A\* - E than in Kent (59%) or nationally (62%).
- Significantly more students (79%) achieved 1+ A Levels or academic equivalent at A\* - E than in Kent (67%) or nationally (67%).
- More students (70%) were awarded A\* - C grades in A Level examinations than in Kent (76%) or nationally (74%).

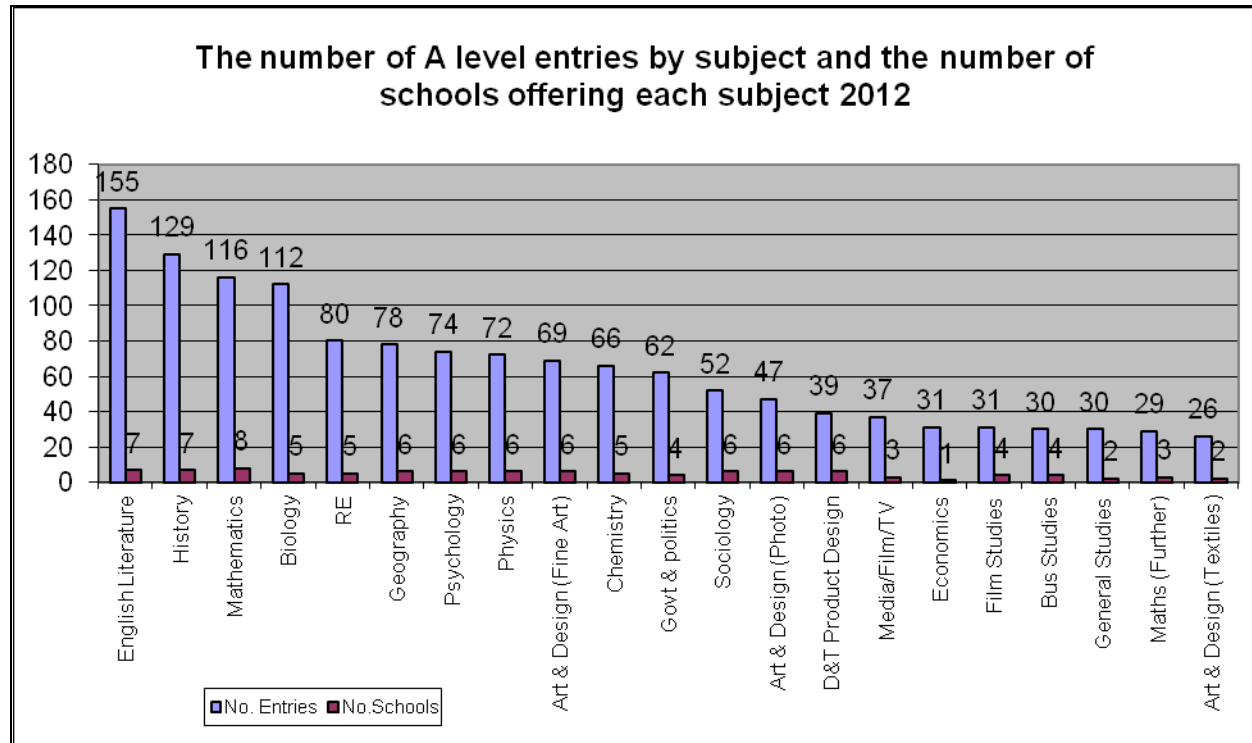

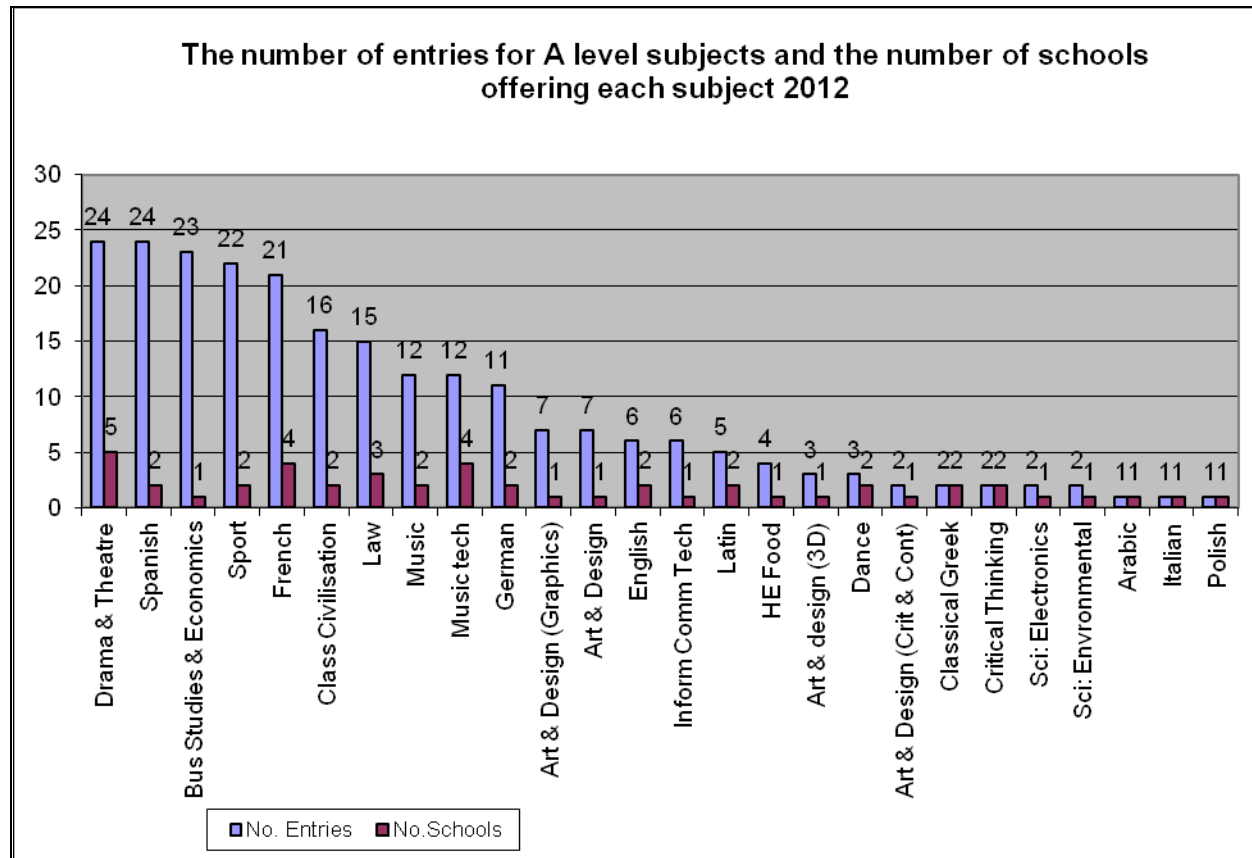

## 2.2.8 Narrowing the Gap by age 19

- Only 63.4% of learners in Canterbury who were eligible for free school meals achieved Level 2 by 19, 23.3% fewer than those who are not. Although this gap is wide it is in the median range for Kent as a whole.
- Only 25.4% of learners in Canterbury who were eligible for free school meals achieved Level 3 by 19. This is 34.2% fewer than those who are not and is the fourth highest in Kent for this level.

## 2.3 Discussion Points

1. Schools in Canterbury could consider using alternative ways of getting some students to level 2 Maths and English, for example using Functional Skills embedded in vocational learning.
2. Some could improve their APE so that they will exceed minimum standards.
3. In some cases post 16 students are drifting into an academic route with little chance of progression. Robust CEIAG in schools will help them choose the most appropriate pathway.
4. Better working relationships between providers could be developed to ensure that a young person's progression does not suffer if they switch from one type of institution to another.
5. Canterbury vocational providers should look at how to raise the proportion of students getting Distinction and Merit at BTEC.
6. Fewer students in Canterbury move up an attainment level, post 16, than is the average in Kent. This is a particular concern for students who have level 2 without English and Maths. Canterbury post 16 providers could examine their progression data to ascertain why.
7. Providers working together can ensure that the vocational offer across the district provides progression opportunities for all students.
8. Schools and colleges could consider how to use their funds to support students who have been eligible for free school meals to attain the same levels of qualifications as those who do not at Level 2 and Level 3.

### 3. Improve and extend vocational education and training and apprenticeships

#### 3.1 Summary

Whilst Canterbury had been experiencing a period of economic growth for most of the decade, between 2008 and 2011 employment in Canterbury fell by 1,900 jobs, or 3%, compared to a decline of 0.4% in Kent as a whole. It suffered more than the rest of Kent from the closure of Pzifers as a high proportion of its employees lived in the district.

Canterbury's key employment sectors of retail and public sector have suffered from the recession and resulting cuts- this trend could be reversed if the national economic picture recovers. Canterbury is a key retail centre for this part of Kent and would expect to see retail employment rise quickly if national economic growth was achieved.

The most dramatic increase in employment is in the Professional, Scientific and Technical Services Sector. This has very few relevant vocational courses at Level 3 other than IT and would benefit from a discussion between employers and providers as to what higher level courses and apprenticeships would meet their needs. Employment also grew significantly in the Accommodation and Food Service Sectors although there are few courses at Level 1.

Health and Social Care will continue to offer increasing opportunities, but again there are fewer courses at level 1 than there should be given that many NEET young people express this as an area of interest. Travel and Tourism will be a growth area too: Canterbury City Council has a major focus on the "Visitor Economy" to complement Canterbury's status as a major tourist destination, with 7 million visitors annually and generating £495 million.

Although over the three year period employment in construction has dipped by 200, it did rise by 300 jobs in 2010-11 so is on an upward trend. The numbers of courses in this area are justified by this activity and the prospect that this is an area that would recover quickly with national economic growth.

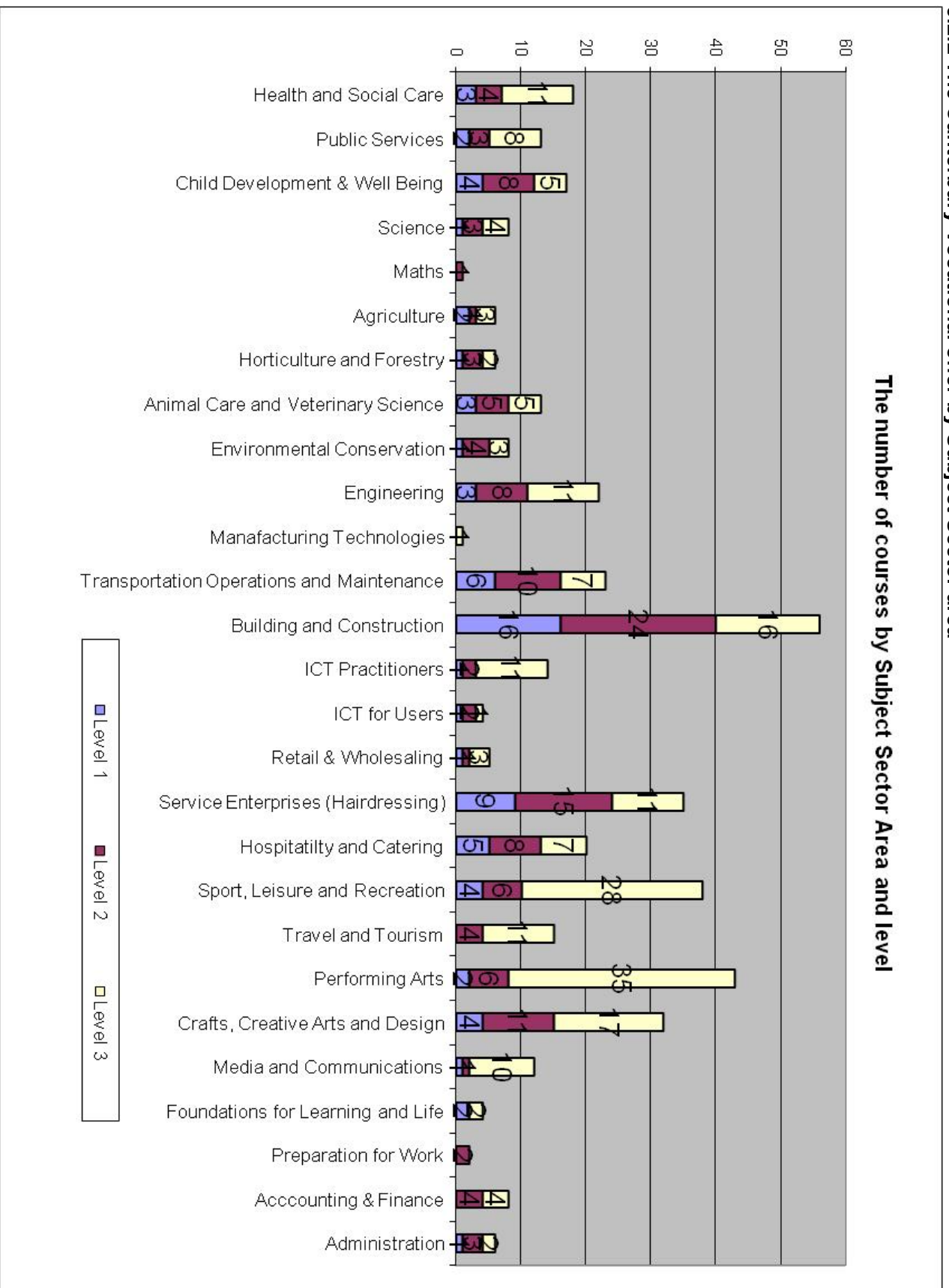
The high numbers of self-employed people suggest that some vocational courses ought to include entrepreneurial skills including those for the arts, entertainment and recreation sectors where employment is increasing. Many of the opportunities in this sector are for freelance self-employed people.

## 3.2 Supporting data

### 3.2.1. The Canterbury Vocational offer and the local economy

1. **Building and Construction** offers the most courses (57) in Canterbury with an even distribution between Levels 1, 2 and 3. Whilst employment has declined in the period 2008-11 it is still a significant employer in the district.
2. **Performing Arts** also has an extensive offer, 43 courses, 35 of which are at Level 3. Whilst this is not a significant local employer it does offer progression to Higher Education
3. **Service enterprises**, comprising mainly hairdressing, offers 37 courses with a spread across the three levels and progression. As this is not a significant employer this is sufficient provision.
4. **Sport, Leisure and Recreation** has 33 courses, with 26 at Level 3 even though there is little employment locally in this sector. It does provide progression to local HE courses in Sports Science but provision would seem to be excessive.
5. **Hospitality and Catering** is a significant local employer but there are only 20 courses. They do however offer good progression from Level 1 to Level 3. As it is a growth sector now employing 5,100 people there is a case for increasing provision.
6. **Public Services** is another big local employment sector but there is only one course at Level 1, 2 at level 2 and 8 at Level 3. However it has suffered from the public sector cuts especially to the local hospital.
7. **Health and Social Care**, a growth sector for the local economy and significant employer (10,300) has 11 courses at Level 3 but only 3 at Level 1.
8. **Engineering**, which is one of the sectors NEET young people express the most interest in, has 22 courses but only 3 at Level 1. Manufacturing is in decline in the district and only employs 1,900 people.
9. **Child Development and Well being** is a growth employer and there are 22 courses with progression- however only 4 of those are at Level 1
10. **Agriculture or horticulture:** There are 12 courses in the district at Levels 1 to 3 through Canterbury College and Hadlow Colleges.
11. **Travel and Tourism** is a sector the city council considers crucial for the local economy as visitors generate £495million annually but there are only 4 Level 2 and 11 Level 3 courses.

### 3.3 The Economic Landscape of Canterbury, 2008-11

#### 3.3.1 Introduction

Between 2008 and 2011, employment in Canterbury fell by 1,900 jobs, or 3%, compared to a decline of 0.4% in Kent as a whole.

The largest sectors in terms of employment are the Wholesale and Retail Trade, Education, Human Health and Social Work Activities, Accommodation and Food Service Sector and Professional, Scientific and Technical professions.

Canterbury District has experienced significant employment growth historically. In 1998 there were 53,600 jobs in the area. By 2011 this had climbed to 60,700, although it peaked in 2008 at 62,600.

Since the mid 1990's employment in public administration, education, health and consumer based services (e.g. retail, and tourism) has grown significantly with 67% of all jobs being in these sectors.<sup>1</sup>

However Canterbury City Council identifies that the District's economy will continue to be challenged by the combination of a forecasted decline in local manufacturing jobs, cuts to the public administration, health and education sectors and, more widely, the fall-out from Pfizer closing and decommissioning of Dungeness Power Station. However falls in construction and retail related jobs observed after the 2008 recession were partly offset by growth in professional, scientific and technical activities and education sector employment (i.e. a key component of all district knowledge based sectors).<sup>2</sup>

Between 2008 and 2011 employment grew significantly in the following sectors:

- Professional, Scientific and Technical Sectors
- Accommodation and Food Service Sectors.

Between 2008 and 2011 employment fell significantly in the following sectors:

- Manufacturing
- Wholesale and Retail Trade
- Transportation and Storage
- Information and Communication
- Public Administration and Defence

83% of business in Canterbury are small which matches the Kent average. Over a third of Canterbury businesses are from the retail, distribution, hotels and restaurants sector. This reflects the area's high proportion of specialist and general consumer goods shops in the service sector.

### 3.3.2 Areas of Employment Growth, 2008 to 2011

#### Professional, Scientific and Technical Services

Between 2008 and 2011 the Professional, Scientific and Technical Services Sector grew by 900 jobs or 36%, compared to growth of 11% across Kent.

Canterbury City Council has targeted making better use of its further and higher education links as fundamental to the District's future economic aspirations, which seems to be having a marked effect.<sup>3</sup>

They have an important role in economic development (particularly in higher-skilled, knowledge intensive, creative economies) and local universities remain a key asset for the future.

Considering the wider Knowledge Economy, approximately 21% of all jobs in Canterbury are related to this sector, which compares to 14.5% across Kent as a whole and 20% in the South East. Canterbury may have reached the limit of its employment potential in this sector, although there could be many opportunities to swap jobs in the public sector with jobs in the private sector.

### **Accommodation and Food Service Sector**

Between 2008 and 2011 the Accommodation and Food Service Sector has grown by 300 jobs, or 6.3%, compared to a decline of 4% across Kent. Canterbury City Council has a major focus on the “Visitor Economy” to complement Canterbury’s status as a major tourist destination, with 7 million visitors annually and generating £495 million. Canterbury’s vision for tourism is:

“We will build upon Canterbury’s offer and reputation as a cultural and heritage destination to grow the value of tourism both economically and socially across the district.

By 2016 Canterbury district will be leading the way in delivering a distinctive, quality-driven and sustainable visitor economy for its visitors, businesses and communities.”

### **3.3.3 Areas of Employment Decline, 2008 to 2011**

#### **Manufacturing**

The Manufacturing Sector has declined by 300 jobs or 14%, between 2008 and 2011, mirroring the decline across Kent. Manufacturing employment in Canterbury has fallen consistently since 1998, from 4,500 employees to its present level. The manufacturing base is primarily located on the 12 business parks and main commercial areas close to the Thanet Way near Herne Bay and Whitstable.

#### **Wholesale and Retail Sector**

This sector has declined by 1,200 jobs, or 10%, between 2008 and 2011, while employment in the county has remained static during the same period. The Sector is one of the two largest employment sectors in the District and remains crucial to the economy of the area. The impact of the recession can clearly be seen, as employment fell by 1,600 between 2008 and 2010, but has been recovering since then.

#### **Transportation and Storage**

Employment in the Transportation and Storage sector fell by 400 jobs or 27% between 2008 and 2011, compared to a fall of 7% across Kent as a whole. Looking at sector data for other Districts and Boroughs in Kent, it would appear that jobs from Canterbury have probably relocated to neighbouring areas with a competitive advantage in this Sector, such as Swale, Thanet, Dartford and Gravesham.

#### **Information and Communication**

Employment in the Information and Communication Sector declined by 200 jobs or 13% between 2008 and 2011, compared to growth of 6% across Kent, although jobs appear to be increasing again. This appears to be inconsistent with the growth in employment in the Knowledge Economy, discussed above. However we know that a high proportion of Knowledge Economy jobs in Canterbury are in the public sector. Information and communication jobs tend to be private sector based which may have been disproportionately affected during the recession.

## **Public Administration and Defence**

Between 2008 and 2011, employment in this sector fell by 500 jobs or 15%, compared to a decline of 14% across Kent. This reflects national and local constraints on public expenditure and a transferral of public funds from back office to frontline services.

### **3.3.4 Other Key Employment Sectors**

#### **Education**

Education is one of the two largest employment sectors in Canterbury, with 11,400 jobs, although this employment level has been as high as 13,100 in 2010. Canterbury has three Universities (University of Kent, Canterbury Christ Church University and University for the Creative Arts), a large Further Education College along with language colleges, state schools, private schools and academies.

#### **Human Health and Social Work**

Employing 10,300 people, this sector not only services the indigenous population, but a huge student population as well. Interestingly employment has fallen slightly since 2008, compared to growth in Kent of 12%.

#### **Public Sector**

The Public Sector includes employees from the Education, Human Health and Social Work and Public Administration and Defence Sectors, although many employees will be in the private sector.

In total 23% of employees are in the Public Sector, compared to 21% in Kent as a whole. Due to the size of the Public Sector, employment in Canterbury has historically been less sensitive to recession. However this has now made Canterbury very vulnerable to constraints on national and local expenditure. For example the downgrading of accident and emergency services at Kent and Canterbury Hospital has resulted in a reduction in employment in health in Canterbury, which has been transferred to Ashford.

### **3.3.5 Unemployment in Canterbury**

The unemployment rate in Canterbury is currently low, at 2.5%, compared to the Kent average of 3.2%. Unemployment in Kent is falling slowly, compared to the comparative period last year, and Canterbury is following this trend. Chart 2 below illustrates comparative rates of other Boroughs/Districts as at the end of 2012,

**Chart 2: Percentage of District Unemployment as at November 2012.**

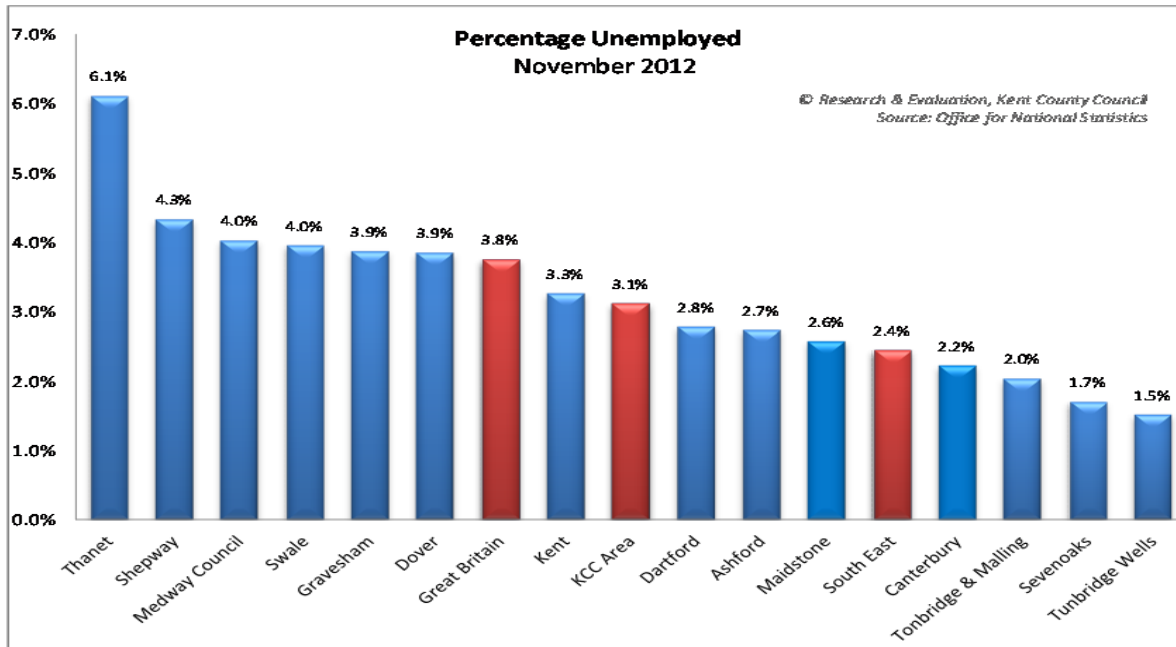


Chart 3 below illustrates the percentage change in unemployment overtime. Thanet and Ashford are the only Districts that have seen an increase in unemployment between November 2011 and 2012.

**Chart 3: Percentage change in District Unemployment since November 2012.**

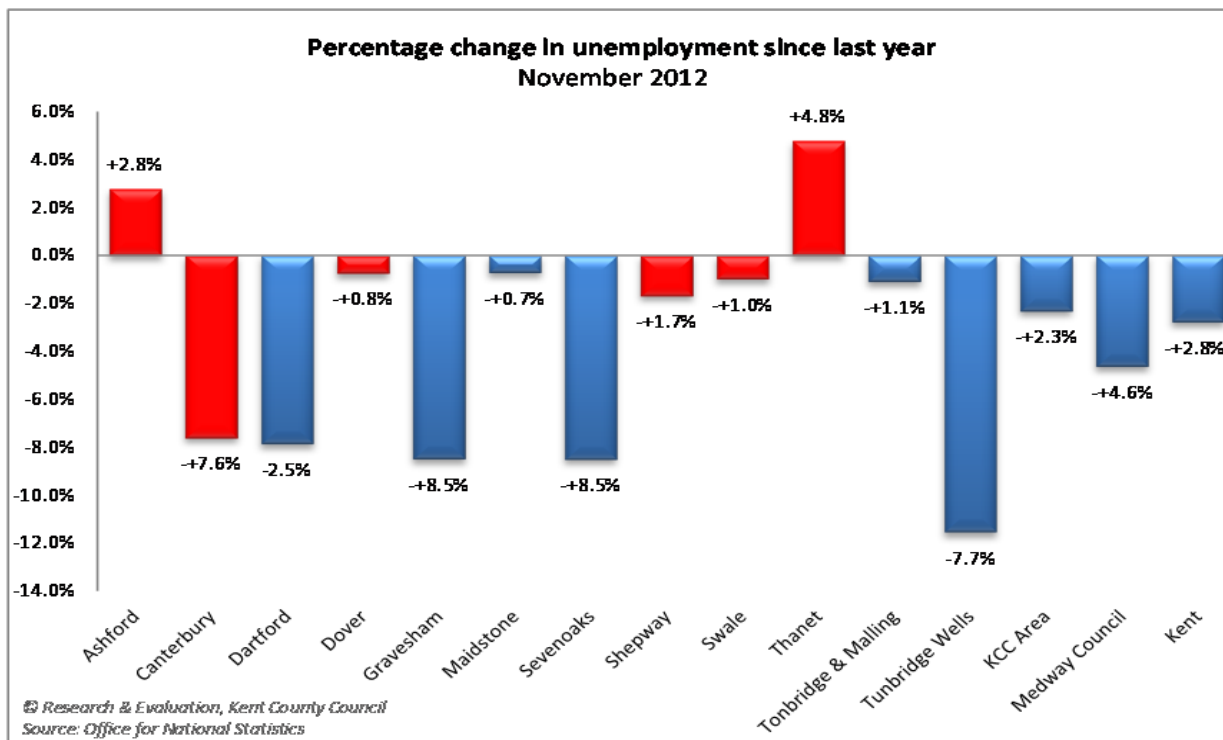
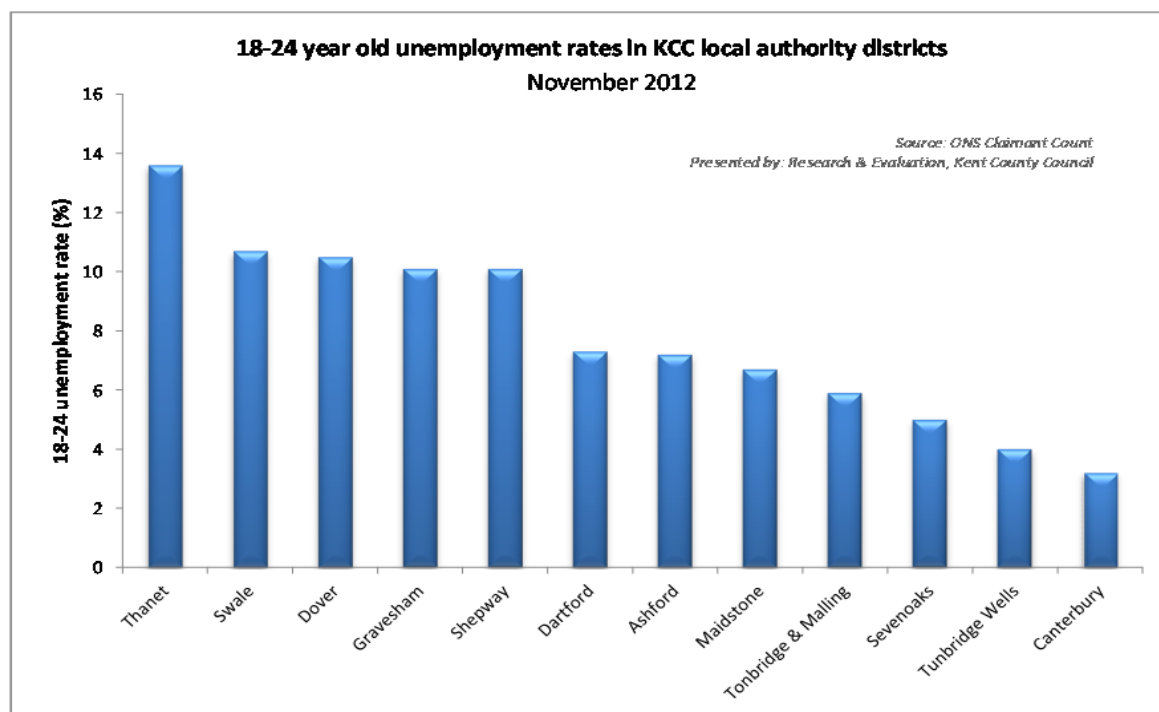


Chart 4 illustrates the comparative levels of 18-24 year old unemployment across Kent. 8% of 18-24 year olds were unemployed in November 2012.

Youth unemployment remains a huge issue in Kent, although Canterbury has the lowest unemployment of 18-24 year olds in Kent.

### 3.3.6 Employment in Canterbury

#### Self-Employment

Canterbury has the highest levels of self-employment in Kent, and well above the South East average. This is consistent with the levels of small business found in the area and the nature of businesses associated with the tourism industry, such as restaurants, coffee bars, pubs etc.

### 3.3.7 Residence and Workplace Earning

Incomes based on residence are comparatively low in Canterbury, compared to Kent and South East averages. Incomes based on workplace are even lower. This suggests that wages in retail and in the public sector based in the District are low, but there is some positive impact from out commuting on overall household incomes. It also suggests that average incomes derived from self-employment are very low in Canterbury.

Table 4 below illustrates how weekly median gross pay has changed since 2009 in Canterbury.

### 3.4 Discussion Points

1. The most dramatic increase in employment in Canterbury District is in the Professional, Scientific and Technical Services Sector. There is limited provision of relevant vocational courses at Level 3 other than IT. KCC and Canterbury CC could broker a discussion between employers and providers to determine what higher level courses and apprenticeships would meet their needs.
2. Employers could be consulted and encouraged to contribute to the content of vocational courses in the district.
3. Providers could consider increasing work with HE institutions in Canterbury to create pathways for young people to take a vocational route into careers, particularly in the professional, scientific and technical services sector.
4. More courses, especially at Level 1, appear to be needed to meet employment demand in the Accommodation and Food Service and Health and Social Care Sectors.
5. More courses are needed in Travel and Tourism, with input from employers and Canterbury City Council as to the content.
6. Vocational courses ought to include entrepreneurial skills and skills for self-employment. Many of the opportunities in Canterbury are for freelance or self employed people, especially in the arts, entertainment and recreation sectors where employment is increasing.
7. All providers of vocational learning should consider work placements as part of their study programmes to ensure young people are resilient to a rise in youth unemployment.
8. There appears to be overcapacity in the following areas: Level 3 Sport and Leisure; Level 3 Performing Arts; Level 3 Crafts, Art and Design; Level 3 Media and Communications.



## 4. Increase Participation and Employment

### 4.1 Summary

In September 2013 the current Year 11 will for the first time have to participate for an additional year in learning, education or employment with training; by September 2015 this will rise to participation up to their 18<sup>th</sup> birthday. If the circumstances were to remain the same in Canterbury, an additional 291 young people would need to participate in September 2015.

Education providers will be held accountable for the destinations of their learners two terms after they have left learning at Key Stage 4 and Key Stage 5. This will apply to all types of learning providers. The release of the 2012 destination data is expected in June 2013 and will include employment data for the first time.

The number of young people who are not participating in Year 13 (200) is over double that in Year 12 (91). This reflects a similar trend across the county; in fact the activities of 16-18 year olds in Canterbury are very similar to the county averages for example the number in full time education and employment with training. This does not mean that there is room for complacency when considering the Canterbury response to RPA. There will be real challenges trying to support vulnerable learners and getting the involvement of local employers to convert jobs into jobs with training; 4% of Canterbury young people are in employment without training.

Research by CXK has identified that a significant number of young people are interested in vocational areas where there are courses available locally and unemployment in Canterbury for 16-24 year olds, at 3%, is half the county average. Understanding why there are NEET young people in Canterbury, reasons for disengagement and identifying the gaps in the provision will need to be a key activity over the coming year.

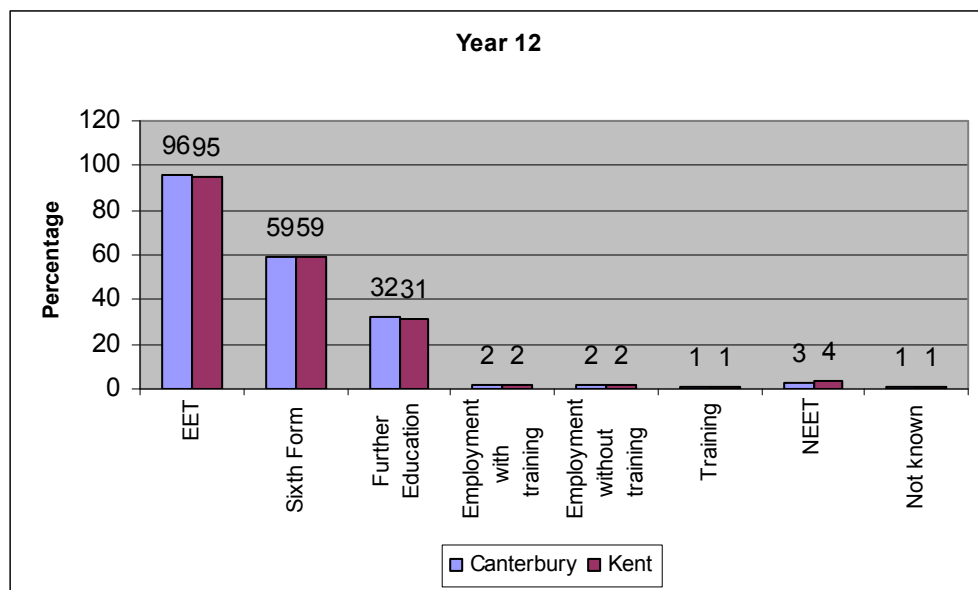
A learner voice study undertaken by the Skills and Employability Service into RPA has identified that young people are very unclear about what it means for them and their options. Below are some of the main findings:

- there were problems in the communication of what RPA means to young people. They perceived it as meaning they had to stay at school and were not well informed about opportunities beyond that;
- there was little knowledge of training, work experience, volunteering or apprenticeships among 16 – 24 year olds. Half of them did not have any career plan. However, they did appreciate careers advice and guidance and preferred to receive it on a one to one basis or using online facilities. It seems that they would respond very positively to bespoke personal guidance and help in planning their future and this would encourage them to continue participating in education or training until 18;
- encouragingly young people recognised the importance of Level 2 English and Maths and expected to study this post 16 until they achieved it.

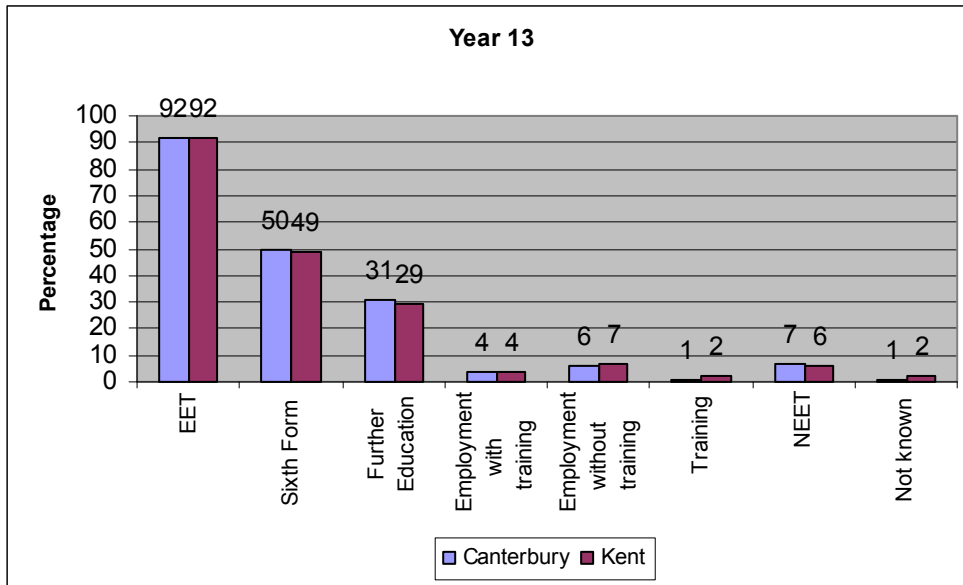
## 4.2 Supporting data

### 4.2.1 Comparison of the activities of young people age group Year 12, 13 and combined 12 and 13 who have completed compulsory education in Canterbury and Kent

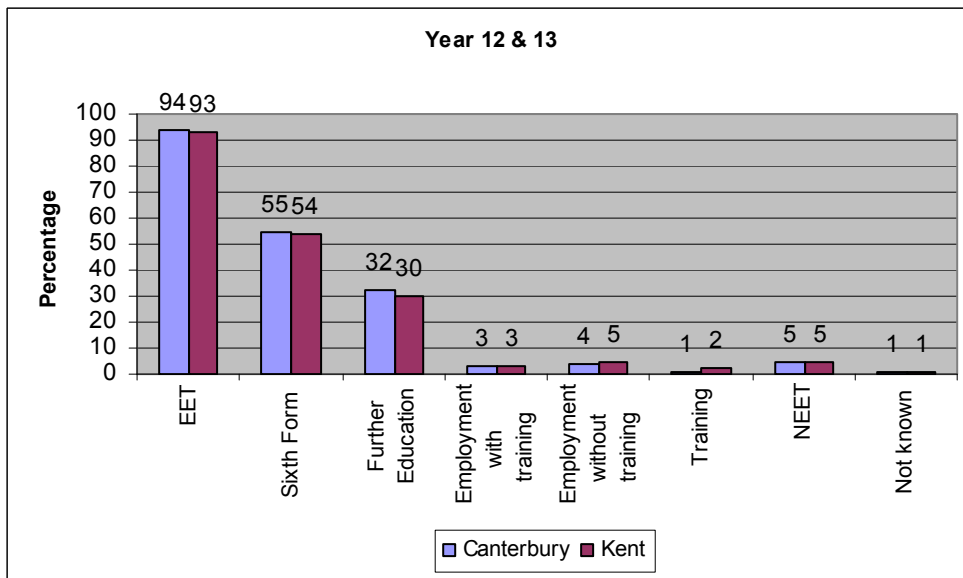
- The numbers of NEET young people in Canterbury for the combined Year 12 13 age group was 5%, exactly the same as the average for the whole county.
- Canterbury has slightly higher rates of young people who are NEET in Year 13 than the Kent average, which is accounted for by lower numbers of young people in jobs without training. Neither of these categories would classify young people as participating under RPA and form a significant total: 13%
- Participation at 6<sup>th</sup> form in both years is the same as that for the whole of Kent (59%).
- Canterbury has a slightly higher rate of participation in FE than the Kent average (1% more)
- Canterbury has a very similar rate of young people in employment with training, employment without training and training as the Kent average
- Participation in Year 13 is lower than in Year 12, with NEET rates at 7% compared to the Kent average of 6%. There are more than double the number of young people NEET in Year 13 as there are in Year 12- 200 compared to 91.
- Based on November 2012 CXK data in September 2013 a further 81 Year 12 young people will need to participate
- In September 2015, if figures remained the same, a total of 260 young people will need to participate that are currently NEET available or in employment without training
- The largest group within the NEET cohort are LDD learners (36%)
- The second largest group are those caring for their own child (24%) which rises to 32% when including those who are pregnant.
- The third largest group are those who are in care (11%)

#### 4.2.4 Preferred vocational areas of NEET group

- Young people who are NEET were asked by CXK what their preferred employment sector would be:
- in Canterbury, a high number of young people wanted to work in construction, where there was a wide range of courses with good progression:
  - 20% of them wanted to work in health and social care or engineering where there are only 3 courses at level 1 for each area:
  - 8% wanted to work in personal health and beauty where there is good provision and progression.

#### **4.2.5 Young peoples view on Participation**

In November 2012 the Skills and Employability Service ran a learner voice targeting two groups of learners. The first, learners aged 13-16 who may be below the Level 2 threshold and the second, post 16 learners who were at risk of and not engaged in education, employment or training. The conclusions and recommendations are listed below.

##### **Conclusions of learner voice**

- Learners lack awareness of what RPA means. Many believe it is about staying on at school until 18, and do not seem to know about the options of taking up training either at an educational establishment with an employer or on a voluntary basis.
- Very few learners had heard about RPA outside of school. The message about changes to education and training for young people is not widely known or understood by parents or employers.
- Learners have a very good understanding of the importance of gaining qualifications in Maths and English. They expected to continue to retake these qualifications if they did not achieve the necessary grades by the end of Year 11.
- Learners prefer to access IAG by personal contact or using on-line access. They like to go to familiar places such as colleges or school or local council facilities.
- Learners prefer to receive individual 1:1 support for CEIAG.
- Learners rated specific support very highly. They rated the guidance received at school and college as good, however, they rated the guidance from employers, relatives, training providers and support workers as excellent.
- Half of the 16-24 learners who took part in the survey had no career plan. This gives an insight as to what may happen to potential RPA learners, should interventions not be developed.
- Learners aged 16-24 did not have apprenticeships on their horizon.
- Very few learners understood the voluntary route and what potential career benefits can be gained from taking up voluntary activities.
- Teenagers with young children had difficulty in considering their future beyond caring for their young child. However, they were very keen on getting help and support from such programmes as YAPs.
- More research would need to be undertaken to find out what help and support learners need with future career planning.

## Recommendations of learner voice

- To develop methods of communication for RPA. Information about what RPA is at one level, impartial IAG for RPA and levels of IAG support about RPA options for learners.
- To use the report as a means to evidence the lack of understanding of RPA by learners, parents, carers and employers. This has some sense of urgency given that the current Year 11 will be affected from September 2013.
- Learners indicated they see the Local Authority, along with schools and colleges, as the place to go to for help and advice for CEIAG. The LA should consider developing its RPA role in getting a consistent message across through the use of this report, the Kentchoices4U website, transition programmes and general information events.
- There needs to be some form of RPA Transition programme available to 16-18 learners, similar to the highly regarded Princes Trust programmes available for 16-24 NEETs learners.
- The positive response to the KC4U website suggests there is an opportunity to build on the increasing use of KentChoices4U as a means to inform parents, carers, and employers as well as learners.
- Ensuring that CEIAG retains its impartiality in providing help and support for RPA options will play a crucial role for learners from Year 9 onwards. Learners are asking for face to face support on specific career outcomes. If they cannot have face to face, they would choose on-line for support. They will continue to need career planning to develop their aspirations and support in achieving their goals

### 4.2.6 The 16-17 Year Old Youth Contract

The Youth Contract is a mentoring support programme designed to help 16 – 17 year old NEETs with low GCSE qualifications (less than 2 at Grades A\* - C), those who have been or are in care (irrespective of any GCSEs gained), and those who have been in custody (including remand, again irrespective of any GCSEs gained). It gives advice and guidance and then prepares individuals to re-engage into education, training or jobs with training. It continues for at least 6 months during the re-engagement period with tracking for an additional 6 months. It therefore supports those on EFA funded programmes to minimise drop out and maximise progress towards completion of an accredited qualification and beyond, with or without some form of employment (paid or voluntary). Providers have a maximum of 6 months from the start date to get each young person into an EET activity.

There are three providers in Canterbury delivering the Youth Contract – Go Train, NXG and the Shaw Trust. To date there have been 24 starts including those at the pre-engagement stage as at May 2013. It is anticipated that this number will rise significantly in the next two months.

Schools can request a visit to engage with a group of potentially eligible Youth Contract young persons. Sessions can happen between March and June to enable initial engagement and delivery to small groups and individuals. Young people who are already eligible can then start on the programme from July 1<sup>st</sup> – if they are sitting 2 or more GCSEs (and not in custody or care) then they can join after results day in August if eligible.

## 4.2.7 Unemployment and youth unemployment in Canterbury

- Canterbury has extremely low rates of youth unemployment 16 – 24
- The rate of unemployment among 18 – 24 year olds, 3%, is half that of the Kent average

### 4.3 Discussion Points

1. The participation rates of all young people in Year 12 and 13 in Canterbury could be enhanced by:
  - creating additional capacity for, potentially, an additional 260 learners who currently choose not to participate, by September 2015;
  - ensuring that no year 12 learner leaves provision without a destination for Year 13;
  - offering a post 16 curriculum which includes substantial work experience for those who would benefit from it.;
  - offering flexible access to learning so that young people who choose to work can do so whilst continuing to study, and other groups such as teenage parents and those with health needs can study more remotely;
  - actively supporting young people who are NEET to access courses in which they have expressed an interest and which will provide employment in the district eg construction, health and social care;
  - engaging in all the forums which are being established to support joint working to reduce NEETS eg NEET 2 EET, KIIASS.
2. KCC and schools could collaborate to produce more information and a consistent message regarding RPA and provide support for decision making e.g. using Kentchoices4U. Schools could ensure that:
  - CEIAG retains its impartiality in providing help and support for RPA options;
  - these options are presented to learners from Year 8 onwards; and
  - CEIAG include face to face support for those who are potential NEETs.

The message could be communicated using all available partners eg accompanying business rates letters to employers from the city council
3. By working jointly on an RPA Transition programme for 16-18 learners, providers can help them progress to an appropriate destination. Funding for such programmes through ESF and Princes Trust is reducing so consideration should be given to utilising core EFA *study programme* funding. The S&E Service will help facilitate collaboration.
4. All providers could develop a positive working relationship with Youth Contract providers and understand YC referral procedures to ensure that this resource (transition and mentoring) is used effectively to reduce NEETs – subsequently improving provider destination measures.
5. Employers need to be made aware that young people must continue in learning until 18 and help them work with learning providers to enable young people, especially 17 year olds, to combine study and work if they choose.
6. Research amongst the NEET group needs to be undertaken to understand why they are not participating despite having the availability of appropriate vocational courses.



## 5. Target Support to Vulnerable Young People

### 5.1 Summary

A close examination of the 16-18 year old NEET group in Canterbury shows that just under half have been identified by CXK as having a disability. Of this group over half are BESD. In addition the most significant needs for statemented learners of Year 9 to 11 in Canterbury are for those with BSED (258 learners). This group represents a significant challenge for the delivery of RPA in Canterbury

The second highest group of young people in Years 9-11 with statements are those with autistic spectrum disorders. There are also a significant number of young people in years 9 to 11 with speech, language and communication needs. Numbers for all other types of disability were very low, with no more than 3% of the NEET young people in any disability category which suggests there is good engagement and provision for other types of LLD young people.

A break down of the 16-24 CXK priority group shows that there are relatively low numbers of young people who are NEET because they are caring for their own child (37) or pregnant (12) when compared to the rest of the county. However, this is still a significant challenge.

The third highest group of the 16 – 24 CXK priority groups who are NEET are Looked After Children. Given that there are a total of 49 LAC at the post 16 stage and nearly 1 in 3 are NEET and that there are currently 70 statemented LAC in full time education in Canterbury, supporting this group this will be an ongoing issue.

There is a significant problem with permanent exclusions in Canterbury. There were 46 in the 2011-12 school year which is by far the highest in Kent. There were also 1246 fixed term exclusions in Canterbury, the fifth highest in Kent.

There were 95 children being educated at home in Canterbury in February 2013, which is the sixth highest in the county and may pose problems for post 16 transition for these students.

Canterbury was the fourth highest district in Kent for producing young offenders, but has seen a significant downward trend of offending by young people in Canterbury. Rates of offending by young people are falling across the county, but falling faster in Canterbury than in most districts. It is down 37% from September 2011 to September 2012.

Canterbury also has a significant problem with absenteeism. It had the highest number of absences at secondary school age of any district in Kent for the year 2011-12. As a proportion of learners, it is third highest behind Sevenoaks and Shepway. Canterbury is also third highest in Kent for absences from special schools.

## **5. Target Support to Vulnerable Young People**

### **5.2.1 Client Caseload Information System (CCIS) data on NEET young people and vulnerable learners provided by CXK**

There are two sets of data that have been supplied by CXK who under contract from KCC track all young people up to the age of 19 and up to 25 for young people who have a disability.

The data is stored on a Client Caseload Information System (CCIS) and while the initial source of the data is from KCC, CXK maintain the database which can lead to discrepancies between data held by CXK and KCC. Data held in the CCIS has to be maintained in a way that is proscribed by the DfE and this can again cause data discrepancies, particularly in terms of categorisation.

KCC also contract with CXK to provide support for vulnerable learners which include 10 priority groups which are listed in the table below.

The data held in the CCIS is important because it is used to report to the DfE, who use it to produce NEET data and because it is the only database in Kent that includes consistent data about the whole 13-19 cohort and up to 25 for those with disabilities.

Two sets of data have been taken from the CCIS and used in this report. The first is a breakdown of the 16-24 year olds in Kent, by district who are NEET and in one of the priority groups. The second is a breakdown of the 16-18 year olds have a disability registered on CCIS, as defined by the DfE guidelines. In some cases young people may have more than one disability but only one is provided in the data.

### 5.2.2 Breakdown of the 16-24 year olds who are NEET and in one of the Priority Groups - November 2012

- 157 (9%) of the Kent young people in the priority groups are Canterbury residents.
- A high proportion of these are LLD (36%); Canterbury has the third highest number of NEETS of this group in the county.
- Compared to other districts in East and mid Kent, Canterbury has relatively low numbers of young people who are NEET because they are caring for their own child (37).
- The third highest group of NEETs are looked after children.

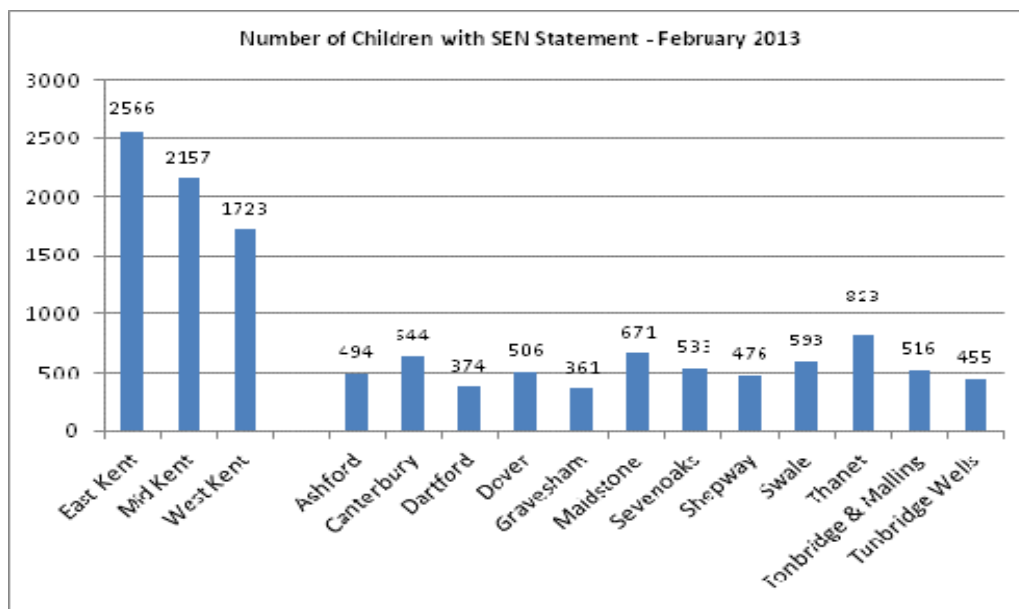

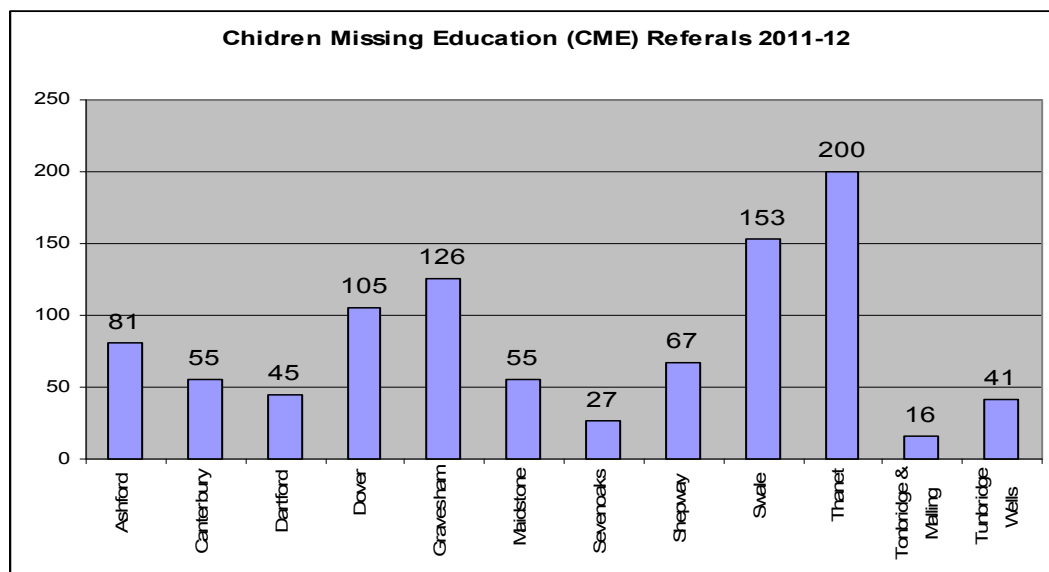
### 5.4.4 The Number of children with a SEN Statement – February 2013

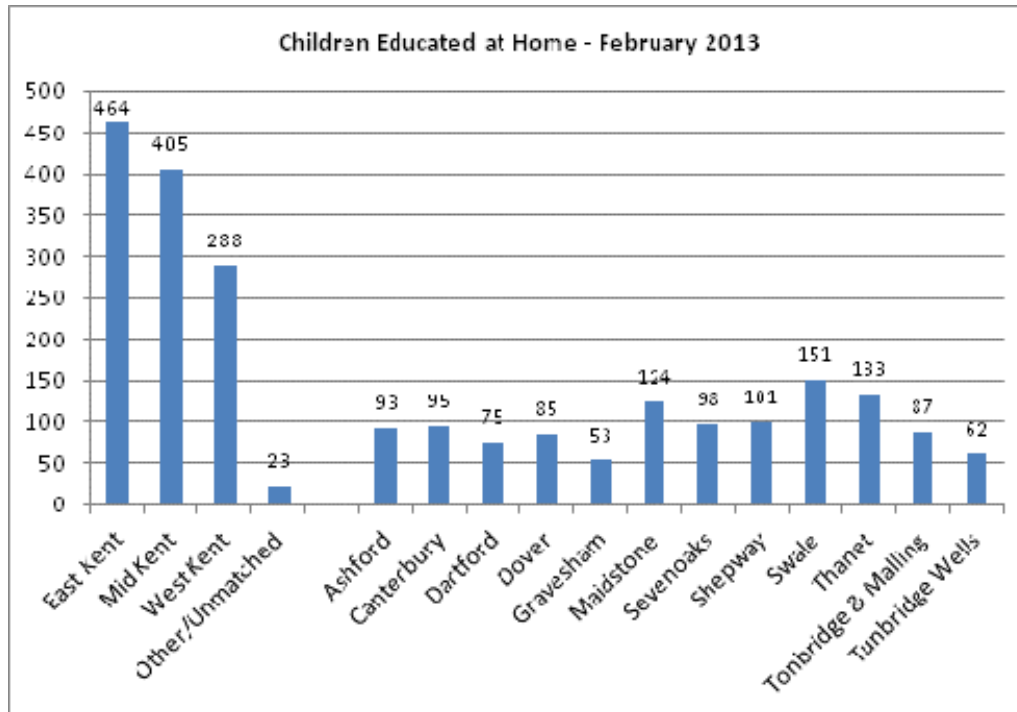

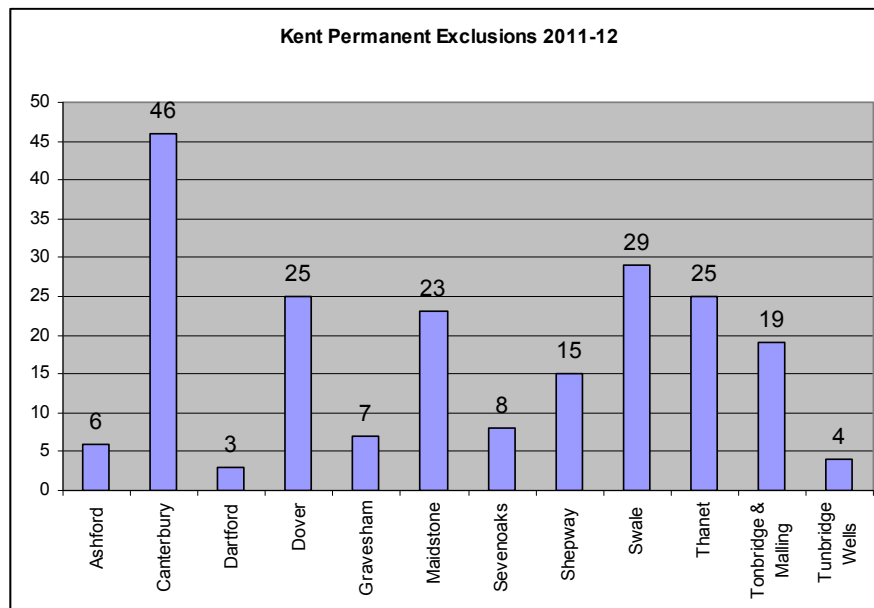

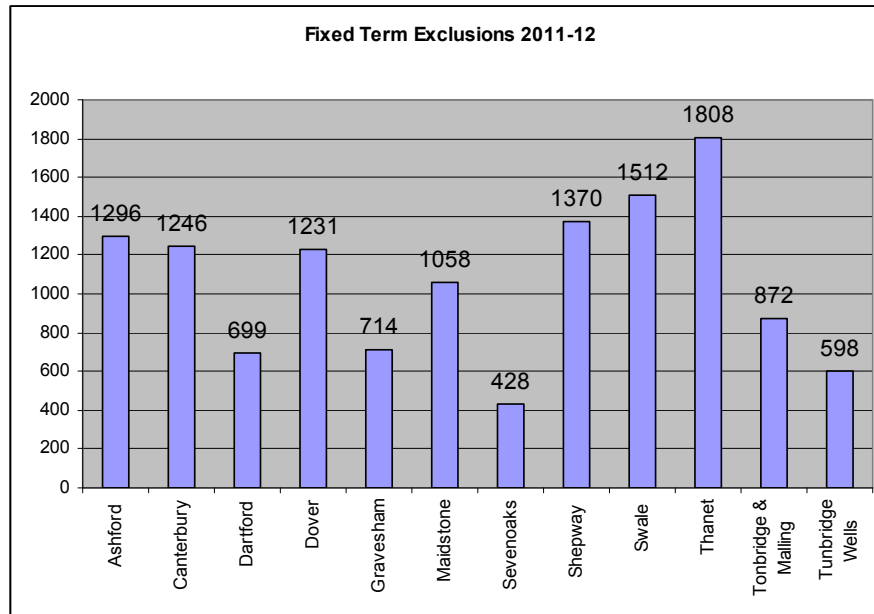

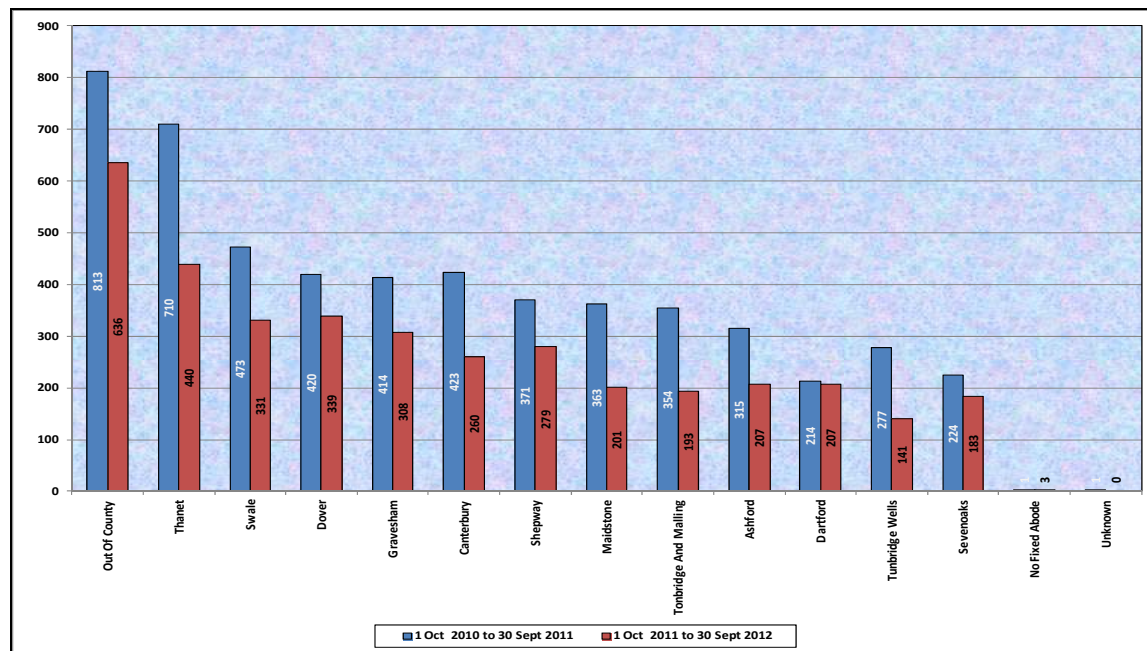

## 5.11 Discussion Points

1. Overall KCC, providers and other agencies collectively could better target their support to the most vulnerable, particularly looked after children, those educated other than in school (home educated or in alternative provision/PRU) and those with BESD.
2. A strategy is needed to meet the needs of the high numbers of learners with statements for social, emotional and behavioural learning difficulties. There is currently no specialised post 16 provision for these young people who are now under a duty to participate until 18. Considerably more specialised provision or support for BESD learners in mainstream provision needs to be made available as a matter of urgency.
3. The district could develop an offer which is more accessible to learners caring for their own child, using supports systems such as YAPS (Young Active Parent Support).
4. The Skills & Employability Service and KCC Families and Social Care need to support providers in working with LAC who are placed by other local authorities. Many of these have SEN and require intensive and constant support to achieve good educational outcomes and participate to 18.
5. An action plan is needed between Canterbury schools and the new PRU to reduce permanent and fixed term exclusions.
6. A district transition forum would help ensure that there is support and oversight for all learners who are out of school, to support their progression to post 16 provision.
7. Schools could work together with KCC to develop a strategy to reduce persistent absence as this has a direct link to the probability of being NEET post 16. Extra support for post 16 transitions should be offered to learners who have had a high level of absence at school.
8. Better use could be made of the data available on young people, particularly those who are statemented, so that post 16 planning can begin in Year 9.
9. KCC, Canterbury providers and other Kent specialist providers could work together to improve the information on post 16 provision and support for LDD learners, using Kentchoices4u to publicise it.
10. Canterbury providers should support the work of the Kent Integrated Adolescent Support Services (KIASS).
11. Canterbury Providers could work with the Youth Contract to access support for NEET learners. This work should start with young people who are at high risk of being NEET before they finish key stage 4.
12. Canterbury providers could work with Virtual School Kent, who are offering post 16 support for Looked After Children.
13. KCC could support providers in developing mechanisms to improve educational outcomes and engagement for LAC from other local authorities especially where the provider receives an inadequate service from that LA and requires help in challenging the placing authority.
14. More capacity is needed in the Vulnerable Learner Apprenticeship Scheme to encourage the recruitment and support of apprenticeships for vulnerable learners.
