Free Early Education and Childcare Period Sept 2024 – Aug 2025

This document details the funding periods and payment dates for childminders in Kent offering Free For Two Funding, 3&4 Universal Funding, the Working Parent Entitlement, Early Years Pupil Premium (EYPP) and Disability Access Fund (DAF) for children aged 9 months – 4 years and is to be used in accordance with the terms of the Kent Provider Agreement.

### **Funding Rates**

The funding base rate for providers in 2024/25 are as follows:

3 & 4 Year Olds	£5.16
2 Year Olds	£7.55
9 Months +	£10.26
EYPP	0.68p per funded hour

Additional funding may be added for providers who qualify for the quality supplementary rates. Deprivation supplements will no longer be added to provider rates and will be an additional payment made by KCC's Finance Team.

#### **Funded Weeks**

In line with the Kent Provider Agreement, providers can offer a non-stretched or stretched pattern or both. However, where providers are unable to open for the 38 weeks and this has been agreed with KCC, the provider must ensure that parents are made aware prior to taking up their place that they will not be able to access their full free entitlement with them.

#### **Settings offering Stretched funding**

In the case of a parent taking up the 'stretched' offer, they must be made aware that they may exceed their free early education and childcare hours. Please be aware that the choice of whether to stretch the funding is up to each provider and is not obligatory.

Free Early Education and Childcare claims can only be submitted under a 38 week or 48 week pattern. If you wish to deliver the funding entitlements outside of these options, please refer to the stretched funding calculator, child tracker and sample calendars on KELSI to ensure you claim the correct number of funded hours.

# **Submitting Funding Claims**

All Free Early Education and Childcare claims\* are submitted to Management Information via the Synergy FIS Provider Portal and follow an estimate and actual attendance / headcount collection process. Providers **must** have a signed Parental Declaration Form before submitting any claims. Any new children starting after the headcount submission window (who have not attended another Kent provision in that funding period) or amendments to claims can be submitted via the adjustment tab in the provider portal and will be paid in line with the payment windows specified.

\*Disability Access Fund (DAF) does not follow this process and is not completed within the Synergy FIS Provider Portal. The application can be found on KELSI - <u>Claiming EYPP and DAF - KELSI</u>. Payment for eligible children will be made in line with the set payment dates on pages 3&4.

### **Free For Two Funding**

Free For Two Funding is for the most disadvantaged two year olds in Kent. Estimate and actual attendance should be based on KCC confirmed eligible children only. Children can start at any point during a term and claims **can** be submitted to increase funded hours throughout the term.

### 3&4 Year Old Universal Funding and the Working Parent Entitlement for 9 months- 4 years

A headcount claim should only be submitted for those children who are accessing their **full** funded hours during the designated headcount week. Funding is based on one claim, per term, per child for these entitlements. Universal hours and the Working Parent Entitlement hours **cannot** be increased after headcount week. If a parent wishes to increase their hours, they will need to wait until the following term or pay for the additional hours.

#### **Designated Headcount Weeks:**

Autumn 2024: Monday 9 September – Friday 13 September 2024

Spring 2025: Monday 13 January – Friday 17 January 2025

Summer 2025: Monday 28 April – Friday 2 May 2025

#### **EYPP**

Early Years Pupil Premium (EYPP) is based on up to 15 funded hours a child is receiving for the term across all the entitlements (EYPP is not payable on the additional 15 hours entitlement for 3&4 year-old children of working parents).

Providers must add the parent details from the Parental Declaration Form onto the child's funding claim in the provider portal and tick the EYPP consent box to allow KCC to complete an EYPP check on all children, EYPP will then be added to the child's claim for the term. If a child meets the non-economic criteria, then providers can follow the application process on KELSI - <u>Claiming EYPP and DAF - KELSI</u>.

# **Submission Windows and Payment Dates:**

The Early Years Local Funding Formula 2024/25 Consultation feedback indicated a strong preference from Childminders for monthly payments. KCC have split both the estimate and actual attendance/ headcount payments into 2 payments to profile payment over the months in the term.

## **Early Year Census**

The Early Years Census is how the local authority receives funding to pay providers for the year, so it is vital that **ALL** providers complete it. Census week will be 13 – 17 January 2025 and providers will have until 31 January 2025 to submit their return.

Failure to submit a census will result in your Spring term actual attendance/ headcount payment and any subsequent payments being placed on hold until it is received.

## **Compliance Visits**

KCC, its agents or any person authorised by KCC, will carry out regular audits on all registered childcare providers to ensure compliance with the requirements of Free Early Education and Childcare funding. KCC, its agents or any person authorised by KCC, will also carry out checks as a result of a complaint or concern.
