#### Prevent

The Prevent programme is a key part of the Government's counter-terrorism strategy. It aims to stop people becoming terrorists or supporting terrorism. It deals with extremist ideology, extremists and extremist groups where they are moving towards terrorism. Schools and governing bodies have a critical part to play. Significant news coverage has featured over the past few months on the threat of IS and travellers to Syria and Iraq. There have been a number of examples of school children travelling to these areas. Department of Education guidance 'Keeping Children Safe in Education', (April 2014) refers to the risks of radicalisation and the guidance contains links to the Channel process. Channel is a key element of the Prevent strategy. It is a multi-agency approach to protect people from radicalisation. It is about safeguarding children and adults from being drawn into terrorist related activity. It is not an entry to the criminal justice system but a needs based support and intervention programme.

Prevent now features prominently within the Ofsted schools inspection framework. The recent reports on Sir John Cass School, an award-winning secondary school in Tower Hamlets that is going into special measures over concerns about its sixth-form Islamic society's possible links to radical preachers, demonstrates the critical role of schools in the Prevent agenda. On 26th November the Home Secretary introduced the Counter-Terrorism Bill – this proposes creating a new duty on certain bodies to have due regard to the need to prevent people from being drawn

into terrorism. It will apply to schools, colleges, universities and others. Whilst there are priority areas elsewhere in the country, all areas need to understand the local threat and in partnership, take action to address it.

It is essential that school safeguarding leads and governors with safeguarding responsibilities understand their role to support the Prevent strategy. Training and awareness will be rolled out over the next few months. Kent and Medway have an effective Prevent multi-agency steering board driving the local agenda. #### Kent Safeguarding Children Board networking workshops

#### **Safer Recruitment Training**

You will be aware that as of 1 September 2014 there has been a change to the training requirement for school staff recruitment panels. Currently the School Staffing (England) Regulations 2009 require that at least one member of staff of a recruitment panel is required to

have completed training approved by the Secretary of State. Whilst regulation will continue to require at least one member of the panel to have undertaken safer recruitment training, the training no longer needs to be approved by the DfE. Consequently the on-line training facility approved by the DfE is no longer available, although the NSPCC is working to establish such a training resource which should be available in the New Year. During the DfE's consultation on the removal of the requirement for safer recruitment training to be approved by the Secretary of State, schools were concerned that, at the point the on line training closed, they would become individually responsible for identifying appropriate trainers and suitable training for their staff. These fears have been allayed by the development of the Safer Recruitment Consortium which includes the NCB, NSPCC, NCTL and the Lucy Faithful Foundation who have taken on the task of updating the materials and reaccrediting trainers who were approved to deliver the previous model. The Education Safeguarding Team has two approved trainers to deliver the revised safer recruitment training and with the support of the Schools Personnel Service we will continue to provide sufficient places to school senior leaders and governors as this is an area that Ofsted will continue to monitor during inspections.

We are also developing safer recruitment refresher training (half day) to update school leaders who have successfully undertaken the initial full days training. There is currently no requirement that stipulates how often this training should be refreshed but KCC (with the approval of KSCB) is advocating that this should take place every three years. It is hoped that this Refresher training will be available before Easter 2015. #### Disqualification and The Early Years Foundation Stage (2014)

The Department for Education has now confirmed the requirements stipulated in The Childcare Act 2006 and The Childcare (Disqualification) Regulations 2009 extend to the Early Years Foundation Stage in both the Maintained and Private, Voluntary & Independent (PVI) Sectors.

In summary, the regulations mean an individual 'providing early years childcare or later years childcare to children who have not attained the age of eight' may be disqualified as a result of an act for which they are directly responsible (for example, committing a specified crime). Additionally, they may also be 'disqualified by association' as a result of living in the same household as someone who would themselves be disqualified.

Individuals who are disqualified are not permitted to continue to work in early or later years provision, including school nursery and reception classes. They can apply to Ofsted for a waiver, who may grant a full or partial waiver. While an application to Ofsted is under consideration the individual must not continue to work in the setting.

#### **Child Sexual Exploitation update**

You will be aware that Kent along with 7 other local authorities, was recently part of an Ofsted thematic inspection in relation child exploitation. The national findings were published on 14 November 2014 entitled "The sexual exploitation of children: it couldn't happen here, could it?" November 2014, No. 140175

The national findings included 25 recommendations for local authorities, local partners, Ofsted and the Government. There is little specific reference to schools but schools need to be aware of their responsibilities as a partner agency and of the need to evidence knowledge of CSE as part of Ofsted inspections. The report states

Local authorities and partners should

- ensure that information and intelligence is shared proactively across the partnership to improve the protection of children in their area and increase the rate of prosecutions
- consider using the available child sexual exploitation assessment tools to improve risk assessments of children and young people in their area; where these are in place, they should be used consistently by all agencies
- ensure that sufficient appropriate therapeutic support is available to meet the needs of local young people at risk of or who have suffered from child sexual exploitation, including care leavers
- make sure that local strategies and plans are informed by the opinions and experiences of those who have been at risk of or have suffered from child sexual exploitation
- enable professionals to build stable, trusting and lasting relationships with children and young people at risk of or suffering from child sexual exploitation
- consider how effective local schools are in raising awareness and protecting children at risk of or who have suffered from sexual exploitation.

#### Ofsted should

- ensure that child sexual exploitation is considered within the safeguarding sections of all future inspection frameworks and across all remits
- continue to sharpen the focus given to child sexual exploitation in all children's services inspection frameworks, including the review of Local Safeguarding Children Boards.

What this means for you as a DCPC

You will need to aware of the Kent Policies and Procedures in regard to CSE. Information can be found on the kscb.org.uk website <a href="http://www.kscb.org.uk/professionals/sexual\_exploitation.aspx">http://www.kscb.org.uk/professionals/sexual\_exploitation.aspx</a>

You will need to consider staff awareness and understanding of CSE in particular the early signs. The Barnardo's leaflet "Spot the signs" for professionals should be available in school.

You will need to consider how you are educating children about CSE - how to keep themselves safe, how to report etc.

You will need to consider how CSE relates to other policies and procedures in particular KSCB's "sexually active young people" and "Missing Children" policies as well as the Children Missing education procedures.

There are CSE training courses available from Kent Safeguarding Children Board, however these are likely to be very much in demand due to the recent inspection. If you cannot access a KSCB course in the near future you should make use of the materials provided via KSCB. We recommend as a minimum that you download the CSE toolkit and the CSE procedures and add them to your DCPC information if you haven't already done so.

At the bottom of KSCB pages you will find a link to the local Government Association awareness raising resource. These include "Spot the signs" for partner agencies and some useful video clips.

**'Looking for Lottie' - Child Sexual Exploitation (CSE) Training from the University of Kent** Launched in November 2014, developed by the Centre for Child Protection at the University of Kent with NHS Health Education Kent, Surrey and Sussex, 'Lottie' offers health, social care and education professionals the opportunity to train on key aspects of online CSE. It is an interactive and immersive simulation, based on real cases and research. 'Lottie' is designed for use with both professionals and young people (11-18). It follows the story of a schoolgirl Lottie and how she becomes involved with Jake, a seemingly innocent 'boyfriend'.

'Lottie' includes links for professionals with tools and reflective questions about how to respond to young people who are potentially at risk, to gain insight into grooming behaviour, how to spot it on different social media and how to help children protect themselves from child sexual exploitation.

'Lottie' can be used in formal and informal settings to educate young people about grooming methods via social media in a real-life social media scenario and by understanding and exploring the behaviours and implications for the characters, young people will learn how to safeguard themselves.

#### e-Safety Updates

The recent update to the school Inspection Framework now sees e-Safety fully embedded within several inspection strands (including leadership and management, behaviour and safety and safeguarding) and increased training for inspectors. These, along with ever increasing media coverage and Government interest means that e-Safety should be high on everyone's agenda.

Schools need to be aware of this consultation being undertaken by the DfE on proposed changes in working together arrangements specifically relating to:

- The referral of allegations against those who work with children
- Notifiable incidents involving the care of a child
- The definition of serious harm for the purposes of serious case reviews
