# Introduction

#### What is the purpose of the District Data Pack?

The purpose of the district data packs is to stimulate discussion within district education/training communities on how best to prepare young people for employment, be that at the end of Key Stage 4 or after post graduate study.

The packs look at new and old data sets and ask searching questions about local pathways, their compatibility with the local economy and the support young people receive; particularly vulnerable young people. They have been produced as a desk top exercise, they do not propose solutions, but provide the key questions that need addressing and the data to support the development of localised solutions.

#### What data has been used?

The intention has been to use where possible data that has not been widely used and to collate data to give an overview at a district, county, regional and national level to provide a wider context.

A significant number of data sources have been drawn together and as a consequence there will be some minor inconsistencies in the data. However, where there may be inconsistencies in the data, this is highlighted and the messages the data provide are consistent.

This is unavoidable due to the way data is collected locally, regionally and nationally. Kent County Council, Education Learning and Skills Directorate are currently reviewing the way it stores data and the way it works with other directorates.

#### How does the District Data Pack support Kent County Council Policy?

The Local Authority has clearly articulated how it intends to support young people make the most of their potential in the 14-24 Learning, Employment and Skills Strategy and the structure of the data pack reflects its four strategic priorities:

- To raise attainment and skill levels
- To extend and improve vocational education, training and apprenticeships
- To increase participation and employment
- To target support to vulnerable young people

#### How should the District Data Pack be used?

The executive summary tells the high level picture of the district and raises 8 key questions. Each priority section then has a summary, the supporting data from which the conclusions have been drawn, followed by a number of more searching questions.

It would not be possible to address all of the issues raised in the data pack at once, it is for local groups of education/training providers and employers to identify their own local priorities and strategies.

The data packs should not be used in isolation and local providers may wish to use the UKLP datadashboard on level 3 provision and their own data systems to complement the process.

Richard Little, your local Skills and Employability Area Manager and John Turner, Participation and Progression Manager will be able to support districts co-ordinate their response.

#### The relationship with the District scorecards

The district data packs do not establish any new benchmarks or measures for local providers; their purpose is support providers' strategic planning.

# **Executive summary**

#### 1. 16-18 population

Gravesham is a net importer at Year 7-11 (449) and sixth form (149), but almost forty percent of 16-18 year olds who attend FE Colleges travel to Dartford.

The Year 7-11 population is set to fall by over 300 by 2015/16 but should return to higher than current levels by 2018/19. However, using current forecast models the sixth form population is set to contract by over 100 by 2017/18. So it will be over 5 years before population rises will impact on sixth forms sizes.

When collectively planning the post 16 offer in Gravesham, providers need to consider that there are falling numbers of learners, the educational levels they need to cater for and that there may be an opportunity to increase the number of learners studying locally by encouraging FE learners to study within the Borough.

The population of Gravesend creates significant challenges to the local economy, the three largest groups are contrasting comprising of; middle aged parents receiving benefits, living in neighbourhoods of social housing with higher levels of unemployment, Younger professionals with children, some living in ethnically diverse neighbourhoods (12%), vulnerable singles and lone parents with young children (14%), living in higher crime areas in neighbourhoods of social housing (12%)

#### 2. Raise Attainment

At Key Stage 4 achievement in Gravesham is strong. It is the second highest performer in the county for GCSE English and Maths, with only 1 in 5 not gaining a C grade. The percentage of students with 5 A\*-C grades with English and Maths entering Level 3 courses at sixth form is the highest in county and above the national average.

The fail rate for AS Level is slightly higher than the county and nationally but for A Level it is below both and overall retention from the beginning of Year 12 to the end of Year 13 compares favourably.

The average point score (APS) for Level 3 at sixth form is 42 points above the national average, but, the average point per entry (APE) is slightly below both national and county levels, as are the percentages gaining higher grades (A\*-C). So it would appear that some Gravesham learners are taking more AS/A levels and achieving lower grades, despite strong performance at Key Stage 4.

In sixth form BTEC's performance is comparable with the rest of the county but fewer are achieving D\*.

There is a good spread of A Levels available within the Borough and 6 of the most popular subjects are Russell Group facilitating figures. Progression into universities from Gravesham schools is good but progression to the selective universities does not match the rest of the county, despite the relatively high take up of the facilitating subjects.

In Gravesham like the rest of the county 1 in 4 learner learners participate in post 16 education or training, gain qualifications, but do not progress to the next educational level by age 19. This is particularly the case for learners who are Level 2 without English and Maths at 16, where just over half do not progress to the next level.

Progression for learners by age 19, who were below Level 1 at 16, is also an issue; over half do not gain any further qualifications and only 1 in 4 reach Level 1.

#### 3. Improve and extend vocational education, training and apprenticeships

Between 2008 and 2011, total employment in Gravesham decreased by 1,800, or 6% (27,700 to 25,900). This compares to an overall fall in employment in Kent of 0.4% in the same period. The Borough's economic strengths, which will influence its ability to support new employment in future, include its location within the Thames Gateway growth area, where major housing growth is planned and its good transport accessibility to the A2 and the M2 motorway, with fast rail links to London.

The construction sector has been traditionally strong but the Borough's manufacturing base has been hit particularly hard during the recession. Gravesham's large manufacturing companies are largely focused on activities such as aggregates and cement production, metal refining, chemicals, paper, marine and electrical engineering and some riverside-related uses.

Between 2008 and 2011 the only employment sectors in Gravesham that increased by any percentage were:

- Human Health and Social Work
- Education
- Real Estate
- Professional, Scientific and Technical Activities

Retail and Wholesale employs the **largest** number of residents in Gravesham (4,500) but there is only one full time course on offer at Level 3. This does not allow learners with an interest in a career in Retail to obtain successful qualifications to enter into employment at appropriate levels.

Self-employment rates in Gravesham have traditionally matched Kent and South East averages, although has increased in 2011/12. This mirrors the reduction in employment in large companies seen during the recession.

Youth unemployment remains a huge issue in Kent and is high with Gravesham having the fourth largest unemployed population of 18-24 year old residents.

Progression opportunities are very good with most courses being offered across Levels 1-3 in Gravesham. However, there is a need for the curriculum offer to reflect the needs of the local economy. For example Human, Health and Social Care and Retail are areas of growth but there are a limited number of courses available for these subjects. Conversely there are a very high proportion of Sport and Performing Arts courses (particularly at Level 3) but limited opportunities for employment in these areas and therefore this provision should be reviewed.

Professional, Scientific and Technical Activities have been identified as an area for growth but at present there are limited courses and an increase in provision should be considered.

Tourism is forecast to be a growth area for Gravesham, a dialogue with local providers and the Borough Council is needed to understand the range of opportunities that could develop in this sector, in addition to those offered through Hospitality and Catering. There is limited provision in Travel and Tourism.

There are greater opportunities to study apprenticeships at a range of levels across a wide range of industry sectors. Providers should encourage more learners to consider this as an entry point into employment or as an alternative to going to university.

#### 4. Increase Participation and Employment

In relation to RPA, 87% of 16-18 year olds already participate in Gravesham, but it is the remaining 13% who will create the challenge. On looking at this group it can be seen that participation in Year 12 is far higher than in Year 13. In total, if post 16 circumstances do not change by 2015, an additional 220 young people would need to participate.

If we look at how learners participate in Gravesham, it can be seen that more learners attend FE Colleges than the rest of the county and attendance at sixth form is lower than the county average.

Under RPA a new group of young people will need to be supported, these are those that are in employment without training. In Gravesham this number amounts to 86 learners.

Gravesham providers will need to consider what type of provision would be most appropriate to accommodate these young people and how they can work with employers to convert jobs without training into jobs with training.

It is encouraging that of the current NEET population 2 in 5 have expressed an interest in working in one of the sectors that have been identified for growth in Gravesham.

Gravesham has the third highest unemployment rate in the KCC area at 4.2% and has the fourth highest proportion of 18-24 year olds who are unemployed in the South East (8.5%). Therefore it is essential that young people received good IAG, support and post 16 pathways that meet their needs.

A recent learner voice survey carried out by the Skills and Employability Service identified that young people in Kent currently do not understand the concept of RPA, many think it is about staying on at school and are looking for face to face guidance to support them making important post 16 decisions.

To conclude, it will be difficult for Gravesham providers to deal with all the challenges that RPA and high unemployment will create, particularly if it is a reactive response to the problem. Providers need to consider how they can develop early intervention strategies in Key Stage 4 and in Year 12, in addition to realigning the post 16 offer.

#### 5. Target Support to Vulnerable Young People

In Gravesham the number of 16-24 year olds who are NEET and included in one of the CXK's county wide priority groups is 139 (8%), of this number the largest groups are: caring for own child (52 and another 12 who are registered as pregnant), LLD (39) and Looked after/In care in total (10).

A further analysis of the 16-18 year old NEET data identifies that almost half are LDD and quarter are BSED. This need will continue as there are currently 125 learners in key stage 4 who have a BSED statement.

This will create challenges to Gravesham providers who will need to consider how they prepare their learners for transition from Year 9 and Year 11 onwards, how learners are supported through transition and what the most appropriate post 16 pathways. There is also the need to map the range of support that is required from agency partners.

In February 2013 there were 86 known looked after children in Gravesham and 32 (37%) who were the responsibility of other Local Authorities. Of these 13 learners were in Key Stage 4 and 9 were post 16 learners. Within this group 15 had a statement, 8 had a statement (but were the responsibility of another LA), 5 had ASD, 4 had BESD and 4 had MLD statements.

Gravesham Borough has the lowest number of children (361) of all ages with a SEN Statement in Kent but it does have the **third** highest number of Children Missing Education Referrals. Consideration will need to be taken on how to reach out to this group due to their potential to become NEET.

Exclusions in Gravesham are healthy when compared across Kent. As at February 2012 there were 7 permanent exclusions making Gravesham the fourth lowest district. It also has the fourth lowest rate for fixed term exclusions.

Gravesham has 131 young offenders but the fifth highest number of offences committed in the County. There has been a significantly downward trend of -29% between October 2010 and September 2012.

### Key challenges for Gravesham providers

- 1. There are 165 learners who gained no further qualifications by age 19. What can be changed at district level to improve this situation?
- 2. Despite strong performances at KS 4, the attainment of higher grades at level 3 and the average points per entry (APE) were lower than expected.
- 3. There is a mismatch between the vocational offer and the needs of the local economy. This should be reviewed.
- 4. Participation in year 12 is higher than in year 13. How will providers increase retention as there will be a potential increase in learner numbers due to RPA?
- 5. Gravesham providers should ensure that there are the correct transition opportunities in place for vulnerable groups, particularly those that are at risk of becoming NEET to enable them to progress successfully into a positive destination.
- 6. The number of self employed people 16-24 has increased in Gravesham and consideration should be given to improving awareness and developing opportunities for business start up and entrepreneurial opportunities


# 1.2 Supporting data

- 101 learners travel out for sixth form education and 250 travel in.





#### 1.2.2 Population change

- The Year 7-11 population is predicted to decline until 2015/16, after which it will start to climb again.
- The sixth form population is forecast to decline by 128 learners to 2017/18, after which it will start to climb again.
- The sixth form forecast models do not take into account the impact that Raising the Participation Age will have on sixth forms.

# 1.2.3 Inter-district migration of Gravesend residents for Further Education

Of the 1149 16-18 year old Gravesham residents who were in Further Education in 2009/10, 722 (63%) studied in Gravesham. Those who did travel out of the District went mainly to Dartford, 348 (81%), where 5% studied at Level 1, 24% at Level 2, 70% at Level 3 and 1% at Level 4.



#### 2.2.4 Attainment by Provider Type

Learners with prior attainment at 16:

- 42.3% (26) of learners below Level 1 at 16 who went to a FE college gained a Level 1 qualification, compared to 29.4% (17) at training providers (exact definition unclear) and 26.7% (15) who went to their home sixth form.
- 64.2% (176) of learners at Level 1 at 16 who went to a FE College gained a Level 2 qualification, compared to 50% (34) who went to their home sixth form. 37.5% (40) who went to a training provider. The number who went to another sixth form is too low to draw conclusions (10).
- 82% (50) of learners who were Level 2 without English and Maths who went to their home gained a Level 3 qualification, compared to 64% (14) who went to another sixth form and 29.5% (112) went to a FE College. This data includes A Level students and those studying vocational courses.





# 2.2.7 Progression of A Level students into Higher Education

- Progression into Higher Education from Gravesham schools exceeds that for the county. Progression
  into the selective Sutton Trust Universities is slightly below county levels but relatively healthy given
  the lower exam points per student.
- The take up of the Russell Group facilitating subjects by Gravesham learners is good but progression to a Russell Group University is low which suggests that there may be an issue linked to the aspirations of some Gravesham learners.

# 2.2.8 Narrowing the gap by age 19

- Gravesham has a lower number of FSM eligible learners compared to other districts with a similar cohort size.
- The gap at Level 2 by age 19 in Gravesham is higher (-29.1) than the national (-18) and Kent (-25.5) gap.
- The gap at Level 3 by age 19 in Gravesham is in line (-34.5) with the Kent gap (-34.4), but higher than the national gap (24.3).

# 2.3 Discussion points

- 1. In Gravesham there were 34%(113) of learners at Level 1 gained qualifications but not at Level 2. There are also 165 learners who gained no further qualifications by age 19. Therefore, is there sufficient and appropriate Level 1 provision within the locality?
- **2.** There are significantly more learners that do not achieve Level 2 English (446) than maths (249). Is this an issue that can be changed through collaboration and the sharing of good practice?
- **3.** At Level 3 students perform well but the proportion of students achieving the highest grades for A level and BTEC is lower than the Kent and National averages. Ways of improving this should be considered.
- 4. How can Gravesham providers support each other in relation to progression to university through sharing CEIAG good practice, curriculum design and curriculum choice.
- 5. For students eligible for FSM the attainment gap is above the Kent average for those achieving Level 2 but continues to widen for learners achieving at Level 3. The issues for this should be discussed collaboratively with all with providers to improve the outcomes for
- 6. Providers may wish to look at their own LPUK Data Dashboard as there will be issues specific to each individual institution regarding Level 3 data.

# 3. Improve and extend vocational education and training and apprenticeships

# 3.1 Summary

Between 2008 and 2011, total employment in Gravesham decreased by 1,800, or 6% (27,700 to 25,900). This compares to an overall fall in employment in Kent of 0.4% in the same period. The Borough's economic strengths, which will influence its ability to support new employment in future, include its location within the Thames Gateway growth area, where major housing growth is planned and its good transport accessibility to the A2 and the M2 motorway, with fast rail links to London.

The construction sector has been traditionally strong but the Borough's manufacturing base has been hit particularly hard during the recession. Gravesham's large manufacturing companies are largely focused on activities such as aggregates and cement production, metal refining, chemicals, paper, marine and electrical engineering and some riverside-related uses.

Between 2008 and 2011 the only employment sectors in Gravesham that increased by any percentage were:

- Human Health and Social Work
- Education
- Real Estate
- Professional, Scientific and Technical Activities

Retail and Wholesale employs the **largest** number of residents in Gravesham (4,500) but there is only one full time course on offer at Level 3. This does not allow learners with an interest in a career in Retail to obtain successful qualifications to enter into employment at appropriate levels.

Self-employment rates in Gravesham have traditionally matched Kent and South East averages, although has increased in 2011/12. This mirrors the reduction in employment in large companies seen during the recession.

Youth unemployment remains a huge issue in Kent and is high with Gravesham having the fourth largest unemployed population of 18-24 year old residents.

Progression opportunities are very good with most courses being offered across Levels 1-3 in Gravesham. However, there is a need for the curriculum offer to reflect the needs of the local economy. For example Human, Health and Social Care and Retail are areas of growth but there are a limited number of courses available for these subjects. Conversely there are a very high proportion of Sport and Performing Arts courses (particularly at Level 3) but limited opportunities for employment in these areas and therefore this provision should be reviewed.

Professional, Scientific and Technical Activities have been identified as an area for growth but at present there are limited courses and an increase in provision should be considered.

Tourism is forecast to be a growth area for Gravesham, a dialogue with local providers and the Borough Council is needed to understand the range of opportunities that could develop in this sector, in addition to those offered through Hospitality and Catering. There is limited provision in Travel and Tourism.


There are greater opportunities to study apprenticeships at a range of levels across a wide range of industry sectors. Providers should encourage more learners to consider this as an entry point into employment or as an alternative to going to university.

# 3.2 Supporting data

#### 3.2.1. The Gravesham Vocational offer and the local economy

- 1. Sport, Leisure and Recreation offers the most courses in Gravesham (27) and has progression from Level 1-3. There are only 6 courses at Level 2 but 19 courses at Level 3. This area has a small number of employment opportunities.
- **2. Performing Arts** offer 23 courses with only progression from Level 2-3. Again this is not a sector that offers high levels of employment for local people.
- 3. Crafts, Creative Arts and Design offers 16 courses with progression from Level 1-3. Although currently not a large employment sector, it has been identified as a possible area for growth by the East Kent Regeneration Plan. However, earlier work with this sector highlighted the need to include business management in related courses due to the high level of self employment and small businesses in this sector.
- **4. ICT** offers 9 courses and progression from Level 1-3, with decline in admin and support service progression likely to be important in the future. This need for progression through levels also applies to those taking Admin courses (8 available in Gravesham with progression available from 1-3).
- **5. Engineering** offers progression opportunities but not in **manufacturing technologies**. While the numbers employed in manufacturing are dropping, this may not be a reflection of output and young people entering these industries will likely need to be highly skilled.
- **6. Service Enterprises (Hairdressing) offers** 9 courses with progression from Level 1-3. Retail is a growth area.
- **7. Construction** offers 14 courses in Gravesham with progression from Level 1-3 available, but this sector is not a significant employer of local people.
- **8. Horticulture and Forestry** offers 9 courses at all three levels. There is limited information on employment opportunities in this sector
- **9. Science** offers 3 courses at Level 3. Life sciences, low carbon and environmental goods and services have been identified as having the potential for growth.
- 10. Travel and tourism, Child Development, Well Being Health and Social Care and Public services each have 7 courses on offer with progression through Levels 1-3. The first three sectors have seen employment growth where as Public services has seen a decline in employment opportunities.
- **11. Retail** employs the **highest** number of Gravesham residents, but there is only **one** course at Level 3. There are apprenticeship frameworks on offer in this sector.
- **12. Transport Operations and Maintenance** offers 7 full time courses with progression from Level 1-3. There is also Level 2 apprenticeship framework in this sector.

# 3.3 The Economic Landscape of Gravesend, 2008-11

#### 3.3.1 Introduction

Between 2008 and 2011, total employment in Gravesham decreased by 1,800, or 6.5% (27,700 to 25,900). This compares to an overall fall in employment in Kent of 0.4% in the same period.

The Borough's economic strengths, which will influence its ability to support new employment in future, include its location within the Thames Gateway growth area, where major housing growth is planned and its good transport accessibility to the A2 and the M2 motorway, with fast rail links to London. The construction sector has been traditionally strong, with generally low wage levels and land/building costs combined with affordable housing costs.

Its main weaknesses include its small local economy and declining employment levels, relatively low rates of local business formation and entrepreneurship and under representation in the office based sectors generally, which typically have greater potential for growth.

The Borough's manufacturing base has been hit particularly hard during the recession. Gravesham's large manufacturing companies are largely focused on activities such as aggregates and cement production, metal refining, chemicals, paper, marine and electrical engineering and some riverside-related uses.

These activities are concentrated on large sites along the Thames riverside. As these have declined, other private sector opportunities have not grown fast enough to fill the gap.

The Gravesham Borough Council Corporate Plan describes how it is committed to creating future employment growth in the Borough through encouraging enterprise, river related employment opportunities (including a centre for Marine Excellence) and tourism development.<sup>1</sup>

The main employment sectors in Gravesham are the wholesale and retail trade, education and human health and social work activities.

Between 2008 and 2011 the only employment sectors in Gravesham that increased by any percentage were:

- Human Health and Social Work
- Education
- Real Estate
- Professional, Scientific and Technical Activities

Between 2008 and 2011 the following employment sectors fell by a significant amount, 10% or greater:

- Manufacturing
- Construction
- Transportation and Storage
- Administrative and Support Activities
- Public Administration and Defence
- Other Service Activities

The large private sector employers in Gravesend have very familiar names including:

- Rodenstock (manufacture of optical equipment);
- Comma Oil & Chemicals;
- Lafarge Cement;
- Kimberly Clark (paper);
- Britannia Refined Metals
- Port of London Authority

Significant public sector employers include North West Kent College, Gravesham Borough Council and Dartford and Gravesham NHS Trust.

#### 3.3.2 Areas of Growth 2008 - 2011

#### **Human Health and Social Work Activities**

Between 2008 and 2011, employment in the Human Health and Social Work Sector has growth by 1,000 employees or 45%. This compares to average employment growth in Kent of 12.6% and represents the trend toward movement in public spending towards frontline services to meet increasing care needs in the community. This sector employs as many workers in Gravesham as Manufacturing and Construction combined.

#### **Professional, Scientific and Technical Activities**

Between 2008 and 2011 this sector has grown by 10% or 100 employees, which compares to 10% growth seen in Kent as a whole. This will represent inward investment to Gravesham as some higher technology start-ups are replacing traditional manufacturing activities, probably as part of the supply chain for the London Array wind farm.

#### **Real Estate Activities**

The Real Estate Sector grew by 50%, or 100 jobs, from a low base, compared to the Kent average of 18%. Gravesham has seen significant housing development over the last 4 years, has benefitted from the Ebbsfleet Station and fast (HS1) train links to London, along with £120 million of investment in roads and the broader Thames Gateway activities.<sup>3</sup>. This has impacted on the property market and the need for Real Estate Services.

#### **Education**

Between 2008 and 2011 the education sector grew by 100 employees, or 3%. This growth is probably not significant and represents responses to a growing resident population, the growth of academy status and Building Schools for the Future funded developments at Ifield and Northfleet Technology College.

#### 3.3.3 Areas of Decline, 2008 to 2011.

#### Manufacturing

As described in the introduction, Gravesham has traditionally relied on a manufacturing base that is in decline globally. Between 2008 and 2011 the sector lost 300 jobs or 15% of its workforce. This declining trend can be seen as far back as 1998, when the sector employed over 4,500 people.

#### Construction

Between 2008 and 2011 the Construction Sector lost 700 jobs or 29% of its workforce. This compares to a Kent wide average fall of 15%. Gravesham has seen significant construction activity as part of the Thames Gateway in the past, and will again in the future.

#### **Transportation and Storage**

This sector has declined by 400 jobs, or 22%, between 2008 and 2011, compared to a 10% average decline across Kent. Interestingly the two Districts that have seen significant employment growth in this sector in Kent are the neighbouring Districts of Dartford and Swale, both in the Thames Gateway.

#### **Administrative and Support Activities**

Between 2008 and 2011 this sector declined by 900 jobs or 35%, compared to 4% across Kent. This is the largest reduction in employment in any sector in Gravesham. As described in the introduction, Gravesham is very poorly represented by office based employment, and this trend appears to be continuing. The potential for office based developments in Ebbsfleet will determine the future of this sector.

#### **Public Administration and Defence**

The Public Administration and Defence Sector declined by 300 jobs, or 14% during this period. This mirrors the average Kent reduction and reflects the increasing trend towards focussing public spending away from back office towards frontline services.

#### **Other Service Activities**

Activities in this sector are those jobs that provide support services for individuals and households. They include repair of household appliances, funeral services, hairdressing, along with Trade Union Activities, activities of religious organisations and others. Employment in this sector fell by 20% or 100 jobs, from a low base, and matches the Kent average. This is to be expected as employment has fallen across the Borough.

#### 3.3.4 Large Employment Sectors

#### Wholesale and Retail Sector

In common with many Districts this is the largest single employment sector in Gravesham with 4,500 employees. It declined by 300 jobs, or 6% between 2008 and 2011, compared to a static position in Kent as a whole.

#### **Knowledge Economy**

The Knowledge Economy is defined as a group of specific sectors within the economy that are knowledge intensive in their activity, that deal extensively with information/information technology and whose business is all about the distribution or exchange of the information that they hold.

In Gravesham approximately 7.5% of all employees (2,000) are involved in these activities, across all sectors. This is by far the lowest percentage of any District in Kent and compares to 14.5% across Kent as a whole and 21% in the South East.

Clearly long term industrial decline in Gravesham is not being compensated for by employment growth within new technology industries.

#### **Public Sector**

Comprising the Education, Public Administration and Human Health and Social Work Activities, the Public Sector makes up 30% of all employment in Gravesham.

#### 3.3.5 Unemployment in Gravesham

Gravesham has the third highest unemployment rate in Kent, at 4.2%, in March. Chart 2 below illustrates the unemployment rate at November 2012 compared tot the rest of Kent.




Chart 2: Percentage of District Unemployment as at November 2012.

Chart 3 below illustrates the percentage change in unemployment overtime. Between November 2011 and November 2012 the unemployment rate in Gravesham fell, suggesting a fluctuating employment situation. Gravesham and Ashford are the only Districts that have seen an increase in unemployment between November 2011 and 2012.




Chart 3: Percentage change in District Unemployment since November 2012

Chart 4 illustrates the comparative levels of 18-24 year old unemployment across Kent. 8% of 18-24 year olds were unemployed in November 2012.




Chart 4: 18-24 Year Old Unemployment Rates in Districts in November 2012

Youth unemployment remains a huge issue in Kent and is very high in Gravesham residents.

#### 3.3.6 Employment in Gravesham

#### Self Employment

Self-employment rates in Gravesham have traditionally matched Kent and South East averages, although has increased in 2011/12. This mirrors the reduction in employment in large companies seen during the recession.

# 3.3.7 Residence and Workplace Earnings

The median weekly gross pay of workers in Gravesham is very high and ranks alongside Tonbridge and Malling and Tunbridge Wells. It grew by only approximately 9% between 2009 and 2011. The measure used here is a residence based figure and reflects the higher salaries available by a proportion of Gravesham residents commuting to London.

Table 4 below illustrates how weekly median gross pay has changed since 2009 in Gravesham.

#### 3.4 Discussion points

- 1. Progression opportunities are generally good in Gravesham with most courses being offered across Levels 1-3. However there is a need for the curriculum offer to better reflect the needs of the local economy.
- 2. Gravesham providers need to engage in a dialogue with employers focussing on employment growth sectors such as Human, Health and Social Care and Professional, Scientific and Technical occupations. The number of courses available in these areas should be reviewed and a dialogue held between providers, employers and the Borough Council.
- 3. In some sectors, the number of Level 3 courses is disproportionately large compared to the number of Level 1 and Level 2 courses that are available, and compared to the number of jobs available in these sectors. For example Sports, Leisure and Recreation and Performing Arts. Gravesham providers should consider a better balance of provision.
- 4. Retail and Wholesaling is the largest employment sector in Gravesham, in common with all Districts and Boroughs. However there is only one course available, at Level 3. Providers should review the support available to learners who want to progress in these occupations.
- 5. The number of self employed people has increased in Gravesham and consideration should be given to improving awareness and developing opportunities for business start up and entrepreneurial opportunities. Providers could consider developing additional employability programmes that can be implemented at Key Stage 4 and possibly continued in Key Stage 5 to support RPA and reduce youth unemployment which is high in Gravesham.

#### 4. Increase Participation and Employment

#### 4.1 Summary

In relation to RPA, 87% of 16-18 year olds already participate in Gravesham, but it is the remaining 13% who will create the challenge. On looking at this group it can be seen that participation in Year 12 is far higher than in Year 13. In total, if post 16 circumstances do not change by 2015, an additional 220 young people would need to participate.

If we look at how learners participate in Gravesham, it can be seen that more learners attend FE Colleges than the rest of the county and attendance at sixth form is lower than the county average.

Under RPA a new group of young people will need to be supported, these are those that are in employment without training. In Gravesham this number amounts to 86 learners.

Gravesham providers will need to consider what type of provision would be most appropriate to accommodate these young people and how they can work with employers to convert jobs without training into jobs with training.

It is encouraging that of the current NEET population 2 in 5 have expressed an interest in working in one of the sectors that have been identified for growth in Gravesham.

Gravesham has the third highest unemployment rate in the KCC area at 4.2% and has the fourth highest proportion of 18-24 year olds who are unemployed in the South East (8.5%). Therefore it is essential that young people received good IAG, support and post 16 pathways that meet their needs.

A recent learner voice survey carried out by the Skills and Employability Service identified that young people in Kent currently do not understand the concept of RPA, many think it is about staying on at school and are looking for face to face guidance to support them making important post 16 decisions.


To conclude, it will be difficult for Gravesham providers to deal with all the challenges that RPA and high unemployment will create, particularly if it is a reactive response to the problem. Providers need to consider how they can develop early intervention strategies in Key Stage 4 and in Year 12, in addition to realigning the post 16 offer.


#### 4.2 Supporting data

# 4.2.1 Comparison of the activities of young people age group Year 12, 13 and combined 12 and 13 who have completed compulsory education in Gravesham and Kent


- The NEET rate for the combined Yr12 and Yr 13 age group for Gravesham was 5%, which was the same for Kent.
  - o Participation at Sixth Form is lower in Gravesham (50%) compared to Kent (54%) but participation at FE is higher (36%) than Kent (30%).
  - o Employment with Training is 2% in Gravesham, compared to 3% in Kent.
  - o Employment without Training is 3% compared to 5% in Kent.
  - o 2% are in Training in Gravesham, which is the same percentage as Kent.
- Participation for Yr 12 is above the Kent average and above participation for Yr13.
  - The percentage of Yr 13 who are NEET is 6%, compared to 3% in Yr 12.
- The percentage of learners who participate in Sixth Form and College falls by a lower percentage between Year 12 to Year 13 in Gravesham than in the rest of the county.

#### 4.2.2 Number of young people not participating in Gravesend

- There is an issue in Gravesham with drop out rates particularly in Year 13. There are currently 64 in Year 13 and 35 in Year 12 who are available to participate with no further destination being secured. This is equivalent to another sixth form being operational in the district. The provision for these learners needs to be addressed.
- Based on the figures for November 2012 from CXK we can project that if nothing changed there
  would be 58 additional learners in Year 12 who will need help to participate. There will be an
  additional 162 in Year 13.
- Using the same projections and assumptions for September 2015 would suggest a further 220 learners needing help to participate

#### 4.2.5 Young peoples view on Participation

In November 2012 the Skills and Employability Service ran a learner voice targeting two groups of learners. The first, learners aged 13-16 who may be below the Level 2 threshold and the second, post 16 learners who were at risk of and not engaged in education, employment or training. The conclusions and recommendations are listed below.

#### Conclusions of learner voice

- Learners lack awareness of what RPA means. Many believe it is about staying on at school until 18, and do not seem to know about the options of taking up training either at an educational establishment with an employer or on a voluntary basis.
- Very few learners had heard about RPA outside of school. The message about changes to education and training for young people is not widely known or understood by parents or employers.
- Learners have a very good understanding of the importance of gaining qualifications in Maths and English. They expected to continue to retake these qualifications if they did not achieve the necessary grades by the end of Year 11.
- Learners prefer to access IAG by personal contact or using on-line access. They like to go to familiar places such as colleges or school or local council facilities.
- Learners prefer to receive individual 1:1 support for CEIAG.
- Learners rated specific support very highly. They rated the guidance received at school and college as good, however, they rated the guidance from employers, relatives, training providers and support workers as excellent.
- Half of the 16-24 learners who took part in the survey had no career plan. This gives an insight as to what may happen to potential RPA learners, should interventions not be developed.
- Learners aged 16-24 did not have apprenticeships on their horizon.
- Very few learners understood the voluntary route and what potential career benefits can be gained from taking up voluntary activities.
- Teenagers with young children had difficulty in considering their future beyond caring for their young child. However, they were very keen on getting help and support from such programmes as YAPs.
- More research would need to be undertaken to find out what help and support learners need with future career planning.

#### Recommendations of learner voice

- To develop methods of communication for RPA. Information about what RPA is at one level, impartial IAG for RPA and levels of IAG support about RPA options for learners.
- To use the Report as a means to evidence the lack of understanding of RPA by learners, parents, carers and employers. This has some sense of urgency given that the current Year 11 will be affected from September 2013.
- Learners indicated they see the Local Authority, along with schools and colleges, as the place to go
  to for help and advice for CEIAG. The LA should consider developing its RPA role in getting a
  consistent message across through the use of this report, the Kentchoices4U website, transition
  programmes and general information events.
- There needs to be some form of RPA Transition programme available to 16-18 learners, similar to the highly regarded Princes Trust programmes available for 16-24 NEETs learners.
- The positive response to the KC4U website suggests there is an opportunity to build on the increasing use of KentChoices4U as a means to inform parents, carers, and employers as well as learners.

Ensuring that CEIAG retains its impartiality in providing help and support for RPA options will play a
crucial role for learners from Year 9 onwards. Learners are asking for face to face support on
specific career outcomes. If they cannot have face to face, they would choose on-line for support.
They will continue to need career planning to develop their aspirations and support in achieving their
goals

#### 4.2.6 The 16-17 Year Old Youth Contract

The Youth Contract is a mentoring support programme designed to help 16 – 17 year old NEETs with low GCSE qualifications (less than 2 at Grades A\* - C), those who have been or are in care (irrespective of any GCSEs gained), and those who have been in custody (including remand, again irrespective of any GCSEs gained). It gives advice and guidance and then prepares individuals to re-engage into education, training or jobs with training. It continues for at least 6 months during the re-engagement period with tracking for an additional 6 months. It therefore supports those on EFA funded programmes to minimise drop out and maximise progress towards completion of an accredited qualification and beyond, with or without some form of employment (paid or voluntary). Providers have a maximum of 6 months from the start date to get each young person into an EET activity.

There is one provider in Gravesham delivering the Youth Contract, TBG Learning. To date there have been 15 starts including those at the pre-engagement stage as at May 2013. It is anticipated that this number will rise significantly in the next two months.

Schools can request a visit to engage with a group of potentially eligible Youth Contract young persons. Sessions can happen between March and June to enable initial engagement and delivery to small groups and individuals. Young people who are already eligible can then start on the programme from July  $1_{\rm st}$  – if they are sitting 2 or more GCSEs (and not in custody or care) then they can join after results day in August if eligible.

#### 4.2.7 Unemployment and youth unemployment in Gravesend

- Gravesham has the **third** highest unemployment rate in the KCC area at 4.2%.
- Gravesham has the **fourth** highest proportion of 18-24 year olds who are unemployed in the South East (8.5.0%)
- In all age groups, Gravesham has higher unemployment rates than is recorded for Kent and nationally.

#### 4.3 Discussion points

- 1. Gravesham providers need to keep abreast of local developments created by the Tiger Fund, to ensure that the curriculum offer matches the needs of the local economy in order to keep the youth unemployment rate low.
- 2. There is a 8% drop in retention from Year 12 to 13 in sixth forms and 3% in FE. At the same time there is a rise in the number of young people in jobs without training as well as an increase in the NEET population. Can the curriculum offer in Gravesham be adjusted to improve this?
- 3. It is projected that an additional 200+ learners will need to participate by 2015. How will the curriculum planning in 2014 prepare for this?
- 4. Gravesham providers have attended the NEET to EET meeting which has proven to be successful. All providers should be encouraged to attend including apprenticeship providers.
- 5. The largest NEET groups are 'caring for own child' and LDD. Is there the right provision in place to allow for progression to take place?
- 6. The three employment sectors of most interest to the NEET population are engineering, health and social care and retail. How can they be engaged with employers and training providers to have a positive destination in these areas.
- 7. Gravesham providers should consider engaging with the Skills and Employability Service who are developing a Kent wide and district Risk Of NEET Indicator (RONI). This uses data to create a model of NEET young people that can be used to identify those at risk of becoming NEET as early as Year 9.
- 8. Gravesham providers could in partnership with kentchoices4u consider how they could present a clear provision map to Gravesham young people and their parents/carers and consider how they could use new technologies to communicate the offer.

#### 5. Target Support to Vulnerable Young People

#### 5.1 Summary

In Gravesham the number of 16-24 year olds who are NEET and included in one of the CXK's county wide priority groups is 139 (8%), of this number the largest groups are: caring for own child (52 and another 12 who are registered as pregnant), LLD (39) and Looked after/In care in total (10).

A further analysis of the 16-18 year old NEET data identifies that almost half are LDD and quarter are BSED. This need will continue as there are currently 125 learners in key stage 4 who have a BSED statement.

This will create challenges to Gravesham providers who will need to consider how they prepare their learners for transition from Year 9 and Year 11 onwards, how learners are supported through transition and what the most appropriate post 16 pathways. There is also the need to map the range of support that is required from agency partners.

In February 2013 there were 86 known looked after children in Gravesham and 32 (37%) who were the responsibility of other Local Authorities. Of these 13 learners were in Key Stage 4 and 9 were post 16 learners. Within this group 15 had a statement, 8 had a statement (but were the responsibility of another LA), 5 had ASD, 4 had BESD and 4 had MLD statements.

Gravesham Borough has the lowest number of children (361) of all ages with a SEN Statement in Kent but it does have the **third** highest number of Children Missing Education Referrals. Consideration will need to be taken on how to reach out to this group due to their potential to become NEET.

Exclusions in Gravesham are healthy when compared across Kent. As at February 2012 there were 7 permanent exclusions making Gravesham the fourth lowest district. It also has the fourth lowest rate for fixed term exclusions.

Gravesham has 131 young offenders but the fifth highest number of offences committed in the County. There has been a significantly downward trend of -29% between October 2010 and September 2012.

#### 5.2 Supporting Data

# 5.2.1 Client Caseload Information System (CCIS) data on NEET young people and vulnerable learners provided by CXK

There are two sets of data that have been supplied by CXK who under contract from KCC track all young people up to the age of 19 and up to 25 for young people who have a disability.

The data is stored on a Client Caseload Information System (CCIS) and while the initial source of the data is from KCC, CXK maintain the database which can lead to discrepancies between data held by CXK and KCC. Data held in the CCIS has to be maintained in a way that is proscribed by the DfE and this can again cause data discrepancies, particularly in terms of categorisation.

KCC also contract with CXK to provide support for vulnerable learners which include 10 priority groups which are listed in the table below.

The data held in the CCIS is important because it is used to report to the DfE, who use it to produce NEET data and because it is the only database in Kent that includes consistent data about the whole 13-19 cohort and up to 25 for those with disabilities.

Two sets of data have been taken from the CCIS and used in this report. The first is a breakdown of the 16-24 year olds in Kent, by district who are NEET and in one of the priority groups. The second is a breakdown of the 16-18 year olds have a disability registered on CCIS, as defined by the DfE guidelines. In some cases young people may have more than one disability but only one is provided in the data.

# 5.2.2 Breakdown of the 16-24 year olds who are NEET and in one of the Priority Groups - November 2012

- 139 (7.8%) of the Kent young people in the priority groups are Gravesham residents.
- The groups with the highest number of young are: caring for own child (52 and another 12 who are registered as pregnant), LLD (39) and Looked after/In care in total (10).



#### 5.4.4 The Number of children with a SEN Statement – February 2013











#### **5.11 Discussion points**

- Gravesham providers in collaboration with KCC and other agencies need to consider developing new models to reduce the number of teenage pregnancies, support to re-engage young parents in education, training or employment with training and develop appropriate post 16 pathways.
- 2. KCC and Gravesham providers need to work together to make better use of the data available on young people, particularly those who have a statement, so that post 16 planning can begin in Year 9 as part of a moving on plan.
- 3. More local provision should be made available to support LDD young people, using Kentchoices4u to publicise it, which in turn will reduce the number who have to travel out of the county.
- 4. Considerably more specialised provision or support for BESD learners in mainstream provision needs to be made available as a matter of urgency.
- 5. KCC, providers and other agencies need to work collectively to target their support on the most vulnerable, particularly Looked after Children, those in alternative provision/PRU and BESD.
- 6. KCC, Gravesham providers and other agencies need to work together to improve the tracking arrangements for young people.
- 7. Gravesham providers should support the work of the Kent Integrated Adolescent Support Services, the BESD virtual sixth form project and Virtual School Kent, who are offering post 16 support for Looked After Children
