- 4.2 **A planned workshop** in Ashford led by the Area Education Officer which will support the development of a best practice model for a shared approach between schools, Early Help and Skills & Employability.
- 4.3 **Partnership meetings** at District level to monitor and plan for those who are NEET, with a specific focus on those who are in the vulnerable groups. These meetings include:

CXK – Where CXK are working in partnership with the Youth Hub Delivery Managers significant progress is made with the NEET in the vulnerable groups

Early Help – involving both the District Manager and the Youth Hub Delivery Manager **Skills & Employability** – the four Participation & Progression Managers are ensuring that the Districts offers and partners are fully aware of the EET provision available to young people and increasing the District offer

VSK - all young people are assigned to a Post 16 Support Officer, Post 16 Assistant Head or Locality Assistant Head. The Post 16 Support Officers are working with the young person and Social Worker to identify the young persons status and then to support them into EET. However the large increase in Unaccompanied Asylum Seeking Young People (UASC) has impacted on the workload capacity of the Post 16 Team

YOT – the four Teams are becoming increasingly engaged in addressing the EET needs of the post 16 age group and their recent performance during Quarter 2 (2015.16) revealed a significant numerical and percentage increase from the 16 / 17 years age group subject to statutory supervision engaged in EET. A protocol has been agreed by YOT with SEND to ensure joint working with those young people who have an Education Health Care Plan

- 4.4 **District good practice guide** is being developed to support the establishing of supportive business processes and shared partnership activity this will inform the quality assuring of the provision, both preventative and reactive, for the potential and actual NEETS
- 4.5 **Troubled Families Programme** the District Partnership Managers, the FIP Workers and the Employment & Skills Apprenticeship Officers are addressing EET opportunities for young people, 16-18 years, known to them.
- 4.6 Information & Intelligence is producing a monthly NEET bulletin to support Early Help staff in both the Units and in the Open Access provision to be aware of activities in Districts relevant to the needs of the vulnerable groups. Additionally training on the delivery of the Rapid English accredited programme is being provided for staff working in the Youth Hubs and in the YOTs as the qualification does increase employability

5. Management Information


- 5.1 The focus on the use of the IYSS case management system has increased in intensity with staff from Early Help, YOT, Troubled Families and VSK being trained by the Systems Training Officer adding significantly to the number of users which will assist the meeting of the objective to maintain the accuracy of the system
- 5.2 The team continues to process monthly updates from: schools on joiners and leavers and colleges on joiners the National Apprenticeship Service identifying possible not known matches with other CCIS databases nationally to agree the lead LEA
- 5.3 Monitor data quality and issues addressed with users to ensure records are updated






