Minimum commitment of 12 months

Cleaning Contract Management Package A

This service is for any establishment who has made use of the Premises Cleaning Framework Agreement which commenced on 1st August 2012. The contract is fully administered by Client Services and any site has the opportunity to join at any point during the 4 year contract.

In addition to unlimited telephone advice during office hours we also offer the following services as part of the package:-

- Contract Procurement to include specification and all procedures up to award

Minimum commitment of 12 months

This package is also for schools using the framework agreement who may have In-House arrangements for part of their site and need support in this area.

In addition to unlimited telephone advice during office hours we also offer the following services as part of the package:-

- Advice on Caretaker Risk Assessments and compliance with individual schools needs

Cleaning Monitoring Package D



Minimum commitment of 12 months

This service is offered to those schools that have opted to make their own arrangements for premises cleaning with a private contractor who is not used under the KCC Framework Agreement.

This package includes three or six full audits each year which will give the management of the establishment reassurance knowing that a professional 3rd party is monitoring standards and providing written reports. The management is then able to take up any issues highlighted, directly with the service provider.

Telephone support and advice is available during normal office hours. The audit to include (may vary depending on time of visit and access to rooms):

- Hygiene Areas
- Classrooms, corridors, halls
- Cleaning cupboards
- Equipment and chemicals
- Documentation
- Holiday Cleaning
- COSHH, Health & Safety
- Staffing issues uniform, PPE, absence cover, DBS
- Communication Training records

Refuse Collection, Transfer & Disposal Contract Management - Package R

This service is for any establishment who has made use of the Refuse Collection, Transfer and Disposal Framework Agreement which runs until July 2016. The contract is fully administered by Client Services and any site has the opportunity to join at any point during the contract.

In addition to unlimited telephone advice during office hours we also offer the following services as part of the package:-

- Contract Procurement to include specification and all procedures up to award
- Ensure legislative standards are being met
- Specific advice on Health and Safety issues related to general refuse and recycling

Ad hoc Packages

Site Cleaning Audit

This package is a one-off audit of the school premises. The aim is to:

- give valuable information regarding cleaning standards
- advise on health & safety issues relating to caretaking and cleaning
- identify the areas of greatest risk, to enable resources to be focused
- prioritise the topics on which you need more guidance or training
- ensure compliance with legal requirements

When taking this package a school should consider that if they should require support throughout the year, then they would benefit from the additional services included in package C or D

Site Evaluation for Advisory Workloads

This package will provide you with an advisory workload for your caretaking and cleaning staff.

The cost will cover using your establishment plans to estimate the floor area and the administration time to generate the calculations.

Contract Letting Service

Client Services are able to support an individual school or group of schools wanting the independence of a single site or group contract.

When undertaking procurements schools must do so in compliance with the Scheme for Financing Schools and the individual school's finance policy. Support packages are based on the estimated contract value over the term of the contract.

Less than £50k - At least three written quotations must be obtained.

The support can include -

- A draft school meals specification to be used as the base of your proposal and adjusted to include site specific requirements
- Invitations to quote to procure best value
- Evaluation using a fair and transparent method to ensure compliance with health & safety legislation
- Arranging evaluation of standards through site visits
- Contractor interviews
- Contract award letters
- Supplier debrief

<u>Over £50k</u>, a competitive tender and compliant procurement process must be followed. If over £172,514, it becomes OJEU procurement. Client Service will work in partnership with the Schools' Buying Club to provide schools with a compliant tendering method that ensures market competition for best quality and best value.

The support can include all the services with in the previous package plus -

- Advertising the contract as appropriate
- Procurement plan and schedule
- Management of PQQ and ITT
- Fair and transparent clarifications
- Financial checking
- Draft contract terms and conditions
- Set and agree KPIs
- Termly / annual service performance reviews
- Management of any process challenge
- Information on other areas where the school could save money!

'Should a school decide to pull out before the procurement process is complete or choose not to award the contract, a fee will be applied'.

When purchasing this contract letting service, you also commit to purchase the Cleaning Contract Management package for the life of the contract to ensure that standards of the contract are maintained.

Caretaker Recruitment

Many of you will be experienced in recruiting school staff such as teachers but when it comes to taking on a new Site Manager or Caretaker, you might ask yourself if you have the knowledge and understanding of the role to employ the best person for the job.

Although a lot of time may be spent working alone Caretakers come into contact with a variety of people including children, teachers and contractors working on the site. They may also supervise other staff such as Assistant Caretakers and Cleaners. In larger schools, Caretakers are taking on more responsibilities and will often need to manage a budget. They often also have responsibilities for site security involving locking and unlocking buildings.

This package will include advice and support with

- Short listing people to interview
- Attendance on interview day prepared to ask candidates appropriate questions
- Identification of future training needs

Schools are also advised to work closely with the School Personnel Service to ensure Employment and TUPE legislation is being complied with.

Health & Safety Risk Assessment

In order to manage health and safety, employers are required to carry out risk assessments and record the significant findings. This involves identifying and assessing workplace hazards faced by employees, contractors, visitors and members of the public and putting in place suitable arrangements to control these risks. This may be an area where you need the support of a competent person to assist you with carrying out the risk assessments within KCC standards.

This package will include a visit to the site to support a representative from the school to produce the written Risk Assessment which will cover areas such as -

Personal safety, personal protective equipment Waste management, working at heights Working with Electricity
