1 Background

- 1.1 In 2020/21 a falling rolls fund was created for Kent schools and academies in order to protect schools who have a falling roll and meet a number of criteria, primarily, evidence that the places will again be needed within the medium term.
- 1.2 The continuation of this fund is subject to annual review and decision by the Forum

- 3.1 Of this total £446,358 will be disbursed to academies in April 2021 as the academy financial year is different to schools and local authorities.
- 3.2 A total of four dis-applications were submitted to Secretary of State for approval where the schools did not meet the minimum requirement of either a good or outstanding OFSTED rating. Three of the four dis-applications were not approved as it was considered these schools had sufficient reserves to cover the resulting reduction in funding.
