Children's Commissioning attended the School SENCo forums in March 2025 to outline changes to the delivery of support from Specialist Teaching and Learning Service as they move into KCC and align the delivery of support to the Communities of Schools and Early Years models of support. SENCos were invited to send through questions. Responses are outlined in this FAQ document.

A number of questions were received. Where there are recurring themes and duplicate questions these have been grouped and a single response provided.

Communities of Schools:
