**Dear Colleagues** 

As the current situation continues to evolve, the DfE has today released updated guidance for Free School Meals and exceptional school costs associated with COVID-19; I also wish to highlight additional local guidance to support you.

#### **Free School Meals**

The Government has today updated guidance relating to Free School Meals; previously schools were able to continue supporting eligible families with vouchers during Easter but were not required to do so and the cost would not be recoverable from the Government. This has now changed and whilst schools remain able to decide locally how they will arrange support, the cost of supporting eligible children out of school during Easter will now be met by the Government, up to the value of £15 per pupil per week.

The cost of providing free school meals to eligible pupils who are attending school over Easter will however need to be met by the school. The National Voucher Scheme is being updated to operate over the Easter period and schools remain able to procure their own vouchers instead should they wish. The Government has stated that this arrangement will operate over Easter as an exception and not any other future holidays.

#### **Reclaiming Finances**

The DFE has today announced details on the process for Schools to reclaim exceptional costs associated with coronavirus including typical costs which could be incurred and funding limits. Further guidance on how you will submit your claim to the DFE will be provided by the DFE in June but in the meantime it is important you maintain a separate record of all expenditure relating to coronavirus to enable to you to make this claim. #### **Pupil Premium Plus and Supporting Foster Parents**

Virtual School Kent has committed to ensuring that funding levels to schools via the Pupil Premium Plus (PP+) grant are maintained during this unprecedented time. The £400 per Kent Child In Care payment will continue as normal for the summer term and be paid in the June advance. VSK are attempting to support foster carers as much as possible but are evidencing a lack of physical resources for home learning at the current time, such as paper, printer ink and arts & craft resources etc. I would appreciate your consideration regarding supporting foster carers with such physical resources utilising the PP+ grant allocation for the summer term, this can be explored through a discussion between school and carers.

# **KCC Schools Facilities Management Services**

All schools have now entered a period of reduced occupancy; it is however still vital that statutory building maintenance and inspections continue to ensure they remain safe. Updated guidance for schools where KCC is the responsible body has been published on KELSI, setting out what needs to take place under different scenarios.

In my letter of 1<sup>st</sup> April, I highlighted that several schools had been targeted by fraudsters taking advantage of the current crisis to conduct 'Spear Phishing' fraud; further incidences have arisen this week, it is vital that all school are staff aware if this and know what to do as set out in the following guidance:

Kent Trading Standards are also aware of a wide number of corona themed scams operating. This can include fraudsters offering to do shopping or collect medication for vulnerable individuals and asking for money upfront and then disappearing.
