Headline Commentary

Management Information are committed and focused on fulfilling our obligation to Kent's young people during these difficult times. We will continue to provide all necessary analysis to help Managers and Key Workers achieve this goal.

The NEET population is currently at 2.1% compared to 2.2% at the same time last year, and our Not Knowns are at 46.4%, compared to 59.5% at the same time last year.

The Participation rate is 50.3%, which is an improvement from the same point last year, 36.7%.

District performance for NEET varies from 1.4% in Dover to 2.9% in Dartford. District performance for Not Knowns varies from 36.9% in Tunbridge Wells to 56.2% in Ashford.

There are currently a number of Post Stat returns still to come in from colleges, however, 91.2% of the September Guarantee cohort have received a positive SG offer*, compared to 90.4% this time last year.

The Local Authority has a statutory duty to collect data from all education establishments regarding offers they have made to 16and 17-year olds from September. It is an important part of our planning and transition support offer. Enabling us to identify those at-risk of NEET, gaps in local provision and to work alongside you in supporting our most vulnerable young people.

The process in place to collect this data is a partnership between MI, The Education People's Skills and Employability service and Kent schools and colleges. Despite the challenging times we find ourselves in, we are endeavouring to complete this process as usual.
