Updates for the Sector

How tests and testing kits for coronavirus (COVID-19) work 23 March 2021 Page summary: The different types of tests and testing kits for COVID-19, and the specifications for manufacturers. Change made: Added new guidance page of testing kit providers.

If you have any problems with COVID-19 testing products, you should report them as soon as you can. This can help the Government to identify any potential issues with the kits. Details on what and how to report are outlined below.

Patients - what to report

Examples of problems to report include, but are not limited to:

- taking more than one test and getting different results
- the test being invalid (for example, the control line did not appear)
- finding the instructions for use or the labelling difficult to understand
- the kit (or part of it) breaking
- the buffer liquid leaking
- not being able to take a sample for any reason
- having difficulty using the software app (for example, you cannot report the result).

Updates for Families

New one-off £500 payment for working households receiving tax credits March 2021

Updated to clarify that the payment is non-taxable and will not affect benefits. It does not need to be declared as income for Income Tax Self Assessment or for tax credit claims and renewals. If you want to change your bank details, you must do this by 8 April.

Test and Trace support payment March 2021

Parents and carers of children who have been advised to self-isolate by their education setting or by NHS Test and Trace are now able to apply for a <u>Test and Trace Support Payment</u> or discretionary payment of £500, if they meet the eligibility criteria. The extension of the Test and Trace Support Payment scheme, which is administered by district and unitary local authorities in England, ensures that parents receive the financial support they need if they are unable to attend work due to childcare responsibilities.

Parents and carers should apply to their local authority to receive a payment. Applications for the Test and Trace Support Payment scheme are made via the local authority in which the parent or carer resides, not the local authority where the setting is situated, if these are different.

To be eligible applicants must meet all of the criteria that:

they are the parent or guardian of a child or young person in the same household and need to take time off work to care for them while they self-isolate. This is limited to one parent or guardian per household for the child or young person's self-isolation period, they are employed or self-employed and they cannot work from home while undertaking caring responsibilities and will lose income as a result. The parent/carer meets all the other means-tested eligibility criteria for a Test and Trace Support Payment or locally determined criteria for a discretionary payment.
